 Hon'ble NGT OA 139/2019 order dated 09-09-2022 regarding Group Housing Project Mahagunpuram, A-19, Sector-63 Noida Uttar Pradesh 201301 MAHAGUN REAL ESTATE PRIVATE LIMITED File no- 3662

Nodal Officer SEIAA placed UPPCB, letter no. H82237/C1/NGT-102(vidhi)/2022 dated 23.09.2022 received in this office on 27.09.2022 regarding order passed by Honourable NGT, Principal Bench, New Delhi in O.A. no. 139/2019

SEIAA observed as follows –

- EC was issued to said project vide letter no. 228/SEAC/333/2009/TAJ dated 12.02.2010
- 2 EC for expansion project was issued vide letter no. 373/parya/SEAC/3662/2016 dated 22.03.2017 and in this condition no. 10, which was not there in original EC, was added.
- Project Proponent submitted an application dated 11.03.2022 for amendment in condition no. 10
- In the application seeking amendment in EC, Project Proponent didn't mention that there is a litigation related to the issue of green belt in Honourable NGT, Principal Bench, New Delhi
- SEIAA in their meeting no. 606 dated 19.05.2022 amended the said EC condition (Most probably Honourable NGT has referred to this decision of SEIAA-UP in their judgement dated 09.09.2022).
- As the judgement dated 09.09.2022 was not in the knowledge of SEIAA, amendment in EC for expansion project was issued vide letter no. 190/parya/SEIAA/3662/2021 dated 26.09.2022



Honourable NGT, Principal Bench, New Delhi in OA No. 139/2019 (Earlier O.A. No. 06/2018) has issued following orders on 09.09.2022. These orders came in the knowledge of SEIAA-UP through the letter of UPPCB dated 23.09.2022

"....One of the points raised during the hearing is that amended EC has been issued on 19.05.2022 to the effect that instead of 15% of the total plot area, green belt may be maintained on 15% of the net plot area. This is rather intriguing and difficult to understand how such corrigendum/amended EC can be issued after the project has been developed and 12 years after the original EC dated 12.02.2010. Being after final adjudication and orders of this Tribunal which are being enforced, we are of the view that the same cannot be considered. While taking such decision, binding orders of this Tribunal have been ignored illegally. Under section 33 of the NGT Act, orders of this Tribunal will override the said SEIAA decision."

# SEIAA opined as follows -

- In light of Hon'ble NGT order dated 09.09.2022 in OA 139/2019 (Earlier O.A. No. 06/2018), amendment issued vide letter no. 190/parya/SEIAA/3662/2021 dated 26.09.2022 is cancelled / withdrawn. Order to this effect be issued immediately.
- MS, SEIAA to communicate the cancellation / withdrawn order to UP RERA; DM, Ghaziabad; VC, GDA; MS, UPPCB and Project Proponent.
- Show cause notice be issued to Project Proponent as to why action should not be initiated against them for concealing facts and misleading SEIAA-UP.

- 1- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 2- The lease area its address and production per annum should match with as mentioned in DSR and LoI. In case there is any difference clarification/amendment letter from competent authority shall be submitted along with EIA. EIA and public hearing shall be conducted as per the lease area its address and production per annum mentioned in DSR and LoI.
- 3- Public hearing shall be conducted as per EIA notification, 2006 (as amended).
- 4- SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.
- 5- KML file for the area and mining lease area should be provided.
- 6- Status of leases granted/to be granted in various mining khands along with production since the formulation of DSR, duly certified by the competent authority should be submitted.
- 7- In case project proponent intends to temporarily store mined out material or any tools, equipment's or other material outside mine lease area then NOC from competent authority for doing so should be submitted and details of such area and associated Environmental impacts should be included in EIA-EMP report. This should also be clearly mentioned during public hearing.
- 8- Road network to be used by the project should be clearly shown on Survey of India toposheet in 1:50,000 scale. In case road network involves forest road, permission should be obtained from Forest Department and a copy of the same should be submitted at the time of appraisal of EIA-EMP report.
- 9- The project proponent should clearly spell out whether it is a green field or brown field project. In case it is a brown field project and -
  - If the earlier and present lease holder are same then compliance report of previous EC should be submitted.



- (ii) If the earlier and present lease holder are different then environmental footprint of the site and mitigation measures-should be included in EIA-EMP report.
- 10- In case of expansion / renewal of earlier EC, following information should be submitted
  - Status of compliance of earlier EC conditions by Integrated Regional Office, MoEFCC, GoI, Lucknow.
  - b. Copy of CTE and CTO issued by SPCB.
  - Status of submission of six-monthly compliance report to EC granted earlier
  - d. Court cases, if any.
- 11-Observations raised in public hearing, replies submitted by project proponent, suitable modifications carried out in EIA-EMP report.
- 12-PP / consultant in compliance to Hon'ble NGT order dated 06.05.2022 in OA no. 141/2021 (With report dated 31.03.2022) Raj Kumar Vs. State of UP and Others and with OA no. 141/2021 Rajkaran Karn Vs. State of UP and Others, will submit replenishment study, duly approved by DGM, along with EIA-EMP report for seeking EC.
- 13-Project Proponent should submit action plan for carrying out plantation at least @1,000 plants / ha of lease area. In this case, PP should prepare a plan, duly approved either by Forest Department or Horticulture Department, for planting at least 37,000 plants, either on government land or community land, within a periphery of 5 km from the boundary of the lease area along with provision for maintenance for 5 years. Survival of plants below Uttar Pradesh Forest Department's survival rate will be treated as violation of EC condition.
- 14- In consultation with District Environment Authority or an Authority nominated by concerned DM, project proponent will prepared a conservation and management plan for rejuvenation and management of water bodies having total surface area of more than 185 ha. In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-1 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC-1. In addition to the conditions imposed by SEAC-1, SEIAA added following additional specific conditions:-

- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
