Minutes of the 41st Meeting of SEIAA held on 11th November, 2021

The meeting was chaired by Dr S.S. Negi, Chairman, SEIAA Uttarakhand and was attended by the following:

- (ii) Shri Shailendra Singh Bist, Member, SEIAA Uttarakhand (Online Attendance)

The meeting started with welcome note by the Chairman. The Member Secretary informed that total 38 proposals (B1 & B2) are under consideration for grant of EC in this meeting. Also 4 proposals are under miscellaneous item head consideration for in EC under. After detailed discussion and deliberation on each of the proposal as per agenda item, decision taken by the Authority is as under -




The Authority agreed with the recommendations of SEAC and decided to grant the Environment Clearance with the terms and conditions recommended by it

The other conditions as proposed by SEAC shall prevail. EC shall be operative only after grant of NBWL clearance as it is in Eco Sensitive Zone.
