## Agenda-A- Minutes of 826th SEAC-1 Meeting Dated 23/01/2024

 Building stone Sand Stone Mining Project at Gata No.-997mi, Sl. No.- 09, Village-Sindhora, Tehsil- Sadar, District- Mirzapur, Smt. Nilama Singh, Area 1.010 ha., 8567/7600/SIA/UP/MIN/453801/2023.

SEIAA noted that LoI to the above project was issued in March, 2021 the project proponent made application for ToR in January, 2023 which was issued on 24.05.2023 and application for EC was made on 07.12.2023. It is noteworthy that the project proponent submitted his application after a gap of almost two years and has not explained the reasons for delay.

The issue was deliberated upon in depth and SEIAA noted that the DSRs were being updated by Geology and Mining Department Uttar Pradesh before 4/12/2023 on the basis of extant notifications and guidelines and leases had been auctioned and proposals for EC had been uploaded on Parivesh portal. These proposals have also been appraised and recommended for grant of EC by SEAC. As per para 8(ii) of EIA notification2006 -The regulatory authority shall normally accept the recommendations of the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned. Hence in light of all these facts EC is being granted to the title proposal.

SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC taking into consideration discussion held in SEIAA meeting no. 597 dated 05.05.2022 regarding reply of SEAC-1 and SEAC-2 for compliance/action taken on TOR/Public hearing, adding following specific conditions:-

- Validity period of this EC is 5 years from the date of issue as the LoI has been issued for a period of 5 years or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.
- Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied with.
- Approved explosives and proper technique should only be used for blasting, to avoid loud sound and cracks in nearby buildings.
- A certificate from Forest Department shall be obtained that no forest land is involved in mining or as a route and if forest land is involved the project proponent shall obtain



forest clearance and permission of Central and State Government as per the provisions of Van Sanrakshan evam Samvardhan Adhiniyam, 2023 and submit before the start of work.

- The mining lease holders shall ensure to comply with mine reclamation plan as submitted.
- Three tier green shelter belt of 7.5m width should be developed on the periphery of mine lease area. Local and native species should be planted in consultation with Forest/Horticulture Department/Agriculture University.
- Mine reclamation plan should be prepared for using the mine void for productive use in consultation with local administration and gram-panchayat.
- If the proposed project is situated in notified area of ground water extraction, where
  creation of new wells for ground water extraction is not allowed, requirement of fresh

The issue was deliberated upon in depth and SEIAA noted that the DSRs were being updated by Geology and Mining Department Uttar Pradesh before 4/12/2023 on the basis of extant notifications and guidelines and leases had been auctioned and proposals for ToR had been uploaded on Parivesh portal. These proposals have also been appraised and recommended for grant of ToR by SEAC. SEIAA noted that the above project was taken in the 790th meeting in which SEIAA found that fire NoC is given in the name of Chinmay whereas EC is applied for Urbanac Developers. Further the project proponent was asked to submit layout plan mentioning the location of STP and discharge point details, agreement between project proponent and Ansal Water supply for fresh water. The project proponent has submitted his reply vide letter dated 19.11.2023 but reply is not satisfactory. Hence SEIAA opined that the project proponent should submit relevant and complete information. The project proponent has submitted his reply vide letter dated 03.02.2024. SEIAA opined that the project proponent shall seek and submit fire NoC within one month. The EC is granted but shall be issued only on submission of fire NOC.

 Proposed "Novotel Hotel" project at Khasra No.- 2021, 2041 Mauza Basai Mustkil, Tajganj, Tehsil & District: Agra. U.P. by M/s Pyramid Estates Private Limited. File no-8422.

SEIAA noted the above project was taken in its 793th meeting in which it was opined that reply from project proponent shall be sent to UPPCB for comments on category of the project. UPPCB vide letter dated 29.02.2024 has sent categorization of industries. The CPCB vide letter no.8-29016/ROGW/IPC-VI/2020-21 dated 30.04.2020 has categorized hotels as non-industry category. In present case the waste water discharge is more than 100 KLD but because hotels are non-industry so this may not be treated as "Red" category of industry. However suitable conditions are being imposed on the project proponent to ensure the boilers and gensets are using fuels which will not cause air pollution. In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022 SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and



specific conditions as suggested by SEAC. In addition to the conditions imposed by SEAC, SEIAA added following additional specific conditions:-

- 1- Any order of any Court of law shall be binding on Project proponent.
- 2- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 3- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 4- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same like water harvesting pits and carbon sequestration parks / designed ecosystems. At least one school in the vicinity of project area should be provided with rooftop solar plant, toilets in public place or in school of nearby villages and if there is a girl's school then girls toilet properly equipped with overhead water tank should be constructed.
- 5- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 6- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 7- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. The waste water should not be discharged in any water body. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
- 8- Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
- 9- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per air act 1981 (as amended) and the Construction and Demolition Waste Management Rules, CAQM guidelines.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Van Sanrakshan evam Samvardhan Adhiniyam, 2023 and submit before the start of work.
- 11- If the proposed project is situated in notified area of ground water extraction, where creation of new wells for ground water extraction is not allowed, requirement of fresh water shall be met from alternate water sources other than ground water or legally valid source and permission from the competent authority shall be obtained to use it.
- 12- Provision for charging of electric vehicles as per the guidelines of Gol / GoUP should be submitted within the next 3 months.
- 13- PP should display EC granted to them on their website. 6-monthly compliance report should be displayed on their website and to be given every six month to residents / occupants of the building.



- 14- EC is granted with the condition that EC is valid only for the building plan which has been submitted by PP for seeking EC. In case approved building plan is different from the one submitted for seeking EC then this EC will stand null and void.
- 15- The project proponent shall install organic bio converter.

SEIAA noted the above project was taken in its 732th meeting in which it was noted that clear gap analysis has not been submitted only information obtained through RTI has been forwarded. Hence SEIAA opined that a letter shall be send to UPPCB for clear gap analysis report.

UPPCB is also directed to provide information about other CBWTF established in residential area and also as to adverse environmental impact of the same if any reported...."

SEIAA gone through the report of the joint committee received in the office vide letter no. H98915/C6/Gen658/ 06/2022 (IA No- 29/2022) dated 07.08.2023 and accepted the report of the joint committee.
