## MINUTES OF THE 75<sup>th</sup> GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 31/03/2022 AT 10.30 AM. IN THE CONFERENCE ROOM OF THE 4<sup>th</sup> FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA.

The Seventy Fifth meeting of the Goa-SEIAA (hereinafter referred as 'Authority') was held on  $31^{st}$ March 2022 at 10.30 am in the conference room,  $4^{th}$  floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (<u>refer Annexure - 1</u>).

At the outset, Chairman welcomed Authority members and briefed about the agenda items ( $refer\ Annexure\ -\ 2$ ) to be taken up for discussion / deliberations and suitable decision Accordingly, the same were considered as detailed below.

1. To discuss on Project received from Sir Biotech India Ltd. On 03/03/2022 at P.T Sheet No. 17, Chalta No. Ribandar North Goa.

**Decision:** The PP was directed to submit the revised Plan in 74<sup>th</sup> meeting held on 10/02/2022 however Plan submitted does not meet the criteria as suggested. After perusing the documents submitted by the Project Proponent, the Authority instructed PP to resubmit the revised plan showing the connectivity to the plot beyond the natural reserve demarcated / shown on the plan along with proposed flyover without disturbing the natural cover. The Authority also instructed Project Proponent to submit in writing the activity that they will support under Corporate Environment Responsibility. The matter was deferred to the next meeting.

2. To decide on application for building and construction (8a) project received from All India Institute of Ayurveda (AIIA) located at Dhargal, Pernem- Goa for prior EC.

**Decision:** As the Project Proponent failed to attend the meeting the Authority decided to defer the agenda item for subsequent meeting. The authority decided to issue fresh notice of hearing.

3. Proposed Project M/s Prudential Developers Pvt. Ltd. In Chalta No. 34, P.T Sheet No. 129, Margao, Gogol, Salcete Goa for extension of validy.

**Deliberation:** The representative of Prudential Developers Mr. Paresh Sawardekar appeared before the Authority and submitted the list of CER activities whichever / that they have already done from the date of getting EC i.e 15 September 2014. As per Office Memorandum No. F.No.22-65/2017-IA.III dated 1/05/2018 if the project cost is less then or equal to 100 crores (Brownfield Project) 1% of Project cost should be allocated as CER. As the Project cost is 100 crores the amount of money to be spent for CER comes out to 1 crore. The Authority has accepted that the Project Proponent has



already spent 25 lakhs under CER and remaining 75 lakhs has to be spent for CER. The Authority also suggested some activities to be covered under CER by the Project Proponent and instructed PP to submit in writing the activity that they will support under CER.

**Decision:** The Authority decided to grant the extension of validity of Environmental Clearance for a period of 2 years to Project Proponent upto 14/09/2024.

- 4. Any other matter with permission of the chair.
- 1. To decide on complaint received from Baya Varak against destruction of forest and animals which comes under endemic species at Tulaskarwadi, pernem Goa.

Deliberation: Based on the complaint received from Baya Varak, the Authority had asked the Chief Engineer National Highways & Road & Building to confirm whether any Environmental Clearance was obtained to the said project.

Decision: As per the reply received from the Chief Engineer National Highways & Road & Building, it is informed that the Environmental Clearance for Mopa Airport including the link road to Mopa Aiporrt has been obtained by the Directorate of Civil Aviation in 2015. As there is nothing justifiable in the complaint, the Authority decided to drop the matter.

2. To decide on Complaint received from Baya Varak against GMR Goa International Airport Limited not following the EC conditions

Decision: After scrutinizing the application, the Authority decided to ask the Goa State Biodiversity Board to submit the details of tree plantation done by them at Mopa International Airport.

3. To decide on complaint from Jose Vincent Gomes regarding Construction of Jetty of Captain of Ports

Decision: The Authority has decided to refer back this matter to SEAC for reexamination whether Environment Clearance required or not.

As there was no other point for discussion, the meeting ended with thanks to chair.
