The Authority after detailed discussion and deliberation decided the following:

 Serial No. 1: This proposal was deferred in 5.68 meeting of SEIAA as "DSR was submitted for Granite but the proposal is for Marble & Phyllite Schist". Now, the PP





has submitted the correct DSR. Hence, the Authority accepted the recommendations of SEAC and decided to **grant EC to this proposal.**

- 2. Serial No. 2: This proposal was deferred in 5.58 meeting of SEIAA as "CCR was more than one year old". Now, the PP has submitted the latest CCR, It has been brought into notice of the Authority that the PP has not complied with GC no. 10 & 15 as per the CCR submitted by the Project Proponent. Under these circumstances of non-compliance of conditions of EC issued earlier, it would not be possible to accord the amendment in EC. Hence, the Authority decided to defer this proposal for additional information regarding action taken report to be submitted within 45 days.
- 3. Serial No. 3: This proposal was deferred in 5.57 meeting of SEIAA as "CCR was not submitted". Now, the PP has submitted the latest CCR, It has been brought into notice of the Authority that the PP has not complied with GC no. 10 & 15 as per the CCR submitted by the Project Proponent. Under these circumstances of non-compliance of conditions of EC issued earlier, it would not be possible to accord the EC for expansion. Hence, the Authority decided to defer this proposal for additional information regarding action taken report to be submitted within 45 days.
- 4. Serial No. 4: This proposal was deferred in 5.69 meeting of SEIAA as "the certificate submitted by PP/ Consultant, was found ambiguous. Also, LoI for inclusion of mineral has expired. Hence, the Authority decided to defer this proposal for submission of valid LoI by Project Proponent and seek clarification from Water Resources Department regarding WRD Certificate submitted by the project proponent regarding status of the applied area w.r.t Hon'ble High court order in Abdul Rahman vs State of Rajasthan". PP/Consultant has submitted the same letter again therefore, the Authority decided to close & delist this proposal.
- 5. Serial No. 5: SEAC in its 5B.41st meeting recommended to close and delist this proposal since "PP/ Consultant failed to submit an adequate reply to the query letters issued 20.12.22 and 12.1.23. On the basis of production certificate issued by AME, Sawar. The committee recommended to close & delist this proposal and to apply for ToR under Violation".

SEIAA considered the proposal in its 5.69 meeting and decided to defer the proposal for "closer examination and give an opportunity of personal hearing to the project proponent before taking final decision" During the personal hearing

consultant/project proponent submitted the Past Production certificate. The Authority examined the production figures submitted by PP in context of the observation of SEAC and disagrees with the views of SEAC. The contention of SEAC of considering monthly production of 2006 and reaching a conclusion of violation on account of production in a month exceeding production in the preceding month is completely unjustified. The Authority does not consider this to be a case of violation. Hence, the proposal is **sent back to SEAC** for examining on technical ground for according EC.

6. Serial No. 6: The ToR was granted to this proposal in 2016 by MoEF&CC. SEAC has recommended to Close & Delist the proposal. SEIAA in its 5.69th meeting had deferred the proposal to accord an opportunity for personal hearing to the project proponent. The PP and consultant were present for personal hearing. There is a discrepancy in the ToR granted for production capacity (10855 TPA ROM) and the proposal submitted by PP with compliance of ToR and for grant of EC with production capacity of 27139 TPA (which includes mineral and overburden). The contention of PP during the hearing to drop the overburden, for which they will again apply for amendment in EC is not considered proper. Amendment in EC is appropriate only when there are developments subsequent to issue of an EC or certain material facts were omitted at the stage of grant

The Authority is of the view that the TOR was issued in 2016, i.e. 7 years back, the monitoring data submitted with ToR compliance is of 2017, i.e. 6 years old and the production capacity for which EC is being sought is now substantially higher and including the overburden, than for what the TOR was issued. Hence the Authority decided to close and delist this proposal, as recommended by SEAC, and directed the PP to apply afresh for ToR.

7. **Serial No. 7:** This proposal was deferred in 5.69th meeting of SEIAA as "The Authority was of the view that the parking provided in this proposal is inadequate with respect to dwelling units and decided to call the PP/Consultant for Personal Hearing"

During the personal hearing, PP/Consultant informed that they have changed the proposal in respect of the dwelling units. However, there is no intimation of such change on record. PP was advised to officially submit the revised proposal after which the proposal may be examined. Hence, the Authority decided to <u>defer this proposal</u> for additional information to be submitted within 45 days.

8. Serial No. 8: This proposal was deferred in 5.69 meeting of SEIAA as "The Authority was of the view that the parking provided in this proposal is inadequate with respect to commercial facilities, cinema, gaming zone, offices etc. Hence, the Authority decided to defer this proposal and decided to call the PP/Consultant for Personal Hearing for the presentation on the capacity & utilization of the proposed commercial units"

During the personal hearing, PP submitted the requisite details which were found unsatisfactory. Hence, the Authority decided to <u>defer this proposal for additional information</u> and direct the PP to submit <u>within 45 days</u> the comprehensive plan with provisions for reserved parking (Offices, Shops, and Flats etc. and all staff engaged) & visitors on separate floors of the basement in such a manner that there is no outflow of vehicles outside the premises of the complex.

9. Serial No. 9: This proposal was deferred in 5.69th meeting of SEIAA wherein "Validity of Mining plan of this proposal is expiring on 31/03/2023. The Authority was of the view that since this proposal is for re-validation of EC, the mining plan must be updated accordingly. Hence, the Authority decided to defer this proposal for additional information and call PP/Consultant for personal hearing for clarification on production capacity pertaining to lease area"

During the personal hearing, PP/Consultant submitted the clarification on production capacity pertaining to lease area and also informed that Mining plan approval is under process. Hence, the Authority decided to <u>defer the proposal for submission of valid Mining Plan within 45 days.</u>

10. Serial No. 10: This proposal was deferred in 5.69 meeting SEIAA as "There is no parity in production capacity of ToR letter, Earlier EC and EIA study of this proposal. Hence, the Authority decided to defer this proposal and call PP/Consultant for personal hearing for clarification on production capacity pertaining to lease area"

During the personal hearing, PP/Consultant submitted the clarification on production capacity pertaining to lease area which was found satisfactory. Hence, the Authority decided to **grant EC to this proposal**.

11. Serial No. 11 & 24: In this proposal DSR is submitted for other mineral but the proposal is different mineral. Hence, the Authority decided to <u>defer these proposals</u> for additional information to be submitted within 45 days.

- 12. Serial No. 12, 13 14, 16, 17, 20, 21, 22, 23, 25, 27, 31, 32, 35, 38, 39, 40, 41, 42, 43, 44, 45, 46, and 47: The Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to these proposals.
- Serial No. 15: The Authority accepted the recommendation of SEAC and decided to close & delist this proposal.
- 14. Serial No. 18 & 19: In these proposals, Approval of Mining Scheme is in the name of former lessee and Khasra Number is wrongly mentioned in Aravalli Certificate submitted by PP. Hence the Authority decided to <u>defer these proposals for additional information to be submitted within 45 days.</u>
- 15. Serial No. 26 & 37: The Authority accepted the recommendation of SEAC and decided to grant Amendment in EC to these proposals.
- 16. Serial No. 28: In this proposal Kaila Devi Wildlife Sanctuary & Ranthambore TR is at a distance of 5.1 km from the lease area. Since the production has been carried out from 2006 to 2008 without obtaining EC and NBWL Clearance has not been obtained as mentioned in conditions of earlier EC obtained on 2.6.2016, the Authority accepted the recommendation of SEAC and decided to <u>close & delist this proposal</u> with the direction to apply for ToR under violation and apply for NBWL Clearance.
- 17. Serial No. 29 & 30: AME Salumbar, vide his letter dated 10th March 2023 addressed to the PP, has revoked the Aravali Certificates issued on 26th August 2019 and 17th Feb 2023 respectively to these proposals and has stated that prior environmental clearance not be obtained based on those certificates. A copy of the letter has been endorsed to SEIAA with a request to not accord EC on that account. This fact was not brought in the knowledge of SEIAA by the project proponent at the time of personal hearing on 17th March 2023 in 5.68th meeting of the Authority, which is tantamount to concealment of material fact.

The Hon'ble Supreme Court in W.P. (Civil) No. 202/1995 T.N. Godavarman vs. UOI & Oth. vide order dated 16-12-2002 prohibited and banned the mining activities in the entire Aravalli hills. Further clarification was issued by the Hon'ble Court vide Order dated 08-04-2005, in the contempt petition (C) No. 412/2004. The competent authority in the State to implement the directions of the Hon'ble Court is the Mining Department.

SEIAA has been considering only such cases of mining in the Aravalis, wherein the AME concerned has issued a certificate that the lease area of the PP concerned is not in violation of the orders of the Hon'ble Supreme Court.

In view of the letter dated 10th March 2023 issued by AME Salumbar, the Authority decided to suspend the <u>ToR</u> letter issued dated 20.3.2023 for these proposals till further orders and to issue show cause notice to the PP in regard to why the letter issued for grant of ToR be not cancelled and the proposals rejected.

- 18. Serial No. 33 & 34: The Authority was of the view that the parking provided in this proposal is inadequate with respect to dwelling units. PP is directed to revise the parking provision keeping in view that there should not be outflow of vehicles on the road. Hence, the Authority decided to <u>defer this proposal for additional information to be submitted within 45 days.</u>
- 19. Serial No. 48: In this proposal duly signed past production certificate is not submitted. Hence, the Authority decided to <u>defer this proposal for additional information to be submitted within 45 days.</u>
- 20. Serial No. 49 & 50: The Authority decided to grant Transfer of EC to these proposals.
- 21. Serial No. 51 & 52: In these proposals duly signed past production certificate is not submitted and Mining Plan is also expired. Hence, the Authority decided to <u>defer these</u> proposal for additional information to be submitted within 45 days.

22. Serial No. 36: This proposal was already considered in the earlier meeting of SEIAA and was recommended for EC.
