CONSIDERATION/RECONSIDERATION OF ENVIRONMENTAL CLEARANCE

(1) Proposed Setting up a Common Bio-Medical Waste Treatment and Disposal Facility (CBMWTF) at Plot No. R.S. & L.R. 262, J.L. No. 18, Mouza: Bhupatipur, P.S.: Jagatballabpur, Dist.: Howrah, West Bengal by **M/s. RVD Waste Tech Pvt. Ltd.**

INTRODUCTION

The project proponent (PP) made online application vide proposal no. **SIA/WB/INFRA2/451442/2023** dated **07 November 2023** seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at Sl. No. **7(da) Bio-Medical Waste Treatment Facilities** under Category "**B1**" of EIA Notification 2006.

The PP had obtained ToR vide No. vide No. 1147-2N-69/2019(E) dated 02.12.2019 against proposal no. SIA/WB/MIS/40698/2019.

The SEAC, during its 70th meeting held on 07.05.2025, recommended the proposed project for Environmental Clearance.

SEIAA considered the proposal during its 71^{st} meeting held on 22.05.2025 and decided that the following should be submitted in the PARIVESH portal:

- a) Scrubbing medium used for venturi and packed bed scrubber.
- b) Detailed temperature drop in each phase of equipment from incinerator to stack.
- c) Radius of area of operation and the method used to arrive at the proposed bed count. Provide copy of source material.
- d) No. of existing CBWTFs operating within the radius of influence proposed and their existing capacity with respect to number of beds catered.
- e) Source of effluent generation and the constituents of effluents generated.
- f) Specific time frame of installation and commissioning of phase I and phase II as mentioned in the submission.

The PP uploaded their reply on 31.05.2025.

Hence, the SEAC recommended that the present proposal for EC may be forwarded to SEIAA for rejection.

Therefore, the proposal was referred back to SEAC for uploading it under rejection category.

The SEAC considered the proposal in the 73rd meeting of SEAC, WB (2023-2026) held on 04.06.2025 and decided that the proposal may once again be uploaded in Parivesh portal under 'Rejection' category.
