

The checklist is also available in the website of SEIAA, Odisha (www.orissaseiaa.gov.in). If you are unable to attend the meeting, you can depute an authorized representative of your unit who can explain the project and also respond to the queries / suggestions of the committee members. He should be authorized to offer commitments on behalf of the proponent.
