In continuation of the Proposal submitted by you on "proposed expansion project by M/s., Bhilosa Industries Pvt. Ltd. for expansion for increase in production capacity of manmade fibers at survey no: 199, 200, 201/2, 201/1/3, 202/1/1, 202/1/3/1, 201/1/2 P No.3, 202/2/2, 202/1/2, 202/2/3, 202/2/4, 202/P.P.No.30,31,32,33,34, 202/P.P.No.1,2,3,4, 192/1, 192/2/2, 191/1, 106/1/2/3,4,5, Industrial zone, Naroli, DNH," the draft Terms of Reference (ToR) have been discussed and finalized during the Union Territory Expert Appraisal Committee (UTEAC), Daman & Diu meeting held on 05th December, 2019 for preparation of EIA/EMP report.

The committee prescribed the following Specific ToR in addition to the Generic ToR available in the MoEF's Sector specific EIA Manual for "Manmade Fibres Industry" for preparation of the EIA report in addition to all the relevant information as per the generic structure of EIA given in Appendix III in the EIA Notification, 2006.

## Specific ToR:

- 1) The project proponent made a detailed presentation regarding the project to the SEAC committee. The following observations are made by the Committee
- 2) The User Agency should submit a letter stating that the location of the plant falls within the Notified Industrial Zone, failing which public hearing has to be carried-out by the User Agency.

3) In addition to the standard ToRs published by the MoEFCC under sector 5(f) shall be considered for preparation of EIA Report.

4) This Terms of Reference is valid for period for 3 years from the date of issue of ToRs for submission of EIA / EMP report which can be extended for 1 year with request of the Project Proponent (This confirms with the MoEFCC Government of India Office Memorandum No. J-11013/41/2006-IAII(I) dated 23.03.2010).

The consultants involved in the preparation of EIA report, shall have accreditation with Quality Council of India / National Accreditation Board of Education and Training (QCI/NABET) and would need to include a certificate in this regard in the EIA reports prepared by them and data provided by other Organization(s)/Laboratories including their status of approvals etc.
