MINUTES OF THE 64th GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 05/10/2021 AT 04.00 PM. IN THE CONFERENCE ROOM OF THE 4th FLOOR, DEMPO TOWER, PATTO, **PANAJI-GOA.**

The sixty-fourth meeting of the Goa-SEIAA (hereinafter referred as 'Authority') was held on 05th October 2021 at 04.00 pm. in the conference room, 4th floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (refer $\underline{Annexure} - 1$).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (refer Annexure - 2) to be taken up for discussion / deliberations and suitable decisions. Accordingly, the same were considered as detailed below -

1. To decide on project proposal received from Goa Cricket Association, for "Construction of Cricket Stadium" Dhargalim, Pernem - Goa.

The representative of Goa Cricket Stadium Shri. Vipul Phadke, Hon'ble Secretary and Shri. Harish Shinde, CEO, Goa Cricket Association, Dr. Shobha Kamath, Environment Consultant, and Architect Shri. Uday Joshi, appeared before the Authority and explained the details of the Goa Cricket Stadium.

Decision: After discussion and considering recommendation by the Goa-SEAC the Authority, members unanimously decided to recommend the said project proposal for grant of Environmental Clearance under provision of EIA Notification 2006 (as ammended) with a condition that Project Proponent should adhere to the commitment of keeping not less than 10,000 sq.m area as a virgin land/undisturbed and also fence it up to protect it. Also Project Proponent to submit revised plan marking reserved area on Parivesh portal.

2. To decide on proposed residential project Alcon Construction (Goa) Pvt. Ltd. Located at Survey No. 112/1 and 112/2, Tonca, Taleigao, Tiswadi North Goa. Application dated 17th September 2021 received on Parivesh portal (website of MoEF&CC).

Decision: After scrutinizing the application and documents submitted by the Project Proponent, the Authority decided to inspect the site on 13th October, 2021

at 11:30 A.M onwards to verify site specific conditions and thereafter call the Project Proponent for presentation before the Authority to decide further.

3. To decide on application for Environmental Clearance for sand extraction in Chapora river (6 zones) received from District Collector, North Goa.

Decision: After considering the committee's recommendation and scrutinizing the application and documents submitted by Project Proponent, the Authority decided to recommend proposal for extraction of Sand at Chapora river by traditional (manual) method only at zone 1, 2,5 and 6 in the first instance with 50% capacity for first 3 years respectively and then to decide further capacity thereafter. Whereas proposals pertaining to zones 3(Part 1 and Part 2) and 4 may be referred back SEAC to conduct further scientific study in the matter.

4. To decide on application (Auto ToR Granted) for proposed expansion on MS Billet & TMT Bars manufacturing unit of M/s Global Ispaat Pvt. Ltd. at Plot No. L-16, L-17, M-18 & M-19 of Cuncolim Industrial Estate, Cuncolim Village, Salcete Taluka, South-Goa. This application dated 11th August 2021 received on Parivesh portal (website of MoEF&CC).

Decision: After scrutinizing the application and documents submitted by the Project Proponent the Authority decided to direct GSEAC to visit the site and identify if any specific conditions to be incorporated and also decided to issue show cause notice cum personal hearing before Goa -SEIAA based on 135th and 136th GSEAC minutes of meeting.

5. To decide on re-validation of the Environmental Clearance of the project Marvel Resorts Private Limited dated 30th March 2021 received on Parivesh portal (website of MoEF&CC).

Decision: After scrutinizing the application and documents submitted by the Project Proponent for re-validation the Authority decided to inspect the site on 13th October, 2021 at 11:00 A.M onwards to see the site condition and thereafter call the Project Proponent for discussion.

within a period of one month before this Authority on receipt of the letter along

with Terms of Reference.
