DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The project had earlier been discussed during 29th meeting held on 13.03.2021 during which the committee recommended TORs to the project subject to title verification of the mining block by the concerned revenue authority and subject to exclusion of the private land if any involved due to change of Nalla course and subject to revision of project cost and exclusion of the active water channel.
- b) The project came for appraisal for grant of EC during the 68th meeting held on 30/10/2021 during which it was observed that the PP has obtained title verification of the mining block besides clarification from the MDLTF cell stating that the PP is not involved in any illegal mining activity in the designated block. However, the Committee did not approve the case during the session and further desired:
 - i. PP to obtain *'fit for mining certificate'* from G&M Dept. in view of depleted nature of minor minerals as observed on the Google image.
 - ii. To provide two separate haulage routes for northern and Southern Shoals, with exclusion of active water channel while calculating the targeted mineral production and submission of revised EIA/PFR accordingly.
 - iii. To obtain field verification report of observations relating to presence of off-take points of irrigation kuhls from the concerned Xen Irrigation Dept.
 - iv. Compliance to specific ToR condition relating to photographs of display screen of Air Quality Monitoring Station displaying the dates of collection of baseline data.
 - v. Revision of project cost.
 - vi. Revision of EMP/CER budget.
 - vii. Revision of the mining plan with mine closure plan, revised mining depth, surface plan, area targeted mineral production and replenishment and its *denovo* approval by the competent authority prior to grant of EC or as decided by JKEIAA.
 - viii. Mining depth be restricted to max. 1m in aggregate in view of nonavailability of replenishment data in the DSRs formulated by the G&M Dept. A nominal bulk density of 2.0 in absence of actual measurements.
- c) In the instant meeting, the Committee made following observations:
 - i. The PP has obtained *'fit for mining certificate'* issued by DMO, G&M Dept. Poonch, Vide letter No: DMO-Poonch /21-22/539-40 dated: 20/11/2021 stating that the mining site has naturally replenished postmonsoon and there is enough material to be mined out from the site.
 - ii. The PP has submitted the revised transportation route with two separate haulage routes for Northern (0.52 km) & Southern (1.32 km) Shoals. The active water channel portion has been left out after resizing of the mining block to 4.26 Ha from 8.54 Ha. The remaining portion of 4.26 Ha of mining

block has been divided into Northern shoal (2.26 Ha) & Southern Shoal (2.00 Ha) respectively while excluding the active water channel.

- iii. The NOC has been obtained from the Executive Engineer, I &FC Division, Poonch vide letter No. IFCP/ 1196 dated: 25/11/2021 also stating therein that the mining block is 238 m away from the head of irrigation Kuhl (Kanyuian Kuhl).
- iv. Compliance to specific TOR condition relating to photographs of display screen of air quality monitoring station is awaited.
- v. The project cost has been revised, however same needs to be updated after considering revised EMP/CER as suggested in remarks column.
- vi. EMP/CER budget needs to be revised with appropriate budget as suggested in the remark's column, prior to grant of EC.
- vii. Revised mining plan is still awaited and therefore needs to be submitted, prior to grant of EC.

RECOMMENDATION OF THE COMMITTEE:

In view of the above deliberations and insight gained during the above cited appraisal process, the Committee recommended the case for the grant of environmental Clearance subject to: -

- a) Standard and Specific Conditions as per Annexure B to these Minutes of Meeting.
- b) Compliance of observations made herein above under deliberations, prior to grant of EC.
- c) Revision of Mining plan as deliberated herein above, prior to grant of EC.
- d) Strict adherence to the terms and conditions of the NOCs of the stakeholder departments which need to be monitored by the enforcement agencies and concerned dept.
- e) No JCBs/ Excavators/ Bulldozers to be used in mining and no water course to be disturbed while transporting minor minerals.
- f) Maximum targeted mineral production of **51100 MT**.
- g) Condition the geographical coordinates as per revised area conveyed by G&M Dept. are mentioned in the EC letter by JKEIAA
- **h**) Validity of only three years from the date of commencement of the mining operations duly certified by the District Mineral Officer concerned with intimation to the JKEIAA and JKPCB in view of non-availability of replenishment data.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The project had earlier been discussed during 32nd meeting held on 01.04.2021 during which the Committee had asked for :
 - i. Prior report from district level Committee compromising of I &FC, PWD, Superintendent of the Hospital/ CMO of the District, Soil Conservation Dept., Revenue Dept. and G&M department stating that operation of mining block in close vicinity would not lead to any adverse environmental implications for the nearby Hospital.
 - ii. Prior clarification from the Multi department District Level Task Force (MDLTF) cell, stating that the PP is not involved in any kind of illegal mining activity in the said mining block.
- b) Now the PP has applied for EC under B2 category after resizing the mining block from 4.51 Ha to 2.95 Ha after maintaining a safe distance of more than 500m to the civil structures.
- c) The PP has also furnished cluster certificate for consideration under B2 category.
- d) In the instant meeting the Committee made following observations:
 - i. The PP has obtained clarification from MDLTF cell vide letter No: DCS/SS/2021 726-38 dated: 23/11/2021 issued by Deputy Commissioner, Anantnag stating that the PP is not involved in any illegal mining activity in the mining block.
 - **ii.** The NOC has been furnished by Medical Superintendent (Model Hospital Dooru) Vide letter No. Est/SDHD/Misc/1808-11 dated 16/07/2021 stating that the said hospital has no objection for extraction work at minor mineral block 01 based on the technical report of Executive Engineer of the Flood Control Dept., Anantnag, who, however, has made no mention of any impact on the hospital. The Committee observed that the NOC from the Medical

Superintendent in standalone capacity was not in conformity with the requirement set out by JKEAC and does not entirely clarify the situation to the extent that mining activity including transportation of the mined material will not adversely affect the environmental setting required for the hospital. PP, therefore, shall be required to submit joint report as suggested earlier, **prior to grant of EC.**

- iii. Features indicative of irrigation Khuls were observed on Google image of Nov, 2020 in close vicinity of the resized mining block. Therefore, the Committee desired project proponent to obtain field verification of the observations by the concerned Xen Irrigation Dept. In case, it is found that such irrigation facilities are not actually existing, same needs to be recorded by the concerned hydraulic engineer with consent of local PRI, with seal and signature, certifying therein that there are no irrigation off-take points within 200m of the mining block boundary, preferably on the back side of Colour Google image of the area depicting the mining block boundary and Kuhls/canals off-take points prior to grant of EC. Besides above, NOC from the Tehsildar concerned shall also be obtained by the PP, in case the irrigation facility is a Zamandari kuhl, prior to grant of EC.
- **iv.** Exclusion of active water channel while calculating the targeted mineral production and submission of revised PFR **prior to grant of formal EC.**
- v. Further resizing of the block required to be done to ensure a safe distance of 500m from the boundary of hospital resulting in net area of the mining block within pillars CDHI as 2.40 Ha only, prior to grant of EC.
- vi. Project cost has been underestimated by the consultant as it does not include cost of EMP, CER and therefore needs to be revised, **prior to grant of EC.**
- vii. EMP budget needs to be revised with appropriate budget as suggested in the remark's column above, **prior to grant of EC.**
- viii. Revision of the mining plan with mine closure plan, revised area, mining depth, bulk density, surface plan, targeted mineral production and replenishment and its *denovo* approval by the competent authority **prior to grant of EC.**
 - ix. Mining depth of 3.0 m & bulk density of 2.1 adopted in the instant mining plan were not agreed by the committee. Mining depth be restricted to max. 1m in aggregate and bulk density of 2.0 only be adopted for calculating the production targets in absence of actual field measurements.
 - **x.** Copy of Letter of Intent has not been submitted as part of the documentation and the Committee desired that the PP should submit its copy **prior to grant of EC.**

RECOMMENDATION OF THE COMMITTEE:

In view of the above deliberations and insight gained during the above cited appraisal process, the Committee recommended the case for the grant of Environmental Clearance subject to: -

- a) Standard and Specific Conditions as per Annexure B to these Minutes of Meeting.
- b) Compliance of observations made herein above under deliberations, prior to grant of EC.
- c) Revision of mining plan as specified herein above, prior to grant of EC.'
- d) NOC from the concerned Tehsildar w.r.t Zamindari Kuhl prior to grant of EC
- e) Clarification from the concerned Xen Irrigation Dept. specifically mentioning presence or absence of irrigation offtake points within 200m of the mining block, prior to grant of EC.
- f) Strict adherence to the terms and conditions of the NOCs of the stakeholder departments which need to be monitored by the enforcement agencies and concerned dept.
- g) No JCBs/ Excavators/ Bulldozers to be used in mining and no water course to be disturbed while transporting minor minerals.
- h) Maximum targeted mineral production of 28800 MT.

- i) Condition the geographical coordinates as per revised area conveyed by G&M Dept. are mentioned in the EC letter by JKEIAA.
- j) Validity of only three years from the date of commencement of the mining operations duly certified by the District Mineral Officer concerned with intimation to the JKEIAA and JKPCB in view of non-availability of replenishment data.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- a) The project had earlier been discussed during 19th meeting held on 17.11.2020 during which the Committee recommended ToRs in favour of the project subject to condition that the mining block is relocated to exclude green area and to tap materials south of the Pillar-C of the mining block to appropriately train the nallah.
- b) The project came under appraisal for grant of EC during the 76th meeting held on 30/11/2021 during which the committee did not approve the case. However, the Committee had sought prior action on following points for reconsideration of the case:
 - i. Clarification from Multi Dept. District level Task Force (MDLTF) Cell w.r.t fixing of responsibility for heavy illegal mining in the block.
 - ii. Submission of *'fit for mining certificate'* for the mining block from the G&M Dept.
 - iii. Field verification report from the Xen Irrigation Dept. w.r.t presence or absence of offtake point of irrigation canal/kuhls within 200m from the mining block substantiated with certificate on Google image depicting the same, with local PRI on board.
 - iv. Submission of Technical Feasibility Report from Joint Inspection Committee comprising of representatives of Revenue, G&M Dept., Irrigation & Flood Control Dept. and Fisheries Dept. certifying therein, that the mining activity in the block would not cause any adverse environmental impact on the existing irrigation facilities, flood protection works and fisheries potential of the nalla.
 - v. Submission of clarification / specific NOC w.r.t the two nurseries in close vicinity of the block from the concerned department's viz. Forest/Horticulture Dept. or local PRI/private owners, as the case may be.
 - vi. Exclusion of active water channel while calculating the targeted mineral production and the revised PFR/EIA be submitted prior to grant of formal EC.

DELIBERATIONS/SPECIFIC OBSERVATION(S) OF COMMITTEE, IF ANY:

- 1. The project is a group housing project submitted by the PP under B2 category and falls under 8(a) of the schedule to EIA Notification of 2006.
- 2. The Committee examined the KML file on the latest available Google Image of July, 2021 and observed that the total area of the polygon represented by the KML file submitted by the consultant comprises of approx. 22 kanals and 7 marlas against the 27 Kanals 7 Marlas depicted on the conceptual Site Plan with area statement.
- 3. The Committee examined the documents of the plot earmarked for construction under the project comprising of 2 kanals, 1kanal 17 Marlas and 21 Kanals 19 Marlas covered under sale deeds in favour of Sh. Ab. Hamid Chaudhary falling under Khsra Nos. 415 and 1543. Documents pertaining to khasra Nos. 411, 412, 413 and 414 as mentioned in Form 1/Form1A and other documents were not found to be part of the documentation.
- 4. The consultant was asked to clarify the matter as above and to obtain a certificate from the Tehsildar concerned clearly indicating the title of the land, total area of the plot, geographical coordinates and Khasra Nos, rights to construct upon which vest with the project proponent.
- 5. The PP will also submit a categorical NOC from the Dy. Commissioner, Jammu to the effect that the land to be constructed upon is not a subject matter of any litigation pending in any competent Court of law including Hon'ble High Court of Jammu, Kashmir and Ladakh. This certificate must not be older than 30 days from the date of fresh application.
- 6. The Committee asked the consultant as to why the owner Shri Ab Hamid Chaudhary has not personally applied for grant of EC and wanted to know the locus standii of the project proponent viz. M/S Omkar Nests Pvt. Ltd., Jammu. In this connection, the Committee asked for submission of authorization of land owner, Memorandum of Association of the Company, allied documentation and its registration details. Although, the PP presented an agreement during the course of virtual meeting which did not comprehensively establish the locus standi of the proponent viz. M/S Omkar Nests Pvt. Ltd., Jammu to approach JKEIAA for grant of EC. Therefore, the requisite documents shall have to be submitted as and when the case is brought for reconsideration.
- 7. The Committee desired that the proposed project should be in conformity with the approved master plan of Jammu City and desired specific NOC from the JDA in this regard.
- 8. The Committee also desired prior submission of comfort letters from PDD, PHE and Disaster Management Dept. etc.
- 9. The consultant was asked to indicate the percentage of green cover of the project and to submit the landscape plan duly approved by the competent authority.

RECOMMENDATION OF THE COMMITTEE

In view of the above deliberations / observations made by the Committee herein above, the Expert Appraisal Committee rejected the case in the present form for reasons cited above. However, the PP, if he so desires may approach the JKEIAA for reconsideration of the case after ensuring compliance to the observations made herein above under deliberations.

- a) The case had been discussed by the Expert Appraisal Committee earlier during the 23rd Meeting held on 23/06/2021 and 52nd Meeting held on 14/08/2021 during which the expert Appraisal Committee recommended grant of Terms of Reference to the project subject to resizing of the block to maintain safe distance to the bridge besides, excluding the active water channel, revising the mining plan/PFR/mining depth/surface plan etc..

District level Task Force (MDLTF) Cell needs to be obtained for fixing responsibility in this regard.
- d) The Xen, PHE indicates presence of a dug well in the Nalla without indicating the distance of the said dug well from the mining block. The PP shall obtain fresh NOC from the Xen, PHE certifying that the dug well is located at a location more than 200 m away from the said mining block and that mining operations shall not adversely affect the availability of water in the said dug well.
- e) The conditions of NOC of stakeholder departments need to be adhered to in letter and spirit.
- f) Revision of the mining plan with mine closure plan, revised mining depth, revised surface plan, targeted mineral production and replenishment and its denovo approval by the competent authority.

- a) The case had been discussed by the Expert Appraisal Committee earlier during the 16th Meeting held on 05/10/2020 with original mining bock area of 7.94 Ha and subsequently in 71st Meeting held on 13/11/2021 when the project proponent had applied after resizing the mining block to 2.87 Ha. During the 71st Meeting, the Expert Appraisal Committee did not approve the case and desired prior compliance to the following:
 - i. To obtain consent from all stakeholders including the rightful owners and the local PRIs through the concerned competent revenue authority as per the title

the land had been found to comprise of proprietary land, Shamlat and Ghascharai.

- ii. To obtain field verification report from the concerned Xen Irrigation Dept. with local PRI on board duly certified preferably on the back side of Colour Google image of the area depicting the resized mining block boundary and Khul off-take points, if any within 200m of the mining block boundary.
- iii. Title verification from the competent authority.
- iv. Illegal mining Report from the Multi Dept. District level Task Force (MDLTF) Cell.
- v. Revision of EMP/CER budget.
- vi. Revision of Mining Plan
- 1. Now, the PP has again approached JKEIAA for reconsideration of the case.
- 2. Notwithstanding the fact that the project proponent has complied with the observations/conditions stipulated above, the revised NOC issued by the Xen Irrigation Dept. and produced before the Committee vide letter dated 14/12/2021 indicates that Saknari Canal and Panzwal canal are off taking from the branch of Ferozpora Nallah in this reach.
- 3. The Committee examined the feedback Google image forwarded by the Xen and identified the location on the live Google Image and noted that the two water courses traverse right through the proposed mining block and any mining activity in close vicinity will adversely affect the capacity of the said water courses to transport water, thus affecting the availability of water for irrigation.

RECOMMENDATION OF THE COMMITTEE

In view of the above observation at serial No.3 herein above, the Committee did not agree to appraise the case for grant of EC and the case is therefore rejected.

STANDARD AND SPECIFIC CONDITIONS FOR GRANT OF ENVIRONMENTAL CLEARANCE WITH RESPECT TO RIVER BED MINING PROJECTS ON LEASE BASIS

STANDARD CONDITIONS :-

Statutory compliance

- 1) This Environmental Clearance (EC) is subject to orders/judgment of Hon'ble Supreme Court of India, Hon'ble High Court of J&K, Hon'ble NGT and any other Court of competent jurisdiction, as may be applicable.
- 2) The Project Proponent complies with all the statutory requirements and judgement of Hon'ble Supreme Court dated 2nd August,2017 in Writ Petition (Civil) No. 114 of 2014 in matter of Common Cause versus Union of India & Ors before commencing the mining operations.
- 3) The UT Government of J&K shall ensure that mining operation shall not be commenced till the entire compensation levied, if any, for illegal mining paid by the Project Proponent through their respective Department of Mining & Geology in strict compliance of Judgement of Hon'ble Supreme Court dated 2nd August, 2017 in Writ Petition (Civil) No. 114 of 2014 in matter of Common Cause versus Union of India &Ors.
- 4) This Environmental Clearance shall become operational only after receiving formal NBWL Clearance from MoEF&CC subsequent to the recommendations of the Standing Committee of National Board for Wildlife, if applicable to the Project.
- 5) This Environmental Clearance shall become operational only after receiving formal Forest Clearance (FC) under the provision of Forest Conservation Act, 1980, if applicable to the Project.
- 6) Project Proponent (PP) shall obtain Consent to Operate after grant of EC and effectively implement all the conditions stipulated therein. The mining activity shall not commence prior to obtaining Consent to Establish / Consent to Operate from the concerned State Pollution Control Board/COMMITTEE.
- 7) The PP shall adhere to the provision of the Mines Act, 1952, Mines and Mineral (Development & Regulation), Act, 2015 and rules & regulations made there under. PP shall adhere to various circulars issued by Directorate General Mines Safety (DGMS) and Indian Bureau of Mines from time to time.
- 8) The Project Proponent shall obtain consents from all the concerned land owners, before start of mining operations, as per the provisions of MMDR Act, 1957 and rules made there under in respect of lands which are not owned by it.
- 9) The Project Proponent shall follow the mitigation measures provided in MoEFCC's Office Memorandum No. Z-11013/57/2014-IAJI (M), dated 29th October, 2014, titled "Impact of mining activities on Habitations-Issues related to the mining Projects wherein Habitations and villages are the part of mine lease areas or Habitations and villages are surrounded by the mine lease area".
- 10) A copy of EC letter will be marked to concerned Panchayat / local NGO etc. if any, from whom suggestion / representation has been received while processing the proposal.
- 11) State Pollution Control Board/COMMITTEE shall be responsible for display of this EC letter at its Regional office, District Industries Centre and Collector's office/ Tehsildar's Office for 30 days.

- 12) The Project Authorities should widely advertise about the grant of this EC letter by printing the same in at least two local newspapers, one of which shall be in vernacular language of the concerned area.
- 13) The advertisement shall be done within 7 days of the issue of the clearance letter mentioning that the instant project has been accorded EC and copy of the EC letter is available with the State Pollution Control Board/COMMITTEE and web site of the Ministry of Environment, Forest and Climate Change (*www.environmentclearance.nic.in*). A copy of the advertisement may be forwarded to the concerned MoEFCC Regional Office for compliance and record.
- 14) The Project Proponent shall inform the MoEF&CC for any change in ownership of the mining lease. In case there is any change in ownership or mining lease is transferred than mining operation shall only be carried out after transfer of EC as per provisions of the para 11 of EIA Notification, 2006 as amended from time to time.

Air quality monitoring and preservation

- 15) The PP shall generate data on air quality parameters PM10, PM2.5, NO2; CO and SO2 etc. as covered in the EIA Report covering the aspects of transportation, extraction, etc in the impact zone as per the site condition to ascertain the exposure characteristics at specific places and submit the same along with 6-monthly compliance report to concerned IRO. The data be also displayed prominently at the site.
- 16) Effective safeguard measures for prevention of dust generation and subsequent suppression by way of regular mechanical water sprinkling& other measures shall be carried out in areas prone to dust pollution including haulage route.

Water quality monitoring and preservation

- 17) In case, immediate mining scheme envisages intersection of ground water table, then Environmental Clearance shall become operational only after receiving formal clearance from CGWA. In case, mining operation involves intersection of ground water table at a later stage, then PP shall ensure that prior approval from CGWA and MoEFCC is in place before such mining operations. The permission for intersection of ground water table shall essentially be based on detailed hydro-geological study of the area.
- 18) Regular monitoring of springs in and around the mine lease shall be carried out and recorded maintained. Natural water bodies and or streams which are flowing in and around the project area should not be disturbed. The PP in consultation with concerned department shall regularly monitor the groundwater table in open dug well located in the nearby villages to ascertain the impact of mining over ground water table. PP shall submit Report on changes in Ground water level and quality shall be submitted on sixmonthly basis to Regional Office of the Ministry, MoEF&CC, CGWA and State Groundwater Department / State Pollution Control Board.
- 19) The Project Proponent shall undertake regular monitoring of natural water course/ water resources/ springs and perennial nallahs existing/ flowing in and around the mine lease and maintain its records. The Project Proponent shall undertake regular monitoring of water quality upstream and downstream of water bodies passing within and nearby/ adjacent to the mine lease and maintain its records. Sufficient number of gullies shall be provided at appropriate places within the lease for management of water. PP shall carryout regular monitoring w.r.t. pH and included the same in monitoring plan. The parameters to be monitored shall include their water quality visà-vis suitability for usage as per CPCB criteria and flow rate. It shall be ensured that no obstruction and/ or alteration be made to water bodies during mining operations

without justification and prior approval of MoEFCC. The monitoring of water courses/ bodies existing in lease area shall be carried out four times in a year viz. pre- monsoon (April-May), monsoon (August), post-monsoon (November) and winter (January) and the record of monitored data may be sent regularly to Ministry of Environment, Forest and Climate Change and its Regional Office, Central Ground Water Authority and Regional Director, Central Ground Water Board, State Pollution Control Board and Central Pollution Control Board. Clearly showing the trend analysis on six-monthly basis.

Noise and vibration monitoring and prevention

- 20) The peak particle velocity at 500m distance or within the nearest habitation, whichever is closer shall be monitored periodically as per applicable DGMS guidelines.
- 21) The illumination and sound at night at project sites disturb the villages in respect of both human and animal population. Consequent sleeping disorders and stress may affect the health in the villages located close to mining operations. Habitations have a right for darkness and minimal noise levels at night. PPs must ensure that the biological clock of the villages is not disturbed; by orienting the floodlights/ masks away from the villagers and keeping the noise levels well within the prescribed limits for day /night hours.
- 22) The Project Proponent shall take measures for control of noise levels below 85 dBA in the work environment. The workers engaged in operations of HEMM, etc. should be provided with ear plugs /muffs. All personnel including laborers working in dusty areas shall be provided with protective respiratory devices along with adequate training, awareness and information on safety and health aspects. The PP shall be held responsible in case it has been found that workers/ personals/ laborers are working without personal protective equipment.

Mining plan

- 23) The Project Proponent shall adhere to the working parameters of mining plan which was submitted at the time of EC appraisal wherein year-wise plan was mentioned for total excavation subject to changes recommended in the specific conditions herein below. No change in basic mining proposal like mining technology, total excavation, mineral & waste production, lease area and scope of working (viz. method of mining, overburden & dump management, O.B & dump mining, mineral transportation mode, ultimate depth of mining etc.) shall be carried out without prior approval of the Ministry of Environment, Forest and Climate Change, which entail adverse environmental impacts, even if it is a part of approved mining plan modified after grant of EC or granted by State Govt. in the form to Short Term Permit (STP), Query license or any other name.
- 24) The Project Proponent shall get the Final Mine Closure Plan along with Financial Assurance approved from Indian Bureau of Mines/Department of Mining & Geology as required under the Provision of the MMDR Act, 1957 and Rules/ Guidelines made there under. A copy of approved final mine closure plan shall be submitted within 2 months of the approval of the same from the competent authority to the concerned Regional Office of the Ministry of Environment, Forest and Climate Change for record and verification.
- 25) The land-use of the mine lease area at various stages of mining scheme as well as at the end-of-life shall be governed as per the approved Mining Plan. The excavation visà-vis backfilling in the mine lease area and corresponding afforestation to be raised in the reclaimed area shall be governed as per approved mining plan. PP shall ensure the

monitoring and management of rehabilitated areas until the vegetation becomes selfsustaining. The compliance status shall be submitted half-yearly to the MoEFCC and its concerned Regional Office.

Transportation

- 26) No Transportation of the minerals shall be allowed in case of roads passing through villages/ habitations. (In such cases, PP shall construct a 'bypass' road for the purpose of transportation of the minerals leaving an adequate gap (say at least 200 meters) so that the adverse impact of sound and dust along with chances of accidents could be mitigated.)All costs resulting from widening and strengthening of existing public road network shall be borne by the PP in consultation with nodal State Govt. Department. Transportation of minerals through road movement in case of existing village/ rural roads shall be allowed in consultation with nodal State Govt. Department only after required strengthening such that the carrying capacity of roads is increased to handle the traffic load. The pollution due to transportation load on the environment will be effectively controlled and water sprinkling will also be done regularly. Vehicular emissions shall be kept under control and regularly monitored. Project should obtain Pollution Under Control (PUC) certificate for all the vehicles from authorized pollution testing centers.
- 27) The Main haulage road within the mine lease should be provided with a permanent water sprinkling arrangement for dust suppression. Other roads within the mine lease should be wetted regularly with tanker-mounted water sprinkling system. The other areas of dust generation like crushing zone, material transfer points, material yards etc. should invariably be provided with dust suppression arrangements. The air pollution control equipment's like bag filters, vacuum suction hoods, dry fogging system etc. shall be installed at Crushers, belt-conveyors and other areas prone to air pollution. The belt conveyor should be fully covered to avoid generation of dust while transportation. PP shall take necessary measures to avoid generation of fugitive dust emissions.

Green Belt

- 28) The river bed mining projects involve extraction of sand, gravel and Bajri from dry river/ Nallah Bed and plantation in the 7.5 m buffer of the mine lease will mean plantation in between the river/nallah bed which will obstruct the natural flow of the river/nallah and might also lead to change is natural habitat of aquatic fauna. In lieu of the plantation on river bed the proponents will carry out plantation in the adjacent villages after due consultations with the PR/locals and the concerned DFO. Besides, the PP shall adhere to the conditions for green belt development as per ESR/CER/EMP strictly.
- 29) The Project Proponent shall carryout plantation/ afforestation in backfilled and reclaimed area of mining lease, around water body, along the roadsides, in community areas etc. by planting the native species in consultation with the State Forest Department/ Agriculture Department/ Rural development department/ Tribal Welfare Department/ Gram Panchayat such that only those species be selected which are of use to the local people. The CPCB guidelines in this respect shall also be adhered. The density of the trees should be around 2500 saplings per Hectare. Adequate budgetary provision shall be made for protection and care of trees.

- 30) The Project Proponent shall make necessary alternative arrangements for livestock feed by developing grazing land with a view to compensate those areas which are coming within the mine lease. The development of such grazing land shall be done in consultation with the State Government. In this regard, Project Proponent should essentially implement the directions of the Hon'ble Supreme Court with regard to acquisition of grazing land. The sparse trees on such grazing ground, which provide mid-day shelter from the scorching sun, should be scrupulously guarded/ protected against felling and plantation of such trees should be promoted.
- 31) The Project Proponent shall undertake all precautionary measures for conservation and protection of endangered flora and fauna and Schedule-I species during mining operation. A Wildlife Conservation Plan shall be prepared for the same clearly delineating action to be taken for conservation of flora and fauna. The Plan shall be approved by Chief Wild Life Warden of the State Govt.
- 32) And implemented in consultation with the State Forest and Wildlife Department. A copy of Wildlife Conservation Plan and its implementation status (annual) shall be submitted to the Regional Office of the Ministry.

Public hearing and human health issues

- 33) The Project Proponent shall appoint an Occupational Health Specialist for Regular as well as Periodical medical examination of the workers engaged in the mining activities, as per the DGMS guidelines. The records shall be maintain properly. PP shall also carryout Occupational health check-ups in respect of workers which are having ailments like BP, diabetes, habitual smoking, etc. The check-ups shall be undertaken once in six months and necessary remedial/ preventive measures be taken. A status report on the same may be sent to MoEFCC Regional Office and DGMS on half-yearly basis.
- 34) The Project Proponent must demonstrate commitment to work towards 'Zero Harm' from their mining activities and carry out Health Risk Assessment (HRA) for identification workplace hazards and assess their potential risks to health and determine appropriate control measures to protect the health and wellbeing of workers and nearby community. The proponent shall maintain accurate and systematic records of the HRA. The HRA for neighbourhood has to focus on Public Health Problems like Malaria, Tuberculosis, HIV, Anaemia, Diarrhoea in children under five, respiratory infections due to bio mass cooking. The proponent shall also create awareness and educate the nearby community and workers for Sanitation, Personal Hygiene, Hand washing, not to defecate in open, Women Health and Hygiene (Providing Sanitary Napkins), hazard of tobacco and alcohol use. The Proponent shall carryout base line HRA for all the category of workers and thereafter every five years.
- 35) The PP shall periodically monitor health of all the workers involved at mining site as per the regulations of Mines act.
- 36) Periodical medical examination of the workers engaged in the project shall be carried out and records maintained. For this purpose, schedule of health examination of workers should be drawn and followed accordingly as per the regulations of Mines act. A First Aid Room shall be provided in the project both during construction and operations of the project.
- 37) The Project Proponent shall ensure that Personnel working in dusty areas should wear protective respiratory devices and they should also be provided with adequate training and information on safety and health aspects.
- 38) Project Proponent shall make provision for the housing for workers/labors or shall construct labour camps within/outside (company owned land) with necessary basic

infrastructure/ facilities like fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical health care, crèche for kids etc. The housing may be provided in the form of temporary structures which can be removed after the completion of the project related infrastructure. The domestic waste water should be treated with STP in order to avoid contamination of underground water.

39) The activities proposed in Action plan prepared for addressing the issues raised during the Public Hearing, if applicable, shall be completed as per the budgetary provisions mentioned in the Action Plan and within the stipulated time frame. The Status Report on implementation of Action Plan shall be submitted to the concerned Regional Office of the Ministry along with District Administration.

Corporate Environment Responsibility (CER)

- 40) The activities and budget earmarked for Corporate Environmental Responsibility (CER) as per Ministry's 0.M No 22-65/2017-IA. III dated 30/09/2020 or as proposed by EAC should be kept in a separate bank account. The activities proposed for CER shall be implemented in a time bound manner and annual report of implementation of the same along with documentary proof viz. photographs, purchase documents, latitude & longitude of infrastructure developed & road constructed needs to be submitted to Regional Office MoEF&CC annually along with audited statement.
- 41) Project Proponent shall keep the funds earmarked for environmental protection measures in a separate account and refrain from diverting the same for other purposes. The Year wise expenditure of such funds should be reported to the MoEFCC and its concerned Regional Office.

Miscellaneous

- 42) The Project Proponent shall prepare digital map (land use & land cover) of the entire lease area and KML file for recording the base line data and closure time data (after three years) and submit a report to concerned Regional Office of the MoEFCC.
- 43) The Project Authorities should inform to the Regional Office regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- 44) The Project Proponent shall submit six monthly compliance reports on the status of the implementation of the stipulated environmental safeguards to the MOEFCC & its concerned Regional Office, Central Pollution Control Board and State Pollution Control Board.
- 45) A separate 'Environmental Management Cell' with suitable qualified manpower should be set-up under the control of a Senior Executive. The Senior Executive shall directly report to Head of the Organization. Adequate number of qualified Environmental Scientists and Mining Engineers shall be appointed and submit a report to RO, MoEFCC.
- 46) The concerned Regional Office of the MoEFCC shall randomly monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the MoEFCC officer(s) by furnishing the requisite data / information / monitoring reports.

68	The project proponent shall undertake an environmental audit at least once a year by a reputed third-party entity and report of such audit shall be placed in public domain.
69	To ensure that irrigation inlets are not left high and dry due to mining and resultant degradation of bed, the Project Proponent also must construct well-designed cut-off walls, stretching bank to bank, having depth 1.5 times the maximum scour depth below the bed level, both upstream and downstream, maintaining prescribed distance from irrigation inlet/s as per guidelines.
70	The District Mineral Officer shall monitor the replenishment of the mined-out areas, traffic management, levels of production, river bank erosion, exit point of the site and instruct the Project proponent for initiating measures for mitigating environmental concerns.
71	The PP shall not sub-let the mining block to any third party without written approval from the JKEIAA
72	After ceasing the mining operations, the project proponent shall undertake re-grassing of the mining lease area and any other area which may have been disturbed due to mining activities and restore the area to a condition fit for growth of flora, fauna and fodder as per rules in vogue.
73	The Project Proponent shall strictly adhere to the Sand Mining Guidelines of 2016 and Enforcement and Monitoring Guidelines of 2020 issued by the Ministry of Environment, Forest & Climate Change, GoI
74	An appeal against the EC shall lie with the Hon'ble NGT, if preferred within 30 days as prescribed under Section 16 of the NGT Act, 2010.
75	In the event any conflict in interpretation of Standard /General Conditions vis-a vis Specific Conditions, the Specific Conditions shall prevail.
