The 27th Meeting of the SEIAA, Assam was held at the SEIAA office on 08/02/2022 at 4.00 p.m.

Actions on the recommendations of 32th Meeting of SEAC held on 22nd February, 2022.

1. E.C. for drilling of Exploratory Wells (38 nos) in the non-forest areas of Cachar District Assam on PML Block and Pre-NELP Block AA-ONJ/2, Assam proposed by ONGC, Jorhat. SEIAA.2041/2022, (SIA/AS/IND2/159905/2020)

SEAC Resolution 32/2:

The project proposal requesting EC for drilling of Exploratory Wells (38 nos) in the non forest areas of Cachar District Assam on PML Block and Pre- NELP Block AA-ONJ/2 proposed by the ONGC Jorhat is placed before the SEAC for appraisal and discussion. Scrutinized the documents submitted by the proponent in support of the proposal. Preliminary discussion is held. The proponent was invited to give detail presentation on the different activities and safety measures proposed to safeguard the surrounding environment. Detailed presentation is given by the proponent and participated in the subsequent discussion. After a fruitful discussion the SEAC recommended for issuance of EC against drilling of 38 nos. exploratory of wells as proposed in the proposal. All the 38 nos (Well location NL EC-1 to NL EC-38) well locations fall in the non forest areas under Cachar District, Assam. It is also noted that the following documents and corrections are required for office record.

2. **Proposal of EC for mining of ordinary earth from “Pacharia Ordinary Earth MPA (Patta land)” under North Kamrup Division, Rangia proposed by Sri Basanta Kr. Agarwal. SEIAA.1993/2022, (SIA/AS/MIN/ 246230/2021).**

SEAC Resolution 32/3:

The project proposal asking EC for mining of ordinary earth from “**Pacharia Ordinary Earth MPA (patta land)**” under North Kamrup Division, Rangia proposed by **Sri Basanta Kr. Agarwal** is placed before the SEAC for appraisal and discussion. Documents are scrutinized including the reply of EDS submitted by the proponent. Approved mining plan, recommendation of the DFO, N K Division are discussed. Detailed discussion is held and the committee recommended the proposal approving to *extract 8000 cu.m ordinary earth from the proposed location within the period of two years subject to the condition that the nearby public road should not get disturbed because of mining activities.* The proponent is allowed to *extract 4000 cu.m. ordinary earth from the proposed location per year* strictly following all the terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, North Kamrup Division is requested to ensure due surveillance on the mining operation to guard against occurrences of irregularities during the mining period. He is also requested to mark the proposed site on the ground fixing boundary pillars prior to actual mining and mining is allowed strictly within the proposed site.

He is also requested to mark the proposed site on the ground fixing boundary pillars prior to actual mining and mining is allowed strictly within the proposed site. The DFO will ensure the compliance of the terms and condition approved in the mine closure plan is followed by the proponent.

4. **Proposal asking EC for mining of ordinary earth from “Dirgheswari Ordinary Earth Mining Permit Area” under North Kamrup Forest Division, Rangia by Sri Vinod Kr. Sharma. SEIAA1971/2021, (SIA/AS/MIN/ 247228/2021)**

SEAC Resolution 32/5:

The project proposal asking EC for mining of ordinary earth from “**Dirgheswari Ordinary Earth Mining Permit Area**” under North Kamrup Forest Division, Rangia proposed by **Sri Vinod Kr. Sharma** is placed before the SEAC for appraisal and discussion. Necessary documents are scrutinized and appraised. The approved mining plan and recommendation of the DFO, N K Division is discussed. The committee after due discussion recommended the proposal approving to extract *15000 cu.m ordinary earth from the proposed site within a period of two years*. 6. **Proposal of EC for mining of ordinary earth from “Ordinary Earth MPA on Patta land at Falimari village” under Aie Valley Division proposed by Sri Munnaf Ali. SEIAA.1920/2021, (SIA/AS/MIN/ 239403/2021).**

SEAC Resolution 32/9:

The project proposal asking EC for mining of ordinary earth from “**Ordinary Earth MPA on Patta land at Falimari village**” under Aie Valley Division proposed by **Sri Munnaf Ali** is placed before the SEAC for appraisal, review and discussion. Document furnished by the proponent including the reply of EDS has been scrutinized and deliberated. Approved mining plan as well as recommendation of the DFO concerned is also discussed. The Divisional Forest Officer, Jorhat Division is requested to ensure due surveillance on the mining operation to avoid occurrence of irregularities. Further, the DFO will also ensure that the mining is done not beyond the limit of the approved location and he will also arrange to mark the proposed site on the ground fixing boundary pillars before actual operation. The mine out material shall exclusively utilize against developmental works under North West Jorhat Development Block, Dhekorgora.

Detailed land records and approved mining plan with the report of the DGM are discussed. Recommendation of the DFO, Karimganj Division is also

discussed. The committee after detailed discussion recommended the proposal approving to *extract 106816 cu.m Ordinary earth from the proposed location within a period of 3 (three) years.* The committee is also approved to *extract 35605 cu.m ordinary earth form the said hilly location per year strictly following all the terms and condition laid down in the approved mining plan.*
