The proposal was placed in the 174th of agenda no. 61 SEAC meeting conducted After detailed deliberation on the proposal, committee recommended for raise ADS for submission of Approved Mining Plan of the proposed Mining project along with Pre Feasibility Report & kml file duly marking the distances of nearest habitation/ Village and the nearest Reserve Forest & others (if any) along with the proposed mine lease area co-ordinates duly labelling the latitude & longitude details. The proponent submitted reply to ADS on 25.12.2021. Earlier TOR issued on 08.12.2020 and public hearing held on 16.08.2021. At the time of PH the objections raised are to provide health camps, employment to local people, construct check dam to increase ground water table. The proponent replied that they will provide health camps, employment to local people and check dams will be constructed across the 1st and 2nd order streams. The Chairman SEIAA received a complaint. Hence kept in abeyance. The RO Tirupathi, APPCB forwarded a note through mail. The issue was again placed in the SEIAA meeting held on 23.03.2022 and Referred to SEAC to examine complaint received on the mine , RO, APPCB note and the Public hearing minutes. The case is taken up in 182 SEAC meeting and examined the compliant, report of RO, APPCB and public hearing minutes.
