

The SEIAA examined the recommendations made by SEAC in favour of above mentioned project proposals and unanimously decided to grant Environmental Clearance with the conditions recommended by SEAC alongwith following additional conditions as decided by SEIAA in its 65th meeting held on 07.01.2019 in the light of Hon'ble NGT order dated : 13.09.2018 and MoEF& CC, OM dated 12.12.2018.

- c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.
- d. EIA and /or EMP be prepared for the entire cluster in terms of recommendations 5 (supra) of the guidelines for the purpose of recommendations 6, 7 and 8 thereof.
- e. Revise the procedure to also incorporate procedure with respect to annual rate of replenishment and time frame for replenishment after mining closure in an area.
- f. The MoEF& CC to prepare guidelines for calculation of the cost of restitution of damage caused to mined- out areas along with the Net present value of Ecological services forgone because of illegal or unscientific mining.

At the same time it has also decided that to incorporate additional conditions to the above mentioned project proposals as suggested by Chairman, as the following:-.

“In all Stone Mining projects, depending upon the air pollution estimates based upon fuel use in operations and activities of the respective projects; required monitoring station based air quality monitoring shall be done in the influence area of the project with needed mitigation conditions to ensure sustainable Stone mining as per guidelines, circulars and norms of MOEF&CC / Hon’ble NGT or any other directives of regulatory / statutory bodies and competent Courts.

PP to take preventive steps to avoid flash flood conditions arising from mining operations and probable run off in rainy season conditions”.





Till such study in detail is undertaken by appropriate competent body or on behalf of state / district / department, PP needs to put up area demarking pillars at the coordinates spread over the mining stretch of leased area using level markings over pillars and record periodically the level of sand; supported by suitable means for recording sand level at the pillars and shall create data so created for recording and communication purposes".

- xxiv. Proposed Bricks Soil Mining for M/S Amma Bricks (Prop : Sri Ajay Khan) at Vill - Ulatu, Thana- Pithoria, Dist- Ranchi. (0.517 Ha) (Proposal No. : SIA/JH/MIN/43940/2019)

- xxv. Proposed Bricks Soil Mining for M/S Puja Bricks (Prop : Shri Anil Kumar Keshri) at Vill - Pithoriya, Thana- Pithoriya, Dist- Ranchi. (0.951 Ha) (Proposal No. : SIA/JH/MIN/44645/2019)
- xxvi. Tharghat Bricks Clay Mining Project of M/S Prakash Bricks (Prop : Sri Ramsuchit Mehta) at Vill- Tharghat, P.S- Hariharganj, Dist-Palamu. (1.008 Ha) (Proposed No : SIA/JH/MIN/44979/2019)
- xxvii. Kurse Bricks Mine of M/S Kurse Brick (Prop : Sri Hatim Ansari) at Vill-Kurse, Tehsil-Lohardaga, Dist- Lohardaga. (1.044 Ha) (Proposed No : SIA/JH/MIN/45145/2019)
- xxviii. M/s Sadhu Bricks (Serka Bricks Earth Mine) at Vill – Serka, Tehsil – Bishunpur, Dist – Gumla, (0.64 Ha)

The SEIAA examined the recommendations made by SEAC in favour of above mentioned project proposal and unanimously decided to grant Environmental Clearance with the conditions recommended by SEAC alongwith following additional conditions as decided by SEIAA in its 65th meeting held on 07.01.2019 in the light of Hon'ble NGT order dated : 13.09.2018 and MoEF & CC, OM dated 12.12.2018.

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.
- b. Form-1M be made more comprehensive for areas of 0 to 5 Ha by dispensing with the requirement for public consultation to be evaluated by SEAC for recommendation of grant of EC by SEIAA instead of DEIAA/DEAC.
- c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.
- d. EIA and /or EMP be prepared for the entire cluster in terms of recommendations 5 (supra) of the guidelines for the purpose of recommendations 6, 7 and 8 thereof.
- e. Revise the procedure to also incorporate procedure with respect to annual rate of replenishment and time frame for replenishment after mining closure in an area.
- f. The MoEF & CC to prepare guidelines for calculation of the cost of restitution of damage caused to mined- out areas along with the Net present value of Ecological services forgone because of illegal or unscientific mining.

At the same time it has also decided that to incorporate additional conditions to the above mentioned project proposals as suggested by Chairman, SEAC as the following:-

- a. PP shall provide better health facilities to the work force with maximum health coverage.
- b. PP shall provide guard rails/ barricade with warning signals.
- c. PP shall provide minimum two entries/ exits & install emergency escape from excavated areas.

- d. Top soil up to 30 cm shall be preserved separately & used further in areas requiring improvement of agriculture productivity.
- e. This EC is recommended subject to fulfilment of condition that PP shall install ID/natural draft Zig-Zag Kiln within the time frame allowed by state as per NGT order and gety CTE from JSPCB.
- f. This is subject to all due diligence as per regulatory bodies and Court directives.
- g. PP shall seek advise/instruction by informing concern departments as to the location of buried electrical lines/gas pipe lines, so that no event of electrocution/pipe line damage takes place to avoid injury and other health hazards.

9. SEIAA considered the recommendations made by SEAC in its 82nd meeting held on 04th, 05th, 06th and 07th November, 2019.

- i. Konbir Bricks Earth Clay Mining of M/s Shree Brindavan Construction at Vill – Konbir, P.O. & P.S. – Basia, Dist – Gumla, (8.00 Ac).

The Authority considered the recommendation made by SEAC in its 80th meeting alongwith 82nd meeting (SEAC) through which SEAC has recommended to issue corrigendum in EC stating production figure 15 lakhs brick per annum.

Hence, after deliberations, it was unanimously decided that to issue corrigendum of EC of above mentioned project stating 15 lakhs bricks per annum and other conditions shall remain the same as mentioned in EC letter no. EC/SEIAA/2018-19/2179/2019/594 dated 26.10.19.

10. SEIAA considered the recommendations made by SEAC in its 82nd meeting held on 04th, 05th, 06th and 07th November, 2019.

- i. **Construction (Inculding structural design) of 665 dwelling units in 19 number of G + 6 blocks with 35 dwelling units each) at Mohanpur, Deoghar under Pradhan Mantri Awas Yojna (urban) (package-E).**

The Authority examined the recommendation of SEAC made in 81st meeting and 82nd meeting along with compliance submitted by PP on 7.11.2019 to SEAC and after full deliberations it was unanimously decided to grant EC subject to appropriate fire safety measures as suggested by the Fire department.

- ii. **Construction of 500 bedded Government Hospital of Jharkhand State Building Construction Corporation Ltd. at Vill. : Kolghati 1, Anchal :Sadar, Dist. : Hazaribagh.**

The Authority examined the recommendation of SEAC and observed that compliance of various points raised by Chairman, SEAC and Members SEAC has not been addressed which is necessary to take decision.

Hence, after full deliberations it was unanimously decided that project proponent shall submit the wanting documents/information to SEAC. SEAC is requested to forward clear recommendation for grant of EC.





- iii. **Housing Complex, Construction (including structural design) of 2020 Dwelling units in 101 number of G+3 blocks at Kasidih, Adityapur under Pradhan Mantri Awas Yojana (urban) [Package B] of Adityapur Municipality Corporation at Plot No. : 324, 326, 334,352, 358 & 354, Khata No. : 89, Village : Kashidih, Tehsil : Gamharia, District : Saraikella Kharsawan.**

The Authority examined the recommendation of SEAC and observed that that compliance of various points raised by SEAC has not been addressed which is necessary to take decision.

Hence, after full deliberations it was unanimously decided that project proponent shall submit the wanting documents/information to SEAC. SEAC is requested to forward clear recommendation for grant of EC.

- iv. **Expansion of Residential project of M/s Apna Awas Engineering Pvt. Ltd. of Sri Jitendra Kumar Singh at Vill : Konka, Tehsil : Lower Bazar, Dist.: Ranchi.**

The Authority examined the recommendations of SEAC wherein SEAC has raised certain observation. The compliance of observations raised is made available to the SEAC on 05.11.2019 by the project proponent.

Hence, after full deliberations it was unanimously decided to grant Environmental Clearance with various conditions recommended by SEAC for building and construction project.

- v. **Shrachi Greens Project, Tata Nagar, Jharkhand of Shrachi Reality Pvt. Ltd. Vill – Tamulia Dist.- Saraikela-Kharsawan, Jharkhand.**

The Authority examined the recommendations of SEAC made in 81st and 82nd meeting wherein SEAC has made detail deliberations on above mentioned project proposal and raised certain observation which has made available to the SEAC on 01.11.2019.

Hence, after full deliberations it was unanimously decided to grant Environmental Clearance with various conditions recommended by SEAC for building and construction project.

- vi. **Vibgyor Estates Pvt. Ltd. & High Street Enterprises Pvt. Ltd. of Vibgyor Estates Pvt. Ltd. & High Street Enterprises Pvt. Ltd. at Plot Khata No. - 360 & Plot No. – 1133, Vill. : Misirgonda, Tehsil : Hehal, Dist. : Ranchi, State : Jharkhand.**

The SEAC has discussed the above project proposal in detail and after full deliberations SEAC has raised certain observation. The compliance of observations raised by SEAC was made available on 08.11.2019 by the project proponent.

Hence, after full deliberations it was unanimously decided to grant Environmental Clearance with various conditions recommended by SEAC for building and construction project.

vii. **Withdrawal of Environmental Clearance of the projects located within ESZ-regarding.**


In the light of decision taken in 82nd meeting of SEIAA held on 22.10.19, the Member Secretary, SEIAA has issued show cause notice to the 10 projects which comes under the boundary of ESZ of Palkot Wildlife Sanctuary.

Accordingly after lapse of stipulated time the Environmental Clearance of 10 projects was withdrawn.

Hence, after full deliberations it was unanimously decided to approved the withdrawal of Environmental Clearance of these projects.

The meeting concluded with vote of thanks to the Chairman.
