


1. The project proponent had submitted the proposal online for issuance of TOR.

1. Violation i.e carrying out of work before EC was noticed.
2. Matter referred to Pollution Control Committee
3. PCC filed case in Court due to violation.
4. Court order convicted offenders for acts punishable under section 16 of the EPA, 1986.
5. Both the accused were sentenced to pay fine @ Rs. 1,00,000/- each vide section 15 of the Environment Protection Act, 1986 and in default shall suffer simple imprisonment for one month.
6. Project Proponents have paid the fine. However they did not approach UTEIAA subsequently.
7. Files and records were not returned by PCC to UTEIAA till December, 2021.
