

Now, PP has submitted a reply to the queries raised by SEIAA in its 5.100th meeting and provided further explanation during the course of the meeting. In view of the replies submitted, the Authority decided to accord EC for expansion to this proposal.
- 2. Serial No. 2: The proposal was deferred in the 5.100 meeting of SEIAA held on 26.10.23 for personal hearing to clarify on following discrepancies:
 - a. Pichola lake is adjacent to the project site. WRD certificate is required which clearly states that the project will not infringe the directions of Hon'ble HC in the case of Abdul Rehman vs. State of Rajasthan is required.
 - b. GW NOC is only 30 KLD against the fresh water requirement of 300 KLD. Clarification on how the balanced fresh water requirement of 270 KLD will be met.
 - c. There are two different figures given for the parking in the presentation as well as the Conceptual plan. Final figures for the parking which should be in compliance with the new norms as per SEIAA order dated 15.09.2023.

In this meeting, PP was heard and based on the detailed discussion, the PP was directed to revise the parking plans to incorporate the 200 ECUs parking provision, as stated in the proposal. Moreover, PP had not submitted the desired certificate from WRD as sought by SEIAA. Accordingly, the case was deferred and PP was directed to submit the revised parking plan and WRD Certificate, within 45 days.

3. Serial No. 3: The proposal was deferred in the 5.100th meeting of the Authority to submit revised PFR, latest valid Cluster Certificate and correct DSR. Now, PP has submitted the required documents. Hence, the Authority decided to grant EC to this proposal.

- 4. Serial No. 4: The proposal as deferred in the 5.101st meeting of the Authority for submission of revised Form-1, Cluster Certificate, Aravali Certificate and affidavit of PP mentioning the correct khasra number. Now, PP has submitted the required documents. Hence, the Authority has decided to grant EC to this proposal.
- 5. Serial No. 5: Proposal was deferred in the 5.101st meeting of the Authority for submission of CA certificate mentioning turnover for violation period and latest Certified Compliance Report along with ATR for non-compliance. PP in response to the same, has submitted the required documents.

Hence, the Authority decided to approve EIA/ EMP, grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 4,00,695 /- (Non Refundable) by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 11,61,375 /- towards remediation for Remediation Plan and Natural & Community Resource Augmentation Plan to RSPCB before issue of EC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

6. Serial No. 6: Proposal was deferred in the 5.101st meeting of the Authority for submission of valid NABET certificate, Conservation Plan and latest Certified Compliance Report. PP in response to the same, has submitted the required documents.

Hence, the Authority decided to approve EIA/ EMP, grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 3,17, 681 /- (Non Refundable) by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 11, 47, 513 /- towards remediation for Remediation Plan and Natural & Community Resource Augmentation Plan to RSPCB before issue of EC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 7. Serial No. 7, 8, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 33, 36, 37, 38, 39, 41, 49, 50, 52, 53, 54, 55, 56, 57, 58, 59: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- Serial No. 9, 10: The Authority accepted the recommendations of SEAC and decided to grant amendment in EC to these proposals. However, EC may be issued after

- receiving the Annexure C stating the concurrence/observations of NEERI in the proposal, from SEAC, as mentioned in its abstract.
- 9. Serial No. 21: In this proposal, the PP has not submitted certificate regarding nearest forest distance from DCF Udaipur as well as DCF (Wildlife) Udaipur. Hence, the Authority has decided to defer this proposal for submission of DCF Udaipur and DCF (Wildlife) Udaipur certificate, within 45 days.
- 10. Serial No. 32, 34, 40: The Authority decided to close & delist these proposals on the recommendations of SEAC.
- 11. Serial No. 35: The Authority accepted the recommendations of SEAC and decided to grant amendment in ToR to this proposal.
- 12. Serial No. 42 to 48: These proposals are referred back to SEAC and ME concerned may be directed to submit original DEIAA file to SEAC for such re-appraisal. In regard to the observations of SEAC, regarding no separate provision for re-appraisal cases of DEIAA on the Parivesh Portal, SEAC may be informed that till such time MoEFCC has incorporated a separate provision of re-appraisal of DEIAA cases, all present cases of DEIAA for re-appraisal may be processed as for EC cases, as the case may be.
- 13. Serial No. 51: The Authority decided to refer back this proposal to SEAC with the observations that, SEAC has stated this proposal as a case of violation but has not pointed out the years of violation. In addition, the Authority has also not found any violation based on the production figure certificates. Hence, the matter may be referred back to SEAC to submit its recommendations in regard to violation years. In addition, SEAC may seek ATR from PP in regard to condition no. 10, 15 of Certified Compliance Report which are not being complied.
- 14. Serial No. 60, 61: The Authority decided to grant Transfer EC to these proposals.
- 15. Serial No. 62 to 66: The Authority decided to grant Transfer EC to these proposals with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 16. Serial No. 67 to 72: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the

PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
