

Also to submit the details of the court matters/Orders of the Court pertaining to the project, if any

It may be ensured that the Members receive the aforesaid requisite documents in soft copy/e-mail pertaining to the projects after publishing the agenda positively. Failing which the Committee will not consider the project.

The Project Proponents shall ensure that the reports / documents uploaded in PARIVESH, circulated to the SEAC members and hard copy submitted to the Office are the same. In case of discrepancy, the project will not be considered.

- The Consultant shall include an undertaking in the EIA report that the prescribed TOR have been complied with and that the data submitted is factually correct and also an undertaking shall be submitted owning the contents (information and data) in the EIA/EMP report.
- The industrial projects shall present carbon foot print, net zero/de-carbonisation mechanism, carbon sequestration study etc., with respect to proposed project and their mitigation measures also needs to be included in the Presentation.
- The Infra projects shall present green building initiative.
