The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1 & 2: This proposal was deferred in 5.70 meeting of SEIAA for "Approved Mining Scheme was in the name of former lessee and revised Aravalli Certificate as the Khasra Number is wrongly mentioned". - 3. Serial No. 5: This proposal was closed & delisted in 5.71 meeting of SEIAA as recommended by SEAC. Now, PP has submitted WRD Certificate and Blasting Report for relisting of the project but the Authority noticed that these documents are same as submitted with the proposal earlier. Hence, the Authority decided to not to relist this proposal.

- 6. Serial No. 8: The representation of PP for relisting and grant of EC for the case was considered. However, the decision of the Authority taken in 5.70 meeting dated 10/04/2023 that the PP has to apply afresh is completely in consonance of OM Dated 22/08/2014 of MoEF&CC. Accordingly, the Authority decided to reject the representation given by PP/Consultant.
- 7. Serial No. 9: Proposal was close and delisted in 5.63 meeting of SEIAA for submission of valid LOI, which was not submitted in stipulated time. Similarly the main duty of the consultant is to prepare the proposal with relevant documents in accordance with the requirement under law and directions issued in this regard.

Accordingly, the Authority decided that a show cause notice be issued to PP to explain as to why the application should not be reject and a legal action be initiated for submission of false affidavit. - 13. Serial No. 23, 27, 28, 29, 30: The Authority accepted the recommendations of SEAC and decided to grant EC these proposals with additional conditions imposed by SEAC.
- 14. Serial No. 24: In this proposal, LOI, Cluster Certificate & CCR are expired. Hence, the Authority <u>decided to defer this proposal</u> for submission of additional information within 45 days.
- 15. Serial No. 25: The Authority observed that EIA/EMP for the cluster of 53.4839 ha in which the PP's area is also included, has already been approved by the Authority while according EC to M/s. Nanak Marbles Private Limited (Proposal No.: 68046). PP has already enclosed a copy of that EC issued, in this situation there is no need to approve another EIA/EMP for the same cluster area.

Accordingly, the Authority decided to grant EC to this proposal on the condition that the PP should adhere to the conditions laid down earlier in the already approved EIA/EMP and the relevant parts of the EMP submitted by the PP in respect of issues raised during Public Hearing of this proposal.

- 16. Serial No. 26: In this proposal, approved DSR is not submitted and also the cluster certificate has expired hence, the Authority <u>decided to defer this</u> <u>proposal</u> for additional information to be submitted within 45 days.
- 17. Serial No. 31: In this proposal, according to submitted documents Bandi river is adjacent to the applied area. Also, the WRD certificate does not speak clearly

and

regarding Hon'ble HC Rajasthan direction in case of Abdul Rehman V/s. Government of Rajasthan case no. 11153/2011. The Authority decided to seek a revised certificate from WRD regarding the same, in addition the PP is required to submit the parking details. Hence, the Authority <u>decided to defer this proposal</u> for submission of additional information within 45 days.

- 18. Serial No. 32: In this proposal, EC has been issued by MoEF&CC in 2006 and as The Authority has not been considering violation in cases where prior EC was issued by MoEF&CC. hence the Authority decided to grant ToR without violation to this proposal.
- 19. Serial No. 33: SEAC has recommended this proposal for grant of EC along with bank guarantee of Rs. 6.25 Lakhs for remediation plan, natural resource augmentation plan & community augmentation plan and also a penalty of Rs. 152030/-.

The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the additional conditions imposed by SEAC and on condition that the project proponents must raise a dense plantation in a 7.5 m belt all around the lease area to mitigate pollution effects subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 152030/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 6.25 Lakhs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 20. Serial No. 34, 35 & 36: The Authority <u>decided to grant Transfer EC</u> to these proposals.
- 21. Additional Agenda Serial No. 1: The Authority discussed the proposal in detail and accepted the recommendations of SEAC and decided to grant EC to this proposal.
