Minutes of the 161st Meeting of the State Expert Appraisal Committee (SEAC) held on 26th June 2020 (Friday) for Appraisal of Building and Construction Projects, Townships, and Area Development projects & Mining projects conducted through video conferences.

The SEAC noted the following:

- 1. The Proponent, Tmt.G.Vijayalakshmi, has applied for Terms of Reference for the proposed Rough stone and Gravel quarry lease over an extent of 1.83.90 Ha in S.F.No. 305/1 (P), 307/1 (P) & 307/2 (P) Poomalur Village, Palladam Taluk, Tiruppur District, Tamil Nadu.
- 2. The project/activity is covered under Category "B" of Item 1(a) "Mining of Minerals Projects" of the Schedule to the EIA Notification, 2006.

Based on the presentation made by the proponent and the documents furnished, the committee decided to recommend the proposal for the grant of Terms of Reference (ToR) to SEIAA with Public Hearing, subject to the following specific conditions in addition to the points mentioned in the standard terms of reference for conducting environment impact assessment study for non-coal mining projects and information to be included in EIA/EMP report issued by the MoEF&CC.

- 1. The proponent shall furnish the contour map of the water table detailing the number of wells located around the site and impacts on the wells due to mining activity.
- 2. The proponent shall conduct the hydro-geological study to evaluate the impact of proposed mining activity on the groundwater table, agriculture activity, and water bodies such as tanks, canals, ponds etc. located nearby by the proposed mining area.
- 3. The proponent shall furnish the details on number of groundwater pumping wells, open wells within the radius of 1 km along with the water levels in both monsoon and non-monsoon seasons.
- 4. The Proponent shall conduct the Cumulative impact study on the Agricultural area due to Mining, Crushers and other activities around the site area.
- 5. The details of surrounding well and the cumulative impact on the ground water shall be part of EIA study.
- 6. The Socio economic studies should be carried out within 10 km buffer zone from the mines.
- 7. A detailed report on the green belt development already undertaken is to be furnished. They should also submit the proposal for green belt activities for the proposed mine(s).
- 8. CER activities should be carried out taking into consideration the requirement of the local habitants available within the buffer zone as per Office Memorandum of MoEF & CC dated 01.05.2018.
- 9. A Detailed mining closure plan for the proposed project shall be submitted.
- 10. A detail report on the Occupational safety and health aspects of the workers and for the surrounding habitants during operation of mining for drilling and blasting shall be submitted.
- 11. The recommendation for the issue Terms of Reference is subject to the outcome of the Hon'ble NGT, Principal Bench, New Delhi in O.A No.186 of 2016 (M.A.No.350/2016) and O.A. No.200/2016 and O.A.No.580/2016 (M.A.No.1182/2016) and O.A.No.102/2017 and O.A.No.404/2016 (M.A.No.

758/2016, M.A.No.920/2016, M.A.No.1122/2016, M.A.No.12/2017 & M.A. No. 843/2017) and O.A.No.405/2016 and O.A.No.520 of 2016 (M.A.No. 981/2016, M.A.No.982/2016 & M.A.No.384/2017).

- 12. The lithology of the mining lease area shall be furnished along with the EIA Report.
- 13. A study shall be conducted on the number of trees (name of the species, age) present in the mining lease applied area and how, it will be managed during mining activity.
- 14. The SEAC noted that,
  - i). There was an existing quarry located in the proposed project site, hence the proponent shall furnish the following details from AD/DD, mines of concern District to ensure no violation file is appraised under normal cases.
    - a) What was the period of the operation and stoppage of the earlier mines with last work permit issued by the AD /DD mines?
    - b) Quantity of minerals mined out.
    - c) Detail of approved depth of mining.
    - d) Actual depth of the mining achieved earlier
    - e) Name of the person already mined in that leases area.
    - f) If EC and CTO already obtained and its compliance report from competent authority.
  - ii). Proposal for safety precautions measures to avoid of mining activity to nearby two crushers units are at a distance of 50m and 150m near to the proposed project site.
- 15. The proponent should erect fencing all around the boundary of the proposed area with gates as per the conditions and shall furnish the photographs/map showing the same along with the EIA report.

After Verification of documents in office record, SEAC noted that there is a difference in quantity of mineable resources and depth of mining mentioned in the Precise Area Communication Letter issues by District Collector, Tiruvallur dated on 09.12.2019 and

the Mining Plan approval letter issued by AD/DD Mines, Tiruvallur dated on 21.02.2020.
