1. ACS, Environment, Forest & Climate Change, GoUP letter dated 07.07.2022

This letter was discussed in SEIAA. MoEFCC, GoI, New Delhi vide para-5 of Circular F. No. IA 3-2/15/2022-IA-III (Computer No. 178038) dated 06.05.2022 has made following provisions regarding "Mechanism for handling ToR applications for issuing Standard Terms of Reference (ToRs) or referring to EAC / SEAC through Parivesh portal" —

"In this regard, it is hereby directed that the Member-Secretaries of the concerned EAC / SEAC shall scrutinize the applications as per the provisions mentioned above within seven days from the date of application for issuing online system generated Standard ToR and shall refer the application for grant of ToR to EAC / SEAC only as an exception depending upon the environmental sensitivity involved or as aforementioned guidelines mandate".

SEIAA opined as follows -

- A copy of MoEFCC, Gol, New Delhi above circular dated 06.05.2022 be send to MS, SEAC-1 & SEAC-2 with the direction that procedure laid down by MoEFCC should be followed for handling ToR applications.
- MS, SEIAA should appraise ACS, Environment, Forest & Climate Change, GoUP with reference to above mentioned GoUP letter dated 07.07.2022

Honourable NGT Principal Bench, New Delhi order dated 01.07.2022 passed in I.A. No. 152/2022 & I.A. No. 153/2022 in O.A. No. 319/2022

The applicant has filed the application for seeking setting aside/quashing of the impugned EC dated 31.03.2018 issued in respect of Sand Ghat / Mine located at Khand No. 11/15 and 11/16 at Village- Diya Upahar, Tehsil, Manjhanpur, District-Kaushambi, Uttar Pradesh for an area admeasuring 24.28 hectares and restraining transferring impugned EC on the grounds that the impugned EC is defective / invalid having been granted without EIA/EMP/Public

EC in question was issued vide letter no. 281/parya/SEAC/4045/2018 dated 31.03.2018 (MoEFCC Parivesh id – SIA/UP/MIN/72559/2018) and transferring impugned EC was issued vide letter no. 25/parya/SEAC/4045/2021 dated 22.04.2022.

SEIAA opined as follows -

SEIAA noted that the above project was taken in its 561st meeting File No. 1932/Proposal No. SIA/UP/MIS/ 247035/2021 in which after due deliberation SEIAA opined that since the project proponent UPSIDA proposes to add Beverages / Soft Drink industries under the premises of Trans-Ganga City, hence they shall carry out and submit rapid EIA-EMP to SEIAA. Rapid EIA-EMP should include ZLD (zero liquid discharge) concept, there should be interventions to have a zero water foot print of the proposed industry, international best practices adopted by the beverage / soft drink industry should be proposed, etc. Rapid EIA-EMP should be submitted to SEAC-1 for appraisal. PP should also submit approval from competent authority to include beverage / soft drink industry in the said integrated industrial township. The consultant/project proponent without withdrawing the above project applied for ToR. Hence SEIAA opined that a show cause notice shall be issued to the consultant for clarification.

SEIAA agreed with the recommendation of the SEAC to issue ToR to the above project adding the following condition:-

A land fill site shall be proposed in EIA.

ToR to be issued only when the PP / consultant withdraws the earlier proposal loaded on MoEFCC Parivesh portal as SIA/UP/MIS/247035/2021 and accepted by MS, SEIAA; and show cause notice is issued to consultant for submitting again the proposal without withdrawing the earlier proposal for the same project.

SEIAA opined that without prejudice to any other consequences, action to be initiated u/s 15 read with section-19 of EPA, 1986 against the PP and Project to be closed until EC is granted.
