The Authority after detailed discussion and deliberation decided the following:

1. **Serial No. 1:** The proposal was deferred in the 5.126th meeting of the Authority for submission an affidavit clearly stating whether the proposal falls under violation category or not. Now, PP has submitted the required document. Hence, the Authority accepted the recommendations of SEAC and decided to **grant EC** to this proposal.
2. **Serial No. 2:** The proposal was deferred in the 5.126th meeting of the Authority held on 11.06.2024 for submission of affidavits of PP and Consultant stating whether the proposal is in violation of EIA Notification, 2006 and amendments thereof or is of non-violation. Now, PP vide his letter dated 07.06.2024 has submitted the affidavits of the Consultant with an affidavit of PP for implementation of Cluster EMP. Hence, the Authority accepted the recommendations of SEAC and decided to **approve EIA/ EMP and grant EC** to this proposal with the **condition** that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
3. **Serial No. 3:** The proposal was deferred in the 5.126th meeting of the Authority held on 11.6.2024 for the following deficiencies:-
 - a) Khasra Numbers were wrongly mentioned in the revised Aravalli Certificate. Also, no date was mentioned to confirm when the Aravalli Certificate was issued.

b) Issues raised in the Public Hearing regarding movement of mining vehicles through village and school was not properly addressed in the Public Hearing Action Plan.

c) PP had not submitted Production Certificate for the year 2023-2024.

Now, PP has submitted a revised Aravalli Certificate dated 22.04.2024 with the mention of correct Khasra Numbers. Also, PP has made a commitment to allocate Rs. 5 Lacs for the development of education facilities and Rs. 25 Lacs for metallic road and its maintenance. Along with these documents, PP has submitted a Production Certificate for the Financial Year 2023-2024 to ascertain that the project is not of violation category. Hence, the Authority accepted the recommendations of SEAC and decided to **grant EC** to this proposal.

4. **Serial No. 4:** The proposal was deferred in the 5.126th meeting of the Authority held on 11.06.2024 for submission of authentic Production Certificate for the Financial Year 2023-2024. Now, PP has submitted the required document. Hence, the Authority accepted the recommendations of SEAC and decided to **grant EC** to this proposal.
5. **Serial No. 5, 6:** These proposals were deferred in the 5.126th meeting of the Authority held on 11.06.2024. However, in the 5.129th meeting of the Authority held on 28.06.2024, it was decided by the Authority to review its earlier decisions taken in the 5.126th meeting. Now, the Authority has decided to accept the recommendations of SEAC and **grant EC** issued to these proposals **with the direction** that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 3.11.2023 issued by MoEF&CC.
6. **Serial No. 7, 8, 9, 10:** These proposals were deferred in the 5.127th meeting of the Authority held on 14.06.2024. However, in the 5.129th meeting of the Authority held on 28.06.2024, it was decided by the Authority to review its earlier decisions taken in the 5.127th meeting. Now, the Authority has decided to **defer** these proposals and give **notice to the PPs to apply immediately for Transfer of EC, in absence of which their applications for re-appraisal of DEIAA ECs shall stand rejected** because of non-compliance of conditions as provided in O.M. dated 3.11.2023. In addition, the RSPCB shall initiate action against the Project Proponents for non-compliance of O.M. dated 3.11.2023 issued by MoEF&CC.
7. **Serial No. 11, 12, 13, 24, 25, 28:** The Authority accepted the recommendations of SEAC and decided to **grant EC** to these proposals.
8. **Serial No. 14, 33, 35:** The Authority accepted the recommendations of SEAC and decided to **Close & Delist** these proposals.

9. **Serial No. 15, 16, 17, 19, 20, 27:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **approve EIA/EMP and grant EC** to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
10. **Serial No. 18, 21, 22:** The Authority decided to **refer back** these proposals to SEAC. SEAC can not be arbitrary and whimsical to refuse to approve the EIA/ EMP and recommend for grant EC despite the project being in a cluster. It may appraise the proposal and the EIA/EMP and give its recommendation for grant of EC and approval of EIA/ EMP.
11. **Serial No. 23:** In this proposal, PP has not submitted the affidavit for implementation of Cluster EMP and receipt of the Conservation Plan submitted to the concerned DCF. Hence, the Authority decided to **defer** this proposal for submission of an affidavit regarding implementation of Cluster EMP and receipt of the Conservation Plan submitted to DCF, within 45 days.
12. **Serial No. 26:** In this proposal, Miscellaneous Conditions No. 1 and 3 of the Certified Compliance Report submitted are not complied with. PP has obtained NOC from CGWA for 15 KLD water demand whereas, the proposed increase in water demand is 43.5 KLD. In addition, the license of the Factory was valid till 31.3.2024. Hence, the Authority has decided to **defer** this proposal for submission of Action Taken Report for the non-complied conditions of Certified Compliance Report, Source of increased water demand, within 45 days.
13. **Serial No. 29:** The Authority has decided to **defer** this proposal in light of the following:-
- a) When it has been admitted that the lease area is a part of the watershed of the Kapil Sarovar, an important water body. Hence, PP may submit the comments along with the NOC of the Water Resources Department.
 - b) PP has stated that a fresh proposal was submitted for ToR on 10.07.2021 whereas, as per the Notification dated 06.04.2018 issued by the MoEF&CC, it has been mandated that all mining projects that were granted Environmental Clearances under the EIA Notification, 1994 and but have not obtained EC for expansion/ modernization/ amendment under EIA, Notification, 2006, were required to obtain EC under EIA Notification, 2006. Also, PPs were directed to apply within six months from the date of this notification, i.e. 06.04.2018.


Hence, PP may submit the NOC from the Water Resources Department and clarify why the case of PP should not be considered as a case of violation in respect of the Notification dated 06.04.2018 issued by the MoEF&CC.

14. **Serial No. 30, 31, 32, 34, 36, 37, 38, 39, 40:** These proposals pertain to the re-appraisal of ECs issued by the erstwhile DEIAAs. The Authority accepted the recommendation of SEAC and decided to **grant EC** to these proposals.
15. **Serial No. 41, 42, 43, 44, 45, 46, 47:** The Authority decided to **transfer EC to these proposals with a direction** that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
16. **Serial No. 48:** The Authority decided to grant **Transfer EC** to this proposal.
17. **Serial No. 49:** The Authority decided to **grant the Transfer of EC** to this proposal **with the direction that the RSPCB shall initiate action on the Project Proponent as per the existing rules.** It is directed to the concerned PP that since this EC was issued by DEIAA, the PP shall apply for re-appraisal within 30 days as per MoEF&CC OM dated 28.04.2023, Hon'ble NGT order dated 7.12.2022 and SOP dated 15.01.2024 issued by the MoEF& CC.
18. **Serial No. 50:** The Authority accepted the recommendations of SEAC and decided to **grant the Transfer of EC** to this proposal **with the direction that the RSPCB shall initiate action on the Project Proponent as per the existing rules.** It is directed to the concerned PP that since this EC was issued by DEIAA, the PP shall apply for re-appraisal within 30 days as per MoEF&CC OM dated 28.04.2023, Hon'ble NGT order dated 7.12.2022 and SOP dated 15.01.2024 issued by the MoEF& CC.
19. **Serial No. 51:** The Authority accepted the recommendation of SEAC and decided to **grant the transfer of EC** to these proposals with the direction that the RSPCB shall initiate action on the project proponent for non-compliance of O.M. dated 3.11.2023 issued by MoEF&CC.
