Serial No. 19: In this proposal, PP has proposed Bank Guarantee of Rs. 7,20,000/-and Penalty as Rs. 2,76,000/- but as per SEAC abstract, Bank Guarantee is Rs. 19,70,000/- and Penalty is Rs. 31,000/-. Hence, the Authority <u>decided to refer back</u> this proposal to SEAC for rechecking of figures as well as calculations.
- Serial No. 22: The Authority accepted the recommendation of SEAC and decided to grant ToR to this proposal under violation.
- 13. Serial No. 25: In this proposal the LOI has expired and as per KML, it is evident that mining activity has been carried out in the lease area and a crusher appears to be installed on the site. Hence, the Authority decided to refer back the proposal to SEAC. The PP may submit the valid LOI to SEAC along with comments of Mining Department as to who is responsible for the mining already done in the proposed lease area, as also clarification in respect to whether a stone crusher is installed on the site or not?.

- 14. Serial No. 26: In this proposal the CCR is more than one year old. hence, the Authority decided to <u>defer this proposal</u> for additional information.
- 15. Serial No. 27: The Authority <u>decided to defer</u> this proposal on account of following points:
 - DSR submitted (online) for Jaisalmer/Jaipur District and Proposal is of Bhilwara District.
 - A water body is visible in close proximity of lease area (approx 43 m-KML) but no WRD certificate is given.
 - Cluster expired on 27/06/2022.
- 16. Serial No. 29: In this proposal Cluster certificate has expired, hence, the Authority decided to defer this proposal for additional information.
- 17. Serial No. 30, 32, 33: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals with the direction to comply with the conditions as mentioned in WRD Certificate.
- 18. Serial No. 31: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the direction to comply with the conditions as mentioned in DCF, Pratapgarh Certificate.
- 19. Serial No. 34: In this proposal, DSR is submitted for Sandstone mineral whereas the proposal is of Soapstone. Hence, the Authority decided to <u>defer this proposal</u> for additional information.
- 20. Serial No. 35: The Authority <u>decided to refer back</u> this proposal on account of following points:
 - · In Lease Sanction Order Fire Clay is not mentioned
 - No Budgetary provision is given for issues raised during Public Hearing.
- 21. Serial No. 41: The Authority accepted the recommendations of SEAC and decided to grant Amendment in EC to this proposal and reiterate the General Condition NO. 10 w.r.t NBWL as mentioned in EC dated: 23/06/2017.
- 22. Serial No. 42: This proposal was referred back to SEAC in 5.54th SEIAA meeting stating that "the project proponent has applied for EC for proposed expansion and modernization of the project with cement production capacity 180 TPD (proposed capacity 130 TPD and existing capacity 50 TPD) by installing two vertical shaft kilns of capacity 90 Tons each for producing clinker 180 TPD and existing 50 Tons ball mill will be replace by two balls mills of capacity 90 Tons each for producing end product i.e. cement 180 TPD (OPC, PPC and PSC)"

The PP vide letter dated 18.01.2023 has given clarification accompanied with an affidavit, that the "clinker produced in excess to the required quantity as raw material for cement production will be sold in the market. And the capacity of cement and clinker production will not exceed from the permitted quantity i.e. 180 TPD each". Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.

- 23. Serial No. 43, 44, 45: The Authority was of the view that a closer examination of the Replenishment study is required. Hence, the Authority decided to defer these proposals and decided to call the PP/Consultant for presentation.
- 24. Serial No. 46: In this proposal, since the period of the original EC has expired, Transfer of EC cannot be done at this stage. PP may first seek extension in validity of EC and then re-apply for Transfer of EC. Hence, the Authority decided to reject this proposal.
- 25. Serial No. 47: The Authority decided to grant Transfer of EC to this proposal.
