Chairman SEIAA did not participate in the meeting. 702nd State Level Environment Impact Assessment Authority, UP (SEIAA) meeting was convened and conducted in reference to the letter no. 135/81-7-2023-103(parya)/2007 dated 7-2-2023 of Department of Environment Forest and Climate Change, GoUP

SEIAA gone through the letter of IRO, MoEFCC letter no. vii/ENV/SCL-UP/2202/221 dated 15-11-2022 regarding the above subject. SEIAA opined that the above letter shall be sent to UPPCB for necessary action.

SEIAA opined that the project proponent shall submit NOC from the previous lease holder before transfer of EC.

SEIAA noted that the above project was taken in its 726th SEAC meeting. SEIAA also gone through MOU no. 23/house/0000012441 of invest UP and undated letter of plusnineone Ware House Pvt. Ltd mentioning that they have signed MoU with Invest UP. In light of



discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC-1 and grant EC to the said project along with all the general and specific conditions as suggested by SEAC but SEIAA replaces the specific condition regarding cluster certificate as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate" and adding following conditions:

- Validity period of this EC is 3 months from the date of issue as the LoI has been issued for a period of 3 months or co-terminus with the validity of current mine plan or current lease period whichever is earlier. After this period the EC will become null and void.
