

**MINUTES OF THE 103<sup>RD</sup> GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 09/05/2023 AT 03:30 P.M. IN THE CONFERENCE ROOM OF THE 4<sup>TH</sup> FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA**

The 103<sup>rd</sup> meeting of the Goa - SEIAA (*hereinafter referred as 'Authority'*) was held on 09<sup>th</sup> May 2023 at 03:30 pm in the conference room, 4<sup>th</sup> floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer Annexure - 1*).

**Decision:** After scrutinizing the complaint, the Authority decided to forward the complaint to the Collector for illegal removing of laterite stone and to the Goa State Pollution Control Board with respect to Noise Pollution for further necessary action.


