

Minutes of the 88th meeting of State level Environment Impact Assessment Authority, Jharkhand held on 08th April, 2021.

The 88th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 08th April, 2021 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 88th SEIAA meeting are as follows:-

1. SEIAA considered the recommendations made by SEAC in its 87th meeting held on 23rd, 24th and 25th February, 2021 for grant of Environmental Clearance to the Building projects:


- i. Panache 99 Building Complex (Residential Building & Commercial Building) of M/s Chotanagpur Engineering Works Pvt. Ltd., Village : Konka, Tehsil : Sadar, Dist. : Ranchi, Jharkhand. (Proposal No. : SIA/JH/MIS/190477 /2020)
- ii. Sahara's "Sunrise Point" Residential & Commercial Project of M/s Samay Construction Pvt. Ltd. (Lakshmi Devi & Others), Village : Dindli, Hari Om Nagar, P.S. : Adityapur, Dist. : Saraikela Kharsawan, Jharkhand. (Proposal No. : SIA/JH/MIS/191344 /2021)

It was decided to grant Environmental Clearance to the above mentioned project proposals with the conditions recommended by SEAC.

2. SEIAA considered the recommendations made by SEAC in its 87th meeting held on 23rd, 24th and 25th February, 2021 for grant of Environmental Clearance to the following projects:

- i. Demba Stone Deposit of M/s Amit Kumar Gupta & Vinod Yadav, Mouza : Demba, P.S. : Borio, Dist. : Sahibganj, Jharkhand (3.61 Ha) (Proposal No. : SIA/JH/MIN/192062/2019).
- ii. Dulmi Stone Mining Project of M/s Elite Power Project and Construction Pvt. Ltd., Village : Siru, Tehsil : Dulmi, District : Ramgarh, Jharkhand. (9.50 Ha) (Proposal No. : SIA/JH/MIN/40612/2020).
- iii. Kurkutta Stone Deposit of M/s Bhole Shankar Stone Works, Village : Kurkutta, Taluka : Giddi, Dist. : Hazaribagh, Jharkhand (0.49 Ha). (Proposal No. : SIA/JH/MIN/45227 /2019).
- iv. Brick Soil Mining for M/s Nasim Traders (Sun Bricks), Village : Kochbong, Thana : Namkum, Dist. : Ranchi, Jharkhand (1.53 Ha). (Proposal No. : SIA/JH/MIN/191940 /2021).
- v. Brick Soil Mining for M/s B.S.P. Bricks, Village : Hochar, Thana : Ratu, Dist. : Ranchi, Jharkhand (1.01 Ha). (Proposal No. : SIA/JH/MIN/193973/2021)
- vi. Brick Soil Mining for M/s B.K.B. Bricks, Village : Sanga, Thana : Pithoriya, Dist. : Ranchi, Jharkhand (0.999 Ha). (Proposal No : SIA/JH/MIN/194404/2021)

The SEAC has scrutinized the above projects in the light of Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018. Thereafter, SEAC has made unanimous recommendation for




grant of Environmental Clearance of above mentioned projects proposals. The SEIAA based on the recommendations of SEAC unanimously decided to grant Environmental Clearance to the above mentioned project proposals subject to Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018.

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.
 - b. Form-1M be made more comprehensive for areas of 0 to 5 Ha by dispensing with the requirement for public consultation to be evaluated by SEAC for recommendation of grant of EC by SEIAA instead of DEIAA/DEAC.
 - c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.
 - d. EIA and /or EMP be prepared for the entire cluster in terms of recommendations 5 (supra) of the guidelines for the purpose of recommendations 6, 7 and 8 thereof.
 - e. Revise the procedure to also incorporate procedure with respect to annual rate of replenishment and time frame for replenishment after mining closure in an area.
 - f. The MoEF& CC to prepare guidelines for calculation of the cost of restitution of damage caused to mined- out areas along with the Net present value of Ecological services forgone because of illegal or unscientific mining.
3. SEIAA considered the recommendations made by SEAC in its 87th meeting held on 23rd, 24th and 25th February, 2021 for delisting of proposals:
- i. Stone Mine Project of M/s Radha Krishna Jaiswal at Vill.- Leungdih. Chandil Saraikela-Kharsawan (23.50 Acre).
 - ii. Balkudra OCP (1.0 MTPA Normative & 1.3 MTPA Peak) of M/s Central Coalfield Ltd at Vill. : Balkudra. Dist. : Ramgarh (149.50 Ha).
 - iii. Khanudih Dagdho Balu Ghat of Shri Raj Kumar Mahto. Vill. : Khanudih Dagdha. Tehsil : Baghmara. Dist.: Dhanbad. (21.04 Ha).
 - iv. Bhendra Sand Mining Project on Jamunia River of Sri Pintu Kumar. Vill. : Bhendra. Anchal : Nawadih. Dist. : Bokaro (9.71 Ha).

The Authority examined the recommendations made by SEAC in above mentioned project proposals and after full deliberations, it was unanimously decided to accept the recommendations made by SEAC in this regard and accordingly delist the above proposals.
