SEIAA accepts the recommendation of SEAC and decides to grant the revise EC of above mentioned stone mine proposal.

S. SEIAA considered the recommendations made by SEAC in its 38<sup>th</sup> meeting held on 18<sup>th</sup> to 24<sup>th</sup> December, 2015 (Part –G) to sought the clarification from Department of Mines, Government of Jharkhand:-

I. Common Biomedical Waste Treatment Facility of M/s Medicare Environmental Management Pvt. Ltd. at Village- Lohardaga, Dist- Lohardaga, Jharkhand.

SEIAA agrees with the recommendations made by SEAC to prescribe ToR to the project proposal mentioned above. SEIAA, therefore, decides to prescribe ToR to this project on the conditions recommended by SEAC.

U. SEIAA considered the recommendations made by SEAC in its 38<sup>th</sup> meeting held on 18<sup>th</sup> to 24<sup>th</sup> December, 2015 (Part -G) for credible action to the following project proposal:-

SEIAA considered the DMO's certificate and found that it is not a case of mining renewal and distance from forest is 150 meters only. So its distance from forest is less than minimum distance criteria decided by SEIAA hence this Project is rejected and delisted.
