The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1, 4: The Authority was of the view that the shortcomings in these
  proposals still needs to be resolved. Hence, The Authority decided to defer these
  proposals and decided to call the PP/ Consultant for personal hearing.
- Serial No. 2, 3, 5, 7, 8, 9, 10, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42: The
  Authority accepted the recommendations of SEAC and decided to grant EC to this
  proposal.
- Serial No. 6, 11: The LoI of these proposals has expired. Hence the Authority decided to defer these proposals for additional information with a direction that the project proponent must submit revised LoI within 45 days.
- Serial No. 12, 13, 17, 43, 44, 45, 46, 47: The Authority accepted the recommendation of SEAC and decided to close & delist these proposals.

- Serial No. 16: In this proposal, the legal opinion of the SEIAA was sought by SEAC.
  Hence, SEIAA decided to refer this proposal back to SEAC with the legal opinion of
  the Authority on file.
- 8. Serial No. 19: In this proposal, DCF Certificate is not enclosed and khari river is at 0.3 km. The Authority decided to grant ToR to this proposal with the condition that the certificate from the Water Resource Department (WRD) and DCF Certificate must be submitted with the compliance of ToR.

clearance from NBWL. The project was considered in 5.42<sup>nd</sup> meeting of SEIAA and PP was asked to submit the clearance from NBWL, failing which the Authority decided to close and delist the proposal till the clearance from NBWL is obtained.

- 13. Serial No. 50: This proposal was considered in 5.46<sup>th</sup> meeting of the Authority but LoI of this proposal had expired on 5.10.2022. Now, the PP has submitted the lease agreement. Hence, the Authority accepted the recommendations of SEAC and decided approve EIA/ EMP and grant EC to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 14. Serial No. 51: The Consultant on behalf of PP gave the clarification on the alleged ambiguity stated by SEAC in the WRD Certificate. The Authority disagreed with the recommendations of SEAC. Water Resources Department (WRD) is the competent department in the Government of Rajasthan to deal with the particular issue. SEIAA doesn't find any ambiguity in the certificate issued. In addition to all other that has been stated, it has been further clearly stated that mining in the area will not infringe the directions of Hon'ble High Court in the matter of Abdul Rehman V/S State of Rajasthan and others in D.B. CWP No- 1536/2003. In view of above, the Authority decided to grant EC to this proposal.
- 15. Serial No. 52: This matter was listed before SEIAA in its 5.44th meeting dated 30.09.2022. SEAC-1 in its 5A.25th meeting had recommended to reject the proposal for the reasons mentioned in its minutes. However, the Authority considered it appropriate to afford an opportunity of personal hearing which was communicated to PP/ Consultant. Accordingly, the case was rescheduled in 5.48th meeting of SEIAA and communication was sent on 21.10.2022 for the same. However, the PP was not present.
