- zone. Newly planted saplings to be maintained for minimum 3 years with Geo-Tagged photographs.
- iii. Dedicated water tanker to be provided for mine. The tanker to be used for spraying water on haul road and for irrigating newly planted saplings only. Sprinkling to be done such that the haul road is kept moistened all the time with Geo-Tagged photographs.
- iv. Pre employment Occupational health check up for employees to be done and thereafter at annual interval for PLFT. Audiometry and other required tests. Summary findings of same to submitted along with 6 monthly compliance.
- v. Ensure use of Quality PPEs equivalent not less than 3M make. Records of same to be maintained and submitted with 6 monthly compliance report with Geo-Tagged photographs.
- vi. Keep vulnerable areas unmanned. Ensure rotation of duties. Records to be maintained and submitted with 6 monthly compliance report.
- vii. Failing of any of terms & conditions mentioned in EC can lead to revocation / cancellation of EC

SEAC has made unanimous recommendations for grant of ToRs to above mentioned proposals. The SEIAA, based on the recommendation of SEAC, unanimously decided to grant ToRs to the above mentioned project proposals with the conditions recommended by SEAC.

In the light of the recommendation of SEAC for approval of District Survey Report (Sand) of **Sahibganj district**, the same was considered in the 110th meeting of SEIAA, Jharkhand on 27, 28 and 29.10.2023.

The SEIAA, unanimously, decided to approve the District Survey Report of Sand mineral of **Sahibganj district** on the basis of recommendation of SEAC in the light of Environment & Monitoring Guidelines for Sand Mining 2020 / Hon'ble Apex Court order in Civil Appeal No. 3661-3662/2020, Pawan Kumar Vs State of Bihar & Hon'ble NGT Order in OA No. 54/2022/EZ, Bhumi Adhigrahan Visthapan Avam Punarvas Kisan Samiti Vs State of Jharkhand & Ors, It was also/decided that

a copy of approved District Survey Report of **Sand** should be sent to the concerned Deputy Commissioner for necessary action.

- B. Final District Survey Report (DSR) for Minor Minerals other than Sand Mining or River Bed Mining (Stone) to be approved on following District:
 - I. District Survey Report (Stone) of Garhwa district

After Technical presentation before SEAC and appraisal of DSR, the unanimous recommendation was sent to SEIAA for approval of District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone) of **Garhwa** district, as the District Survey Report (Stone) contained all relevant information required as per the notification no. S.O. 3611(E), dated 25.07.2018 of MoEF & CC, Govt. of India.

In the light of the recommendation of SEAC for approval of District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone) of **Garhwa** district, the same was considered in the 110th meeting of SEIAA, Jharkhand on 27, 28 and 29.10.2023.

The SEIAA, unanimously, decided to approve the District Survey Report for Minor Minerals other than Sand Mining or River Bed Mining (Stone) of **Garhwa** district on the basis recommendation of SEAC. It was also decided that a copy of approved District Survey Report of Stone should be sent to the concerned Deputy Commissioner for onward necessary action.

20. Transfer of Environmental Clearance regarding.

I. Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal), Mouza: Bansjor, Thana: Bansjor, District: Simdega, Jharkhand (1.436 Ha) (Proposal No. SIA/JH/MIN/305306/2023).

The above mentioned project proposal was considered in the light of section 11 of Environment Impact Assessment Notification. 2006 for transferability of Environmental Clearance. The Environmental Clearance was granted by SEIAA, Jharkhand vide letter no. EC/SEIAA/2015-16/1847/2015/2588, dated 31.12.2015 in the favour of "Bansjor Stone Deposit of M/s Krishna Minerals & Trading Agency (Sri Bala Krishna Padhy) at Khata No. – 178, Plot No. – 3535(P) at Village: Bansjor, Thana: Bansjor, District: Simdega, Jharkhand (1.436 Ha)".

The applicant vide online application no. SIA/JH/MIN/305306/2023 has requested to transfer (transfer of ownership) of Environmental Clearance in favour of "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal), Mouza: Bansjor, Thana: Bansjor, District: Simdega, Jharkhand (1.436 Ha)" for which he has

submitted no objection certificate affirming that the Environmental Clearance will be transferred in favour of "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)" for which he has submitted no objections certificate affirming that the lease deed has already been transferred in the name of "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)" by Deputy Commissioner, Simdega vide GRN Number – 2108885981 and they do not have any objections regarding the transfer of Environmental Clearance and all the terms and conditions of Environmental Clearance dated 31.12.2015 shall be complied by "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)".

After the full deliberations, it was unanimously decided that Environmental Clearance issued vide letter no. EC/SEIAA/2015-16/1847/2015/2588. dated 31.12.2015 is being transferred to "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)" with the same terms and conditions under which prior Environmental Clearance was granted by SEIAA. Jharkhand for the same validity period subject to satisfactory compliance to all stipulated terms and conditions "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)" is directed to obtain Consent to Operate from the State Pollution Control Board in the name of "Bansjor Stone Mine of M/s Vineet Enterprises (Proprietor: Shri Vineet Kejriwal S/o Shri Ashok Kumar Agarwal)". In case any change is proposed in the Scope of the project, the Project Authority (PA) shall obtain fresh Environmental Clearance.
