6. Do your Presentation by Screen Sharing (with **full Screen mode**).
7. You shall join VC meeting **only after call received from SEAC Team**.
8. **Proponent (PP) must remain present** in the VC.
9. **Display your name** properly showing your identity as **PP or Consultant**.
10. **Keep all relevant documents** ready for display.
