It is noted that the project site is near to the Pulusumamidi village and the proposed manufacture of MS Billets, TMT Bars, Structural Steel by installing Induction furnace by using Iron Scrap, Sponge Iron etc., involves emission of high quantity of particulate matter and gases into the atmosphere. The proponent proposed air pollution control equipment for control of emissions. However, there is a possibility of break downs of the equipments.

In view of the above, duly considering the high negative impact on environment and health of the nearby residents, the proposal is not considered, hence rejected.
