The Authority after detailed discussion and deliberation decided the following:

 Serial No. 1: This proposal was closed and delisted in the 5.70<sup>th</sup> meeting of the Authority for ambiguous WRD Certificate and expired LoI for inclusion. PP vide his

letter dated 23.6.23 requested relisting of the proposal and submitted extended LoI for inclusion issued from Mining Department dated 12.6.23 and revised WRD Certificate dated 24.3.23 mentioning that Lease area doesn't infringe with the directions of Hon'ble HC in the matter of Abdul Rehman. Hence, the Authority decided to grant EC to this proposal as per the recommendations of SEAC.

- Serial No. 2: This proposal was deferred in 5.80<sup>th</sup> meeting of the Authority for non-submission of DSR of proposed mineral (granite). Now, PP has submitted the same.
  Hence, the Authority decided to grant EC to this proposal as per the recommendations of SEAC.
- 3. Serial No. 3: The proposal was deferred in 5.81<sup>st</sup> meeting of the Authority for submission of CA certified turnover figures. Now, PP has submitted CA certified turnover figures dated 16.6.23. Hence, the Authority decided to grant EC to this proposal as per the recommendations of SEAC subject to condition that an amount of Rs. 46.5 Lacs with reference to Remediation Plan shall be deposited to RSPCB in the form of Bank Guarantee, in addition to this a penalty of Rs. 2.17 Lacs will also be deposited with the RSPCB, as per the provisions of the EIA Notification. 2006.

Hence, the Authority decided to accept the recommendations of SEAC and grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 2.17 lacs by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 46.5 lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

4. Serial No. 4: The proposal was deferred in 5.82<sup>nd</sup> meeting of the Authority for submission of ATR on non-compliance of condition 15 of the Certified Compliance Report and CA certified turnover figures. Now, PP has submitted the ATR and CA certified turnover figures dated 28.6.23. SEAC recommended Bank Guarantee of Rs. 2,04,000/- and penalty of Rs. 97765/-. But as per the new CA certified production figures dated 28.6.23, penalty amounts to be 116331/-....

Hence, the Authority decided to accept the recommendations of SEAC and grant EC for expansion and inclusion of Masonry stone to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 116331/- by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 2,04,000/-towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 5. Serial No. 5: The proposal was deferred in 5.80th meeting of the Authority for not submitting ATR on regular six monthly compliance and copy of EC newspaper advertisement, as mentioned in Certified Compliance Report. Now, PP has submitted the ATR on conditions asked. Hence, the Authority decided to accept the recommendations of SEAC and decided to approve EIA/ EMP and grant EC for expansion and inclusion of Silica sand and Murram to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 6. Serial No. 6, 7: The proposal was deferred in 5.83rd meeting of the Authority for submission of affidavit for implementation of EMP. Now, PP has submitted the required affidavit. Hence, the Authority decided to accept the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the conditions laid down by SEAC.
- 7. Serial No. 8: In 5.83<sup>rd</sup> meeting of the Authority, based on the affidavit given by PP and consultant which stated that this is an eminent case of violation. The Authority decided to give ToR under violation. Now, they have admitted to their mistake that the affidavit was wrongly submitted. This is a fresh case with no violation of EIA, 2006. In view of the above, the decision taken in previous meeting is revised and ToR (without violation) is granted as recommended by SEAC subject to deposition of Rs. 10,000/- (at the rate of Rs. 5000/- each) as fine for submitting wrong affidavit. ToR may be issued once the amount is deposited in RSPCB.
- 8. Serial No. 9: In this proposal, reply to the query letter issued by the Authority to SEAC, in regard to the letter sent by SEAC seeking return of the case, is still awaited. Hence, the Authority decided to defer the proposal till reply from SEAC is received. Thereafter, the proposal may be put in ensuing meeting.
- 9. Serial No. 10: This proposal was considered in the 5.83<sup>rd</sup> meeting of the Authority as a violation case and it was approved for EIA/ EMP and grant of EC without mentioning the condition to submit Bank Guarantee and Penalty before issuance of EC. Through oversight it was not recorded in the minutes of 5.83<sup>rd</sup> meeting. The same has now been corrected as, "the Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to this proposal subject to condition that an amount of Rs.6,89,600/- with reference to Remediation Plan shall be deposited to RSPCB in the

form of Bank Guarantee, in addition to this a penalty of Rs. 48264/- will also be deposited with the RSPCB, as per the provisions of the EIA Notification. 2006.

Hence, the Authority decided to accept the recommendations of SEAC and grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 48264/- by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 6,89,600/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 10. Serial No. 11: The proposal was deferred in 5.83<sup>rd</sup> meeting of the Authority as affidavit submitted with the proposal was in the name of Mohammad Shibli Khan but no document or authorization letter for Mohammad Shibli Khan was enclosed. Now, PP has submitted a resolution of board in the name of Mohammad Shibli Khan. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 11. Serial No. 12: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC for expansion to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 12. Serial No. 13, 14, 16, 18, 19: The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 13. Serial No. 15: In this proposal production figures submitted from March 2021- March 2023 are not certified. In addition to this, in the Certified Compliance Report dated 26.5.23, conditions of Sr. No. 10, 15 are not complied. Hence, the Authority decided to defer this proposal for additional information of certified production figures from the Mining Department and ATR on non-complied conditions of CCR which are to be submitted within 45 days.
- 14. Serial No. 17, 20, 23, 31, 32, 39, 40, 44, 46, 48, 52: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant <u>EC</u> to these proposals.
- 15. Serial No. 21: In this proposal, affidavit regarding implementation of cluster EMP is not enclosed. Hence, the Authority decided to defer this proposal for additional information of affidavit regarding cluster EMP, to be submitted within 45 days.

- 16. Serial No. 22: the Authority decided to defer this proposal for additional information on following discrepancies, clarification on which is to be submitted within 45 days
  - Khasra Number in DCF Certificate dated 26.6.2019 is 2800/4131 but in lease order it is 2800/413.
  - II. Production capacity of the cluster is different in proposal (7,24,158.38 TPA) from cluster mining plan (471129.1 TPA)
  - III. Production capacity of the lease area in the ToR letter is mentioned as 336955 TPA but in the proposal and mining plan it is 35283 TPA.
  - IV. Affidavit regarding implementation of cluster EMP is not submitted.
- 17. Serial No. 24: In this proposal, there is discrepancy with khasra numbers mentioned in Form-1, Patta dated 18.4.2012, amalgamation letter dated 25.7.2016 and Building Plan. Hence, the Authority decide to defer this proposal for additional information for clarification on khasra numbers, justification for proposal to cut trees submitted to forest officer dated 1.6.23 and remedial measures for the same to be submitted within 45 days.
- 18. Serial No. 25: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant ToR under violation to this proposal subject to the condition of submitting approved Building Plan at the time of final application.
- 19. Serial No. 26: The Authority decided to defer this proposal for a detailed presentation particularly on water sources, solid & wastewater management, parking plus open spaces and justification for proposal to cut trees dated (19.7.19) with remedial actions proposed for the same.
- 20. Serial No. 27: The Authority decided to defer this proposal for presentation with special emphasis on parking since the building is located at a particular place where parking of vehicles on the roads on account of public offices in the vicinity has already become a nuisance. Hence, the building has to make provisions to provide parking for residents, staff and visitors to the complex. The plan to accommodate the same may be explained. Architect's certificate dated (24.4.23) may also be submitted.
- 21. Serial No. 28: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant EC to this proposal subject to deposition of BG & Penalty as recommended by SEAC. SEAC further resolved that the amount of Rs. 50,50,500/- with reference to Remediation Plan and Natural & Community Resource Augmentation Plan should be deposited to RSPCB in the form of Bank

Guarantee. In addition to this, penalty of **Rs 10,11,525**/- will also be deposited with the RSPCB, as per the Provisions of the EIA Notification, 2006 and OM dated 28.07.2022 of the MoEF & CC.

Hence, the Authority decided to accept the recommendations of SEAC and grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 10,11,525/- by online/Demand Draft mode and also submit the Bank Guarantee of Rs. 50,50, 500/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 22. Serial No. 29: The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant ToR to this proposal subject to submission of authenticated DSR of the proposed mineral with the final application.
- 23. Serial No. 30: In this proposal, cluster production capacity in proposal is 1316892 TPA (ROM) and in cluster mining plan it is mentioned as 1244035 TPA (ROM). Hence, the Authority decided to defer this proposal for additional information of revised cluster mining plan, to be submitted within 45 days.
- 24. Serial No. 33: In this proposal, DSR of granite is enclosed while the project is for Quartz and Feldspar. Also, the proposal mentions habitation at distances of 17.5m, 37.5m, 67.5m and a kaccha rasta passing through the lease area. Hence, the Authority decided to defer this proposal for additional information of authenticated DSR of proposed mineral and safety measures to be taken regarding habitation and kaccha rasta which is to be submitted within 45 days.
- 25. Serial No. 34, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- 26. Serial No. 35, 36, 37, 41, 42: The Authority accepted the recommendations of SEAC and decided to <u>close & delist</u> these proposals.
- 27. Serial No. 38: In this proposal, Khasra no. in form-1, affidavit is 2685 instead of 2628, 2689/1. In Demarcation survey report, it is 2576. Hence, The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant ToR to this proposal subject to condition of submitting correct khasra no. mentioned in all documents at the time of final application.
- 28. Serial No. 43: In this proposal, Mining scheme was valid till 2022-23. Hence, the authority decided to grant EC as per the recommendations of SEAC subject to submission of approved mining scheme.

- 29. Serial No. 45: For this proposal, the recommendations of SEAC is not in order and needs to be reconsidered. Two different reasons have been cited to close & delist the proposal neither of which merits the solution of close & delist. For expired LoI, PP is required to be given an opportunity to submit renewed LoI. The citing of WRD conditional NOC with respect to passing of a natural nallah/ tributary is also not a case of close & delist. SEAC has to give a conclusive recommendation of whether EC is to be given for a part of the area for which WRD has given NOC or entire proposal needs to be rejected. Hence, the Authority decided to refer back this proposal to SEAC for re-consideration.
- 30. Serial No. 47: In this proposal, Revised DCF Mount Abu and DCF Pali certificate was to be submitted at the time of final presentation as per ToR letter. This condition of ToR has not been complied. Condition No. 15 of CCR dated 17.5.23 is not complied. Also, affidavit of cluster EMP implementation is not enclosed. Hence, the Authority decided to defer this proposal for additional information regarding above mentioned shortcomings, to be submitted within 45 days.
- 31. Serial No. 49: In this proposal, DSR enclosed is of granite while the proposal is of Quartz, Feldspar and Masonry stone also affidavit regarding implementation of cluster EMP is not submitted. Hence, the Authority decided to defer this proposal for additional information of DSR of proposed mineral and affidavit of cluster EMP implementation, to be submitted within 45 days.
- 32. Serial No. 50: In this proposal, general conditions of no. 3, 15 and 16 of CCR dated 23.1.23 are not complied. The mining plan is for the year 2022-23 only and certified production figures for 2022-23 have not been submitted. In addition to this, SEAC's abstract (Online & Hard file) mentions violation details of different proposal and additional conditions are not complete in the abstract enclosed in file. Hence, the Authority decided to defer this proposal for additional information of ATR on non-complied conditions of CCR, certified production figures and valid mining plan, to be submitted within 45 days. Meanwhile SEAC may send corrected abstract of the proposal.
- 33. Serial No. 51: In this proposal, following shortcomings were found -
  - Maximum proposed excavation in form-1 is 1269039 TPA with mineral production 236606 TPA, OB – 1032433 TPA. However, in mining plan mineral production is – 255434 TPA.
  - II. Affidavit of Cluster EMP Implementation is not enclosed

- III. Query reply letter dated 16.5.23 is not enclosed
- DSR is not enclosed. Uploaded DSR on portal is not authenticated.

Hence, the Authority decided to **defer** this proposal for clarification on above mentioned shortfalls.

- 34. Serial No. 63, 67: The Authority decided to grant Transfer of EC to these proposals.
- 35. Serial No. 64, 65, 66: The Authority decided to grant Transfer EC to these proposals with a direction to apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
