MINUTES OF THE 60th GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA–SEIAA) MEETING HELD ON 03/08/2021 AT 10.30 AM. IN THE CONFERENCE ROOM, 4th FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA.

The sixtieth meeting of the Goa-SEIAA (hereinafter referred as 'Authority') was held on 03^{rd} August 2021 at 10.30 am. in the conference room, 4^{th} floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (<u>refer Annexure</u> -1).

- i) Plantation of (Indigenous/ medicinal value) to be carried out within the campus premises in consultation to Goa State Biodiversity Board and submit the list.
- ii) Detailed EIA report to be submitted by the PP to the Authority.
- iii). PP has to make provision for installation of Solar panels within the premises.
- iv) Emergency exit gate to be shown on the proposed site plan.
- v. PP has to submit Contour plan of the proposed site.

Decision: Further the authority decided to inspect the proposed site on 17th August 2021 to check site specific conditions.

2. Project Minor Mineral proposal received from **Dr. Prafulla R. Hede**, Plot/Survey/Khasra No. 29/2, Village Collem, Tehsil-Dharbandora-Sanguem, South-Goa dated 19th March 2021 on Parivesh.

After viewing the committee's recommendation and scrutinizing the application and documents submitted by PP, the Authority noted that there is a violation of environment under EIA Notification 2006 which is released by MoEF&CC so that the proponent has to apply for ToR under violation category as per the successive Notifications issued by the MoEF&CC dated 14th March 2017 and 8th March 2018 respectively.
