The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: The proposal was deferred in 5.100th meeting of the Authority held on 26.10.2023 for a detailed AV presentation to understand the project with special emphasis on parking provided for retail and conventional centre since this is a huge project and PP was called to explain how additional load on traffic will not impact the existing entry and exit facility for the airport passengers.

Now, PP made a presentation on the additional details sought for the project by the Authority. There are two plots for proposed commercial development:-

Plot A – the proposed parking and other provisions as proposed by the PP with respect to plot A were found satisfactory.

Plot B – The Authority had concerns in respect of activities proposed in Plot B. There were no details in the Conceptual Plan submitted in respect of the Convention Centre with a projected population of 4500. The parking provisions for the Flexi Offices were considerably inadequate.

In addition, it was felt that PHED water supply may not be able to supply the entire 669 KLD requirement of fresh water for the complex and the PP needs to apply for ground water supply source from CGWA.

Based on these inputs, the Authority decided to **defer** this proposal. PP may submit the required additional information within 45 days so that the matter may be considered in the ensuing meeting.

- 2. Serial No. 2, 3, 4, 5, 6, 9, 10, 13, 14, 15, 16, 17, 18, 19, 24, 27, 28, 29, 30, 32, 34: The Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals. - 13. Serial No. 43, 48: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to these proposals.
- 14. Serial No. 44: The Authority accepted the recommendations of SEAC and decided to grant amendment in ToR to this proposal.
- 15. Serial No. 45, 49: The Authority decided to close & delist these proposals on the recommendations of SEAC.
- 16. Serial No. 46: The Authority decided to refer back this proposal to SEAC to specify the year sof violation keeping in view the judgement of Hon'ble Supreme Court in the matter of Common Cause vs Union of India and notification dated 06.04.2018.
- 17. Serial No. 47: SEAC has observed that the EC for which amendment is sought, has expired on 21.2.2023. The Committee found it appropriate to recommend to SEIAA to close and delist the proposal. The Authority decided to afford an opportunity to the PP/ Consultant for personal hearing before taking a decision in the proposal.
- 18. Serial No. 51: Cluster Certificate of this proposal has expired on 19.10.2022, Production Certificate for the year 2022-2023 has not been submitted and the Certified Compliance Report submitted is more than a year old. Hence, the Authority decided to defer this proposal to submit the three mentioned valid documents within 45 days.
- 19. Serial No. 52: It has been observed that the earlier EC granted for this Mining Lease has not been transferred to the applicant. Hence, the Authority has decided to defer this proposal for submission of Transfer EC in the name of applicant, within 45 days.



and

- Serial No. 53, 54, 55, 56, 57, 58: The Authority decided to grant Transfer EC to this proposal.
- 21. Serial No. 59, 60, 61, 62: In these proposals, production has been carried out exceeding the granted capacity of EC. Hence, The Authority decided to grant Transfer EC to these proposals with the condition that the PP concerned shall apply for TOR under violation and reappraisal within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 22. Serial No. 63, 64, 65, 66: The Authority decided to grant Transfer EC to this proposal with a direction to apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023 and Hon'ble NGT order dated 07.12.2022.
- 23. Additional Agenda 1: Proposal was closed and delisted in 5.77th meeting of SEIAA as "This proposal is at a distance of 7.3 km from the boundary of Kumbhalgarh WLS for which ESZ is still not notified. Proposed area is within the buffer zone of Kumbhalgarh WLS. Under these circumstances PP may obtain clearance from NBWL and till that time the case may be closed and delisted. PP may apply for relisting of the case once NBWL clearance is obtained or the ESZ of Kumbhalgarh WLS gets notified whichever is earlier"

PP requested to relist the proposal and consider the proposal vide letter dated 07/11/2023 stating that "SEIAA Rajasthan, has issued EC to M/s. Technopro stones Pvt. Ltd and Sh. Kapura Ram, in the similar cases".

Considering the request, the Authority was of the view that earlier as per MoEF&CC OM dated 08.08.2019 which states "Proposals involving developmental activity/project located within 10 km of National Park/Wildlife Sanctuary wherein final ESZ notification is not notified (or) ESZ notification is in draft stage, prior clearance from Standing Committee of the National Board for Wildlife (SCNBWL) is mandatory. In such cases, the project proponent shall submit the application simultaneously for grant of Terms of Reference/environmental clearance as well as wildlife clearance." the Authority issued the quoted EC. Later, NGT judgement was pronounced on 30.09.2022 wherein, NGT directed that the NBWL is to consider the aspects while considering the application for clearance to be granted under the Wildlife (Protection) Act, 1972. Till such time, the MoEF&CC is directed to await the clearance granted





by the NBWL for the purpose of appraisal of the project by the EAC as well as the MoEF&CC and then take appropriate decision in this regard. As per the Hon'ble NGT directions, no EC has been issued after 30.09.2022 to the projects which fall in the ESZ till NBWL clearance has been obtained. In the instant case, the PP has not obtained NBWL clearance. Therefore, the proposal cannot be considered for grant of EC till the NBWL clearance is obtained.
