

**MINUTES OF THE 67th GOA STATE ENVIRONMENT IMPACT ASSESSMENT
AUTHORITY (GOA-SEIAA) MEETING HELD ON 22/11/2021 AT 10.30 AM. IN
THE CONFERENCE ROOM OF THE 4th FLOOR, DEMPO TOWER, PATTO,
PANAJI-GOA.**

The sixty-seventh meeting of the Goa-SEIAA (*hereinafter referred as 'Authority'*) was held on 22nd November 2021 at 10.30 am in the conference room, 4th floor, Dempo Tower, Patto, Panaji. The list of members present during the meeting is annexed (*refer Annexure – 1*).

At the outset, Chairman welcomed Authority members and briefed about the agenda items (*refer Annexure – 2*) to be taken up for discussion / deliberations and suitable decisions. Accordingly, the same were considered as detailed below –

1. To discuss on project received from Sir Biotech India Ltd. on 03/03/2021 at P.T. Sheet No. 17, Chalta No. 4.C. Ribandar North Goa.

The representative of Sir Biotech India Ltd. Mr. Vinod Agarwal, Mr. Ashok Joshi, Mr. Rajiv Aundhe and consultant Rajas S. Salkar appeared before the Authority and explained the details of the project.

Decision: After scrutinizing the application and documents submitted by the Project Proponent, the Authority suggested to increase the open area of the parking plot. The Authority also decided to inspect the site to verify the specific conditions after due intimation to PP.

2. To discuss on project received from M/s. Satt-Adhar Builders on 20/08/2021 at Chalta No. 78, 78-B, 79 to 103 of P.T. Sheet No. 95 of City survey, Panaji Goa, Tiswadi, North Goa.

Project Proponent Shri. Kalpesh Gohil, along with Environment Consultant Mr. Vishal Sannakhri appeared before the Authority.

Decision: After scrutinizing the application and documents submitted by the Project Proponent, the Authority suggested PP to set up STP to the project, electric charging points in the parking area and to provide solar panels and solar water heating. The Authority also suggested PP to put soil belts in the centre of the building and vertical garden for cooling the area. The Authority decided to inspect the site to see the site condition after due intimation to PP and thereafter call the Project Proponent for further discussion of his project.
