Minutes of the 86th meeting of State level Environment Impact Assessment Authority, Jharkhand held on 12th January, 2021.

The 86th meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 12th January, 2021 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

3. Decision on matter related to:-

i. Housing Complex, Construction (including structural design) of 2020 Dwelling units under Pradhan Mantri Awas Yojana (urban) [Package B] of Adityapur Municipality Corporation at Village: Kashidih, Tehsil: Gamharia, District: Saraikela Kharswan, Jharkhand. (Proposal No.: SIA/JH/MIS/114543/2019.

The above proposal was considered in the light of 85th meeting SEIAA through which SEIAA asked the PP to submit the certificate of concerned DFO whether any protected important or sensitive species of Fauna exists in ponds which fall within the premises or not?

The project proponent vide letter no. -3098 dated -30.12.2020 has submitted the certificate of concerned DFO issued vide letter no. -2338 dated -29.12.2020 which clarify that there is no such protected, important or sensitive species of Fauna has been reported in existing ponds within the premises.

Hence, after full deliberations it was unanimously decided to grant Environmental Clearance with the conditions and recommendations made by SEAC vide 83^{rd} minutes of meeting held on $24^{th}-26^{th}$ November, 2020.

ii. Stone Quarry at Baliapur of M/s Virbhan Das at Vill. : Baliapur, Dist. : Dhanbad, Jharkhand (0.89 Ha).

The project proponent appeared with his consultant in light of 85th meeting of SEIAA. The consultant presented the KML file of 2014 and current date, which were found in order.

Hence after full deliberations it was unanimously decided that recommendations made by SEAC vide meeting dated 24th – 26th November, 2020 is accepted. Accordingly it was decided to remove the abeyance clause of earlier decision of SEIAA. This decision shall be communicated to concerned District Mining Officer and Member Secretary, Jharkhand State Pollution Control Board & project proponent.
