4. Grant of EC

The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal with the condition to carry out mining in a scientific manner to keep habitation (at 50 m) and road (near to lease area) safe as mentioned in LOI letter.
- Serial No. 2, 3, 5, 8, 9, 46: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- Serial No. Serial No. 4, 6, 7, 11, 12, 13, 14, 15, 16, 17, 18, 19, 21, 24, 25, 28, 29, 31, 32, 33, 34, 36, 37, 38, 39, 41, 42, 43, 44, 47, 48, 50, 52, 53, 54, 55, 60, 61, 62, 65
   The Authority accepted the recommendations of SEAC and decided to grant EC these proposals.
- Serial No. 10: The Authority accepted the recommendation of SEAC and decided to
  grant EC to this proposal subject to the condition that a 6 feet pucca wall shall be
  constructed from pillar A to D.
- Serial No. 20: In this proposal, as per the KML submitted by PP, it is visible that there is a water body/Nallah which cuts across the lease area hence, a certificate from Water Resource Department shall be obtained stating that mining in proposed area will not affect the natural drainage. Therefore, the Authority decided to defer this proposal for additional information which must be submitted within 45 days.

- Serial No. 26 & 27: In this proposal LoI has expired on 1<sup>st</sup> Jan 2023. Hence the Authority decided to defer this proposal for additional information which must be submitted within 45 days.
- Serial No. 30: In this proposal there is discrepancy in coordinates of the lease area therefore, the Authority decided to defer the proposal on account of re-confirmation of coordinates submitted in the proposal.
- Serial No. 40: In this proposal, after the detailed deliberation SEAC observed that
  there is violation w.r.t increase in production in subsequent years from the base years
  therefore, recommended ToR under violation. The Authority was of the view that as
  the proposal has been applied for EC therefore, ToR cannot be issued. Hence, The
  Authority decided to reject the proposal and direct PP to apply for ToR under
  violation.
- Serial No. 45: The Authority accepted the recommendation of SEAC and decided to grant EC to this proposal with the direction to comply with all the 6 conditions as mentioned in letter issued by DCF, Pratapgarh dated 30.05, 2022.

Authority decided to defer this proposal to revise the safety plan for the public road passing through the lease area.

- Serial No. 66: The proposal was deferred in 5.54th meeting of the Authority for submission of disclosure of consultants and revised cluster certificate. Now, the PP/ Consultant has submitted the same. Hence, the Authority decided to grant EC to this proposal.
- Serial No. 67: The proposal was considered in 5.54th meeting of the Authority and was deferred for the report from District Collector, Bikaner regarding road at 15m and petrol pump at 40 m. Now, the PP has submitted a reply stating that no blasting & drilling is proposed as per Mining Plan and has also submitted an affidavit for the same. Hence, the Authority decided to grant EC to this proposal subject to condition that no blasting condition shall be adhered to as per the mining plan and affidavit submitted by PP.
- Serial No. 68: The proposal was considered in 5.54th meeting of the Authority and was deferred for correct DSR. Now, the PP/ Consultant has submitted DSR for Jalore. Hence, the Authority decided to grant EC to this proposal.
- Serial No. 69: The proposal was deferred in 5.54th meeting of the Authority for submission of DSR of proposed mineral. Now, the PP/ Consultant has submitted the same. Hence, the Authority decided to grant EC to this proposal.

Serial No. 80: As per the decision of the Authority in its 5.54th meeting, three representatives of SEIAA were deputed for the site visit. According to the report submitted by the representatives of SEIAA, no violation has been found by the PP. Hence, the Authority decided to grant EC to this proposal.

### **Auto ToR Decision:**

It has been observed that more than 90% of the applications are received for EC in Rajasthan are for mining projects, with areas less than 4 ha. These are also for standard minerals like sand stone, masonry stone, marble, granite, mica, feldspar and quartz. While the area may be small, even 1 ha., if they are received after cluster formation, they have to go through the TOR route. Presently, these cases also do not qualify in routine for auto-TOR. Therefore, they are examined by SEAC, then submitted to SEIAA for formal grant of TOR, and then the next round of examination by SEAC and SEIAA is done before issue of EC. The process takes several months. These are routine projects and all of similar kinds. Hence no individual customized TOR are framed by SEAC. Accordingly, with a view to ensure expeditious sanction of ECs, it was decided that in all mining projects, whose project area is 4 ha. or less, auto-TOR may be issued.
