

The SEIAA discussed in detail the recommendations of SEAC and noted that the proponent has submitted approved mining plan dt:22.02.2023, the total mining area is 3.00 ha, total minable reserves are 10,98,540 MT, average production 74,250 MT and life of the mine is 15 years.

As per the ADMG, Rangareddy District, Lr.No.4412/S/2006 dt:11.02.2025, after maintaining the 50 mts RF boundry, the net mining area / effective mining area is 1.74 ha. However, as per the ADS reply dt: 30.05.2025 submitted by the proponent the minable reserves, average production and life of the mine, are the same for the net area of 1.74 ha. Therefore, the proponent is requested to clarify the same duly attested by the concerned mining authority.
