

The SEIAA discussed the recommendations of the SEAC in detail and approved the project for issue of Environmental Clearance with specific conditions:

- The applicant should not obstruct/divert the run-off from catchment leading into the adjacent stream to the applicant site and has to provide suitable vents for free flow of water at entry and exit locations along the boundary.
- The applicant should provide an offset of 27.00 mts from the centre of the existing Nala on west side (i.e., 17.50m for Nala + 0.50m for retaining wall + 9.00m for buffer zone) of his site location.
- The applicant should leave areas of Ac 0-05 Gts for Nala and Ac 0-19.20 Gts for 9.00m wide buffer in his site.
- Dumping/throwing of any type of effluents/wastes etc., and allowing sewerage water in to the tank/surplus course is strictly not allowed as it damages the quality of water.

Agenda Item No. 06	Multi Storied Residential Buildings By M/s. Spectra India Mega Projects Pvt Ltd., Sy. No. – 6, 6/A, 6/E, Injapur Village, Abdullapurmet Mandal, Ranga Reddy District & In Sy. No. 93, 94, 95 & 96, Saheb Nagar Kalan Village, Hayathnagar Mandal, Ranga Reddy District. - Environmental Clearance - Reg.

The SEIAA discussed the recommendations of the SEAC in detail and approved the project for issue of Environmental Clearance with specific conditions:

1. 2.15 mts. bed width should be maintained with 1½ : 1 slope duly maintaining the proper slope for free flow of water.
2. Lining should be done either in C.C. or Masonry.
3. 2 Mts. width may be left on either side of the channel, so as to widen in future if necessary.
4. Obstruction of natural flow in the channel or diverting or tapping of water flow from the channel for any purpose other than Irrigation at any time by owners / Developers or any of their representatives causing affect damage to the Feeder Channel will to cancellation of permission at any time along with the legal and penal action.
5. The flow in the Irrigation cum Feeder Channel should not be obstructed or dviated or utilized for any other purpose i.e., diversion of water for any industrial, domiestic, commercial or private purpose in any manner or dumping any type of effluent in to the Feeder Channel causing quality of water as well as eco and violation will result in canceling no objection along with legal / penal proceedings.

- Mining method should be mild and controlled blast only
- Mining should be done as stipulated by Director General of Mines Safety
- The proponent should follow the rules and instructions of DMS from time to time
- Proper information to be given to the villagers and other inhabitants
- Blasting should be carryout only during day time
- There should not be any excessive explosive to be used
- Certified blaster to be employed
- Construction of garland drains with siltation pond
- Protection of greenery in the non-mining areas within the lease area
- Develop a green belt of 7.5 Meters all around as per the norms
- Construction of the approach road
- Install the air pollution equipment and sprinkling of water
