In view of above, the committee recommended that proposal cannot be appraised till the outcome of above WP (C) no. 1394/2023 and/or any further OM issued by the MOEF & CC and to return the proposal to SEIAA for taking a view on above legal issue.

The Authority in its meeting 5.118th Meeting held on 16 th April, 2024 has defer this proposal in light of the O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF & CC regarding stay imposed by Hon'ble Supreme Court in W.P.(C) No. 1394/2023 titled Vanshakti vs. Union of India, with reference to the SOP dated 7th July 2021 and OM dated 28th January 2022. Now, the PP vide mail dated 15.04.2025, requested to process their proposal for further proceeding. The MoEF&CC, in compliance of orders of the Hon'ble

Supreme Court dated 06.01.2025 issued a notification dated 28th March, 2025 that all projects that have applied under the provision of OM dated 07/07/2021 and which are pending as on 02/01/2024 may be processed.

The Authority decided to <u>refer back</u> this proposal to SEAC-2 for examination the proposal in light of the aforementioned Office memorandum.
