1. Expansion of Existing Integrated Paints & Resins Emulsions Manufacturing Plant at UPSIDC, Village-Kasna, Taluka Dankaur, Gautam Buddha Nagar, U.P. Shri Anjum Perwez. File No. 6251/Proposal No. SIA/UP/IND2/62144/2021

SEIAA agreed with the recommendation of SEAC that the matter shall be discussed after submission of online information on prescribed portal.


SEIAA agreed with the recommendations of the SEAC to defer the matter as the project proponent did not circulate the documents to the members of SEAC on time. Hence it will be taken after submission of online request on prescribed portal.

3. Group Housing Project "Rajvansh Residency" at Khasra No.- 1578, Gram- Aurangabad Khalsa, Ward- Raja Bijali Pasi, Lucknow, U.P., Shri RavindraNath Singh. File No. 6259/Proposal No. SIA/UP/MIS/206515/2021

SEIAA noted that SEAC has recommended to issue EC to the above project. SEIAA gone through file and documents and found that the treated waste water is being drained into a drain for which details have not been given. Project proponent shall submit the

complete details of disposal of the treated waste water. The structural stability certificate submitted by the project proponent is not acceptable hence the project proponent shall submit structural stability certificate from a government institution.

4. Proposed Hospital Project at F-16, Sector-50, Noida, District- Gautam Buddha Nagar, U.P., Shri Manoj Kumar Shukla, M/s Global Health Pvt. Ltd. File No. 6261/Proposal No. SIA/UP/MIS/205044/2021

SEIAA noted that SEAC has recommended to grant the prior Environmental Clearance to the proposed project. SEIAA gone through file and documents and found that the project proponent has mentioned ETP of 30 KLD shall be installed for treatment of liquid biomedical effluents which will be recycled after treatment but the project proponent has not submitted any details of ETP proposed. SEIAA opined that as liquid biomedical effluent is proposed to be recycled project proponent shall submit details of ETP including the type of treatment, unit capacity and technology.

5. Jaypee International Sports in Sector-25, along Yumuna Expressway in YEIDA, Gautam Buddha Nagar, U.P. File No. 6147/Proposal No. SIA/UP/MIS/203337/2021

SEIAA agreed with the recommendation of the SEAC to correct the plot area of the project as 1000 ha and amend the terms of reference letter dated 08/02/2021. Rest all the contents mentioned in terms of reference letter dated 08/02/2021 shall remain the same.

6. Multi Modal Logistics Hub at Village-Dadri, Kathera, Pali, Palla, Chitehra, Tehsil- Dadri, Gautam Buddha Nagar., M/s DMIC Integrated Industrial Township Ltd. File No. 5995/Proposal No. SIA/UP/MIS/204693/2021





Rest all the contents mentioned in terms of reference letter dated 19/03/2021 shall remain the same.

7. Expansion of Residential Township "Crossing Republik" at Village-Dundahera, NH-24, Bypass, Ghaziabad., M/s Crossings Infrastructure Pvt. Ltd. File No. 1608/Proposal No. SIA/UP/MIS/206414/2021

SEIAA agreed with the recommendation of the SEAC to extend the validity of Environmental Clearance letter dated 12/10/2013 for the period of 03 years i.e. 12/10/2020 to 11/10/2023. Rest all the contents mentioned in Environmental Clearance letter no. 2099/Parya/SEAC/1608/2016/TA(J) dated 12/10/2013 shall remain the same.

8. Expansion of Existing Residential Complex within existing Premises at Plot GH-08A, Tech Zone-IV, Greater Noida., M/s Habitech Infrastructure Pvt. Ltd. File No. 1551/Proposal No. SIA/UP/MIS/207665/2021

SEIAA agreed with the recommendation of the SEAC to direct the project proponent to submit online TOR application under the expansion proposal and to close the above amendment application submitted by the project proponent.

SEIAA agreed with the recommendation of the SEAC to grant environmental clearance to the project along with following specific conditions:-

Expansion of existing molasses based distillery from 100 KLD to 160 KLD (RS/ENA/Ethanol) along with cogeneration of power: 8 MW at Village- Surjipara Hargaon, Sitapur, U.P., Shri Rakesh Tyagi, M/s Avadh Sugar & Energy Ltd., (Hargaon Distillery). File No. 6295/Proposal No. SIA/UP/IND2/210774/2021

SEIAA agreed with the recommendation of the SEAC to grant environmental clearance to the project along with following specific conditions:-

1. As proposed treated waste water should be completely recycled /reused and ZLD should be achieved. Under no circumstances treated waste water shall be discharged to any drain/sewer line/ inland surface water/Nala etc.
2. Directions/suggestions given during public hearing and commitment made by the project proponent should be strictly complied.

SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC. In addition to the conditions imposed by SEAC the SEIAA added following additional specific conditions:-




- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leave trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.

- 4- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.
- 5- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
- 7- Under any circumstances untreated sewage shall not be reused or discharged to municipal sewer line.
- 8- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.




SEIAA gone through the letter of Shri Vijay Sen dated 24.03.2021 and 25.03.2021 regarding transfer of Environmental Clearance to the above project issued vide letter no. 241/Parya(SEAC)/4042/2018 date 16.03.2018. SEIAA gone through file, documents and noted that the Environmental Clearance was issued to Shri Praveen Kumar, Kothi Lala Babu, House no. 169, Purab Tola, Balrampur. SEIAA noted that the previous lease issued to Shri Praveen Kumar vide letter dated 06.01.2018 for a period of 5 years was cancelled vide DM, Sonbhadra order no. 1892/Khanij/2019 dated 01.11.2019 and another LOI was issued to Shri Vijay Sen Master Genie Services Pvt. Ltd Floor-3, Busa Industrial Street SH-Tandel Marg, Mumbai vide letter dated 920/Khanij/2021 dated 18.03.2021. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 241/Parya(SEAC)/4042/2018 date 16.03.2018 from Shri Praveen Kumar, Kothi Lala Babu, House no. 169, Purab Tola, Balrampur to Shri Vijay Sen Master Genie Services Pvt. Ltd

Floor-3, Busa Industrial Street SH-Tandel Marg, Mumbai with the condition that the EC will not be transferred further. Rest all the content of Environmental Clearance letter no. 241/Parya(SEAC)/4042/2018 date 16.03.2018 shall remain same.

Area mentioned in the previous EC is being transferred only. If there is a change in geo-coordinates of the area then EC will be null and void.
