The project proponent shall submit the revised Form-I with approved mining plan duly clarifying the status of mine lease land details.</p> <p>The issue was examined by the SEIAA in its meeting held on 04.10.2017 and Authority noted with the recommendations of the SEAC.</p> <p>A Clarification letter was sought vide dt.16.04.2018 to submit the information.</p> <p>The project proponent submitted the revised Form-1 along with Mining Plan through online on 08.10.2018 stating that status of mine lease land is Patta land. Director of Mines & Geology, Palamaneru vide letter dated 06.01.2018 stated that there in only one mine of lease area 1.0 Ha. However it is noticed that in the mining plan it the proposed is surrounded by another mine lease of 5.10 Ha. and also there are temples adjacent to this proposed lease and this area surrounded by cluster of mines. These details are not mentioned in their letter.

The Committee recommended to defer the case and the project proponent shall submit the KML/Shape File of the Mine lease area covering 10 km radial distance, for further appraisal.

The issue was examined by the SEIAA in its meeting held on 13.11.2018 and Authority noted with recommendation of the SEAC, A.P .

A clarification letter was addressed to the project proponent vide dt 04.12.2018 to submit the KML/Shape File of the Mine lease area covering 10 km radial distance.

The project proponent submitted the information through online on 26.04.2019.

The issue was examined by the SEAC in its meeting held on 22.06.2019. The Committee observed the following:

The representative of project proponent and their consultant M/s. B.S. Envirotech have attended the meeting presented their proposal. The Committee recommended for issue of Standard Terms of Reference (TOR) with public hearing for the proposed mining project for the proposed products : Colour Granite Mine – 5,100 m³ /Annum.

The issue was examined by the SEIAA in its meeting held on 10.07.2019 and Authority noted with recommendation of the SEAC, A.P .

A TOR letter was addressed to the project proponent vide dated 12.08.2019.

The project proponent submitted the application through online on 05.02.2020 seeking for the Environmental Clearance (EC) along with the details of the surrounding mines within 500 mtrs of the proposed mine and submitted the EMP.

The issue was examined by the SEAC in its meeting held 08.03.2020. The Committee observed the following:

The committee noted that the proponent submitted a judgement copy connected to the Writ Petition no.19924 of 2019 and IA no.1 of 2019 the Hon'ble High court having considered the facts in the Writ Petition, directed that "till next date no further action be taken in furtherance of the notice dated 12.8.2019, by the State Level Environment Impact Assessment Authority". Further it is noted that the petitioner sought Writ of Mandamus declaring the Lr.No.SEIAA/CTR/MIN/02/2018/508-871 dated 12.08.2019 issued by Respondent No.2 calling upon the petitioner to prepare EIA report based on standard TOR with public hearing for issuance of EC as illegal, arbitrary and violative of Article 14 and 16 of Constitution of India and set aside the same
