The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: This proposal was deferred in 5.88th meeting of the Authority for personal hearing along with submission of increased provisions for parking as the Authority found the revised parking provisions were inadequate keeping in view the number and category of apartments proposed as well as parking required for visitors coming to the complex.

Based on the comprehensive discussion and revised parking provisions submitted by PP in compliance of the SEIAA order dated 15.9.23, the Authority decided to grant EC to this proposal.

2. Serial No. 2: Proposal was deferred in 5.86th meeting of the Authority for submission of revised DCF Mount Abu and DCF Pali certificate in compliance to ToR issued dated 20.1.23, along with ATR on non-complied conditions of Certified Compliance Report. Now, PP has submitted the required documents vide his letter dated 5.10.23, in which DCF Pali certificate dated 8.9.23 mentions Jawai Leopard CR -1 and CR -2 are at a distance of 5.37 km and 8.20 km, respectively. Hence, PP is required to submit Conservation plan to the concerned DCF office and receipt of submission of the same to the Authority.

The Authority decided to approve EIA/ EMP and grant EC to this proposal as recommended by SEAC subject to deposition of Bank Guarantee of Rs 5,70,000 /-(Refundable) for Remediation Plan and Natural & Community Resource Augmentation Plan & deposition of penalty amount of Rs. 15,11,25/- (Non Refundable) to RSPCB before issue of EC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 3. Serial No. 3, 37, 40: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
- 4. Serial No. 4, 5, 6, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 23, 24, 25, 26, 27, 28, 29, 30, 39: The Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 5. Serial No. 7: The Authority decided to accept the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal subject to submission of receipt of conservation plan already submitted to DFO office. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

- 6. Serial No. 21: The approved Mining plan submitted along with the proposal was valid from 2018-19 to 2022-23. Hence, the Authority decided to defer this proposal for submission of valid and approved mining plan, within 45 days. PP should also provide a clarification on cluster area being different in Public Hearing notice and minutes, from the cluster area as mentioned in cluster certificate and ToR letter issued dated 14.9.20.
- 7. Serial No. 22: The Authority decided to defer this proposal for submission of a revised CSR budget wherein the budget for electricity assurance needs to be incorporated. Secondly, PP needs to indicate and provide budget for community welfare without restricting it to labor welfare measures only. PP shall also submit a copy of approved mining plan along with aforesaid document, within 45 days.
- Serial No. 31: The Authority accepted the recommendation of SEAC and conditions imposed by SEAC and decided to grant ToR to this proposal.
- Serial No. 32, 33, 34, 43: The The Authority accepted the recommendations of SEAC and decided to grant ToR to these proposals.
- 10. Serial No. 35, 36: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals subject to rectification in the clerical mistake encountered in SEAC abstract of both the proposals.
- 11. Serial No. 38: The Authority decided to defer this proposal for verification of the documents submitted from the Mining Department.
- 12. Serial No. 41: The Authority decided to refer back this proposal to SEAC to re-examine its recommendations in light of the Hon'ble Supreme Court orders dated 3.6.22 and 26.4.23 and give its specific recommendations incorporating its views in respect of aforesaid orders. In addition, this proposal also envisages addition of a strip of land for which LoI has been issued on the condition that NOC from the Forest Department may be obtained.

SEAC may ask the PP to submit NOC from DCF of Ramgarh Vishdhari Tiger Reserve. This would also indicate the stand of the Forest Department in light of the aforesaid orders of the Hon'ble Supreme Court. Moreover, since the original EC was issued by DEIAA and SEIAA/ SEAC are required to re-appraise the same, SEAC may also examine the EC issued by DEIAA and give its recommendations accordingly.

13. Serial No. 42: In this proposal, the Mining scheme was valid from 2018-19 to 2022-23. Hence, the Authority decided to defer this proposal for submission of valid and approved Mining scheme, within 45 days.

14. Serial No. 44: SEAC has recommended this proposal for approval of EIA/ EMP and grant of EC along with the amount of Rs. 2,03,000/- in reference to Remediation Plan and Natural & Community Resource Augmentation Plan to be deposited to RSPCB in the form of Bank Guarantee with the penalty amount of Rs.50,900/-(Non Refundable) to RSPCB before issue of EC.

Hence, the Authority decided to approve EIA/ EMP and grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 50,900 /- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 2,03,000 lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

- 15. Serial No. 45, 46: The Authority accepted the recommendation of SEAC and decided to approve the earlier granted EC by DEIAA Nagaur in these proposals.
- 16. Serial No. 47: In this proposal, production has been carried out exceeding the granted capacity of EC. Hence, The Authority decided to grant Transfer EC to this proposal with the condition that the PP concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 17. Serial No. 48, 49: The Authority decided to grant Transfer of EC to these proposals.
