SEIAA gone through the letter of project proponent dated 26.08.2020 regarding method of mining as semi mechanized. SEIAA observed that the above project was taken in its meeting dated 18.05.2020 in which SEIAA noted that in application method and depth of mining is mentioned as manual and less than 2mts. SEIAA opined that EC is not required as per Government order 446/87-7-2020-39 (parya)/2014 TC-1 dated 01/05/2020. However project proponent requested to evaluate it as per mining plan in which semi mechanized soil excavation is mentioned. SEIAA gone through the file and documents and found that in mining plan the excavation method is mentioned as semi mechanised. Hence SEIAA agreed with the recommendation of the SEAC dated 04.03.2020 to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC adding following conditions:-

- If in future during the progressive mining this lease area becomes part of cluster i.e.
 area equal to or more than 5 ha., limited to B-1 category, then additional conditions

15. Proposed of Ordinary Sand Mining Project on River Rapti at Gata No./Khand No./Zone No.- Ra-06, Village-TerhavirKarthariUrfSisai, Tehsil- Campierganj, District- Gorakhpur, U.P., (Leased Area -5.00 ha.). File No.5810/Proposal No. SIA/UP/MIN/171324/2020

SEIAA agreed with the recommendations of the SEAC to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC but the SEIAA replaces the specific conditions regarding a cluster as "If in future during the progressive mining this lease area becomes part of cluster i.e. area equal to or more than 5 ha., limited to B-1 category, then additional conditions based on the EIA conducted by the concerned lease holders shall be imposed and joint EMP shall be implemented. The lease holder shall mandatorily follow all the imposed conditions otherwise it will amount to violation of E.C. conditions. If the certificate related to cluster provided by the competent authority is found false or incorrect then punitive actions as per the law shall be initiated against the authority issuing the cluster certificate". And adding following conditions:-

- 1. The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 before the start of work.
- 2. The mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora fauna etc.

With the permission of the Chairman:-

1. Revision & Expansion of Group Housing "Palm Olympia" at Plot No.-GH-02, Sector-16C, Greater Noida, U.P., M/s Sam India Abhimanyu Housing. File No. 5771/Proposal No.SIA/UP/NCP/ 55779/ 2020

SEIAA noted that the above project was taken in its meeting dated 17.09.2020 in which SEIAA instructed Nodal SEIAA to put up the case along with the earlier/old file since it is a case of revision cum expansion. SEIAA reviewed the case and agreed with the recommendation of SEAC to agree with the request made by the project proponent regarding use of baseline data generated during winter season from December, 2019 to February, 2020 for the preparation of EIA/EMP report.
