Earlier EC has been granted to the project vide letter No. 192 dated 18.02.2021.

The case was considered in 220th meeting of SEAC held on 01.09.2021 and recommended to SEIAA for grant of Environment Clearance with Gold Rating.

The PP has submitted scrutiny fee amounting to Rs. 2,00,000 vide DD No. 519898 dated 27.10.2021 vide letter dated 09.11.2021 received on 11.11.2021 in compliance of

Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

- That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project

Item No.[3] Environment Clearance for Proposed Residential Plotted Colony (under Deen Dayal Jan Awas Yojna Policy 2016) coming up Rect. No. 7, village Gwal Pahari, Tehsil Wazirabad, Gurugram, Haryana by M/s Namdev Construction Pvt. Ltd.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/215820/2021 dated 14.07.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance under Category 8(a) of EIA Notification 14.09.2006.

The case was taken up in **218th Meeting of SEAC held on 30.07.2021**. The PP informed the committee that the project was earlier granted EC dated 28.012.2019 for development of Affordable Group Housing. PP applied for migration of license from Group Housing to plotted colony under Deen Dayal Jan Awas Yojana and fresh LOI has also been obtained vide DTCP memo no. LC-3900-JE(SS)-2021/5381 dated 04.03.2021 and vide memo no. LC-3900-JE (SS)-2021/11573 dated 11.05.2021 and subsequently Layout plan and Zoning plan has been approved. The committee asked PP to get the earlier EC dated 28.01.2019 for Group Housing Project be withdrawn from SEIAA/MoEF&CC before taking up for fresh Environment Clearance.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/66120/2021 dated 24.08.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance under Category 8(b) of EIA Notification 14.09.2006.

The case was considered in **220th meeting of SEAC** held on **01.09.2021** and the land for the project has been licensed by DTCP vides Licence no. 41 of 2010 dated 07- June- 2010 to Ramprastha Estates Pvt. Ltd & others for setting up of Group Housing Colony on land measuring (37. 618 Acre). However, some part, i.e. land admeasuring 2.068 acres and 13.16 acres out of the entire land was de-licensed vide orders dated December 18, 2018 and March 20,2020 respectively and now the total licensed area is 22.344 Acre .The land was further purchased by M/s Ashiana Housing Ltd via Agreement to Sale from M/s Ramprastha Estates Pvt. Ltd. and other landowners. The license & agreements are placed on record.

The total Plot Area of the project will be 90,422.95 m² (22.34 Acre) and the built-up area of the project will be 2, 25,265.23 m². As the total built-up area of the project is greater than 1,50,000 m², the proposed project falls under Activity 8(b), Category B as per schedule of EIA Notification 2006 and its subsequent amendments.

TOR has been granted by SEIAA vide letter no. No. SEIAA(128)/HR/2021/564 Dated 08.07.2021. The case has been taken up in 220th SEAC meeting; same has been appraised & recommended to SEIAA with "Gold ratings".

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 523221 dated 17.11.2021 vide letter dated 17.11.2021 received on 17.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 519911 dated 28.10.2021 vide letter dated 01.11.2021 received on 03.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

Item No.[8] Environment Clearance for Expansion of Affordable Group Housing Colony Project in the Revenue Estate of Village Hayatpur, Sector 89, Gurugram, Haryana by M/S Ramprastha Sare Land Holding Company One Pvt. Ltd. & Others In Collaboration With Signature Global (India)

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/225850/2021 dated 24.08.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance for Expansion under Category 8(a) of EIA Notification 14.09.2006. Earlier EC has been obtained vide letter dated 24.12.2019.

Compliance report issued by HSPCB received vide letter dated 28.09.2021 wherein, it is mentioned in most of the points that project is in construction stage and noted to comply with and no ground water usage, structure stability certificate submitted etc.

The case was considered in 220th & 221st Meeting of SEAC held on 01.09.2021 & 29.09.2021 and the construction status has been submitted by PP & mentioned in MoM of SEAC; approx. 14,100 sqm (28% of 50409.808 sqm) has been constructed at the project site. The case has been appraised recommended to SEIAA for grant of Environment Clearance for Expansion with Gold Rating.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 564707 dated 12.11.2021 vide letter dated 13.11.2021 received on 15.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

- That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project
- That the no. of in-bound & out-bound vehicles (____PCU/Hr.) and the running hours per day (_____) of DG sets considered while undertaking the studies for evaluating the "Incremental Pollution Load" and those are true to best of our knowledge.
- That there would be no decrease in Green Area as stated in "Accorded EC".

Authority decided to agree with the recommendations & appraisal of SEAC to accord "EC for Expansion" to the said project.

Item No.[9] Environment Clearance for Expansion of Existing Sugar Plant from 2200 TCD to 3500 TCD (expandable to 5000 TDD) at village Sheikhpura Jagir, Tehsil & District Karnal, Haryana by M/s Karnal Co-Operative Sugar Mill Ltd.

The Project Proponent submitted the case to the SEIAA vide online Proposal No. SIA/HR/IND2/55031/2020 dated 18.06.2021 as per check list approved by the SEIAA/SEAC for obtaining EC for Expansion under category 5(j) of EIA Notification dated 14.09.2006.

The case was considered in 217th, 220th & 221st Meeting of SEAC held on 19.07.2021, 30.08.2021 & 29.09.2021 and the PP submitted the letter dated 04.09.2021 for the withdrawal of the case as they don't want to go for expansion as mentioned in letter therefore, the case may be send back to SEIAA for further necessary action. The Committee unanimously deliberated the request of PP and Consultant and acceded the request for withdrawal and decided to forward to SEIAA for consideration of withdrawal of the case.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority decided to allow PP to withdraw its application considering the recommendations of SEAC and the application is hereby de-listed.

Item No.[10] Extension of Environmental Clearance Validity of Group Housing Project at Sector-72, District Gurgaon, Haryana by M/s Tata Housing Development Company Ltd, C/o Tata Services Limited.

The project was submitted to obtain extension in validity of Environmental Clearance under Category 8(b) of EIA Notification 14.09.2006. The case has been recommended for "*Approval of ToR under Violation Category*".

PP has obtained "EC" (Letter no. Ref. No. SEIAA/HR/2011/38 dated 19.01.2011) for Plot area 1,46,704.38 m² (36.2515 acres) and Built-up area 3,48,785.83 m².

Building plans were got approved in 2012. The Environment Clearance validity got expired on 19.01.2018.

The PP applied for extension of validity on 20.03.2018 of earlier EC Dated 19.01.2011 (proof of submission enclosed) as per the Notification of MoEF&CC, GoI dated 14.09.2016 stating that the application filed "more than thirty days after the validity period of Environmental Clearance but less than ninety days after such validity period, then, based on the recommendations of the Expert Appraisal Committee or State Level Expert Appraisal

Committee or District Level Expert Appraisal Committee, the delay shall be condoned with the approval of the Minister in charge of Environment, Forest and Climate Change or Chairman, as the case may be".

The project has been granted "OC". The Project Proponent has completed the construction of the project for the plot area 1,46,704.38 m2(36.2515 acre) and the built-up area is 4,01,303.61 m² without having valid environment clearance. The PP requested to consider their project under violation based on the MoEF&CC Office Memorandum dated 09.09.2019.

The letter dated 29.07.2021 written by MS SEIAA to Chairman HSPCB vide which prosecution of violation of MoEF notification dated 14.09.2006 has been recommended under section 15 of EPA Act 1986 for commencing construction of Group Housing project without obtaining prior extension and expansion of EC under EIA Notification dated 14.09.2006.

SEAC has recommended to SEIAA for Grant of **Terms of Reference and additional terms of reference (under violation)** for undertaking EIA and preparation of Environment Management Plan (EMP) subject to the outcome of court cases.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 008145 dated 15.11.2021 vide letter dated 15.11.2021 received on 17.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority decided to approve the Terms of Reference and additional terms of reference (under Violation Category) provided the Project Proponent has applied during the Violation Window Period as per Notification dated 08.03.2018.

Item No.[11] Environment Clearance for Proposed Warehouse building (Non Agro Produce) in the revenue estate of Village Daboda, Farruknagar, Gurugram, Haryana by M/s Honest Warehousing Pvt. Ltd & Others.

The Project was submitted the case to the SEIAA vide online Proposal No. SIA/HR/MIS/222209/2021 dated 16.08.2021 as per check list approved by the SEIAA/SEAC

for obtaining Environmental Clearance under category 8(a) EIA Notification dated 14.09.2006.

The case was considered in 220th & 221st Meeting of SEAC held on 31.08.2021 & 29.09.2021 and the project would be having 6,229.577 m² (15% of Plot area) as Green Area and the same has been appraised & recommended to SEIAA for grant of Environment Clearance with Gold Rating.

The PP has submitted Scrutiny Fee amounting to Rs. 1,00,000 vide DD No. 000545 dated 10.11.2021 vide letter dated 13.11.2021 received on 15.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

- That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project
- That the no. of in-bound & out-bound vehicles (____PCU/Hr.) and the running hours per day (_____) of DG sets considered while undertaking the studies for evaluating the "Incremental Pollution Load" and those are true to best of our knowledge.
- That the proposed/installed DG sets & fuel to be used would be as per NCAP/GRAP
- That no untreated water would be released inside or outside the project or anywhere, waste water would be treated to tertiary level & would be used with the installation of "Dual plumbing".
- That before coming to operation, Project proponent will ensure that all the permissions & connections pertaining to Electricity/water & Sewage discharge are in place.

Authority decided to agree with the recommendations & appraisal of SEAC to accord "EC" to the said project.

Item No.[12] Environment Clearance for Commercial Colony at Village-Nangli Umarpur, Sector-62, Gurugram, Haryana by M/s JMD Limited.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/216487/2021 dated 05.07.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance under Category 8(a) of EIA Notification 14.09.2006.

The case was considered in 217th & 222nd Meeting of SEAC held on 20.07.2021 & 11.10.2021 and the Committee deliberated that as the project has already been granted TOR by SEIAA on dated 07.08.2018 under violation category as per Notification dated 14.03.2017. Presently, the project proponent has again applied for fresh EC to the project inspite of having TOR under violation category. The PP submitted in the reply dated 27.09.2021 to the observation of SEAC raised vide its earlier 217th minutes dated 20.07.2021 that by mistakenly consultant submitted proposal under violation category. The PP also submitted the letter dated 24.09.2021 written to MS SEIAA for granting EC to the said project as they have not constructed more than 20,000 Sqm at the site but Committee deliberated that as the project has already been dealt under violation category after appraisal of their application under the said category, the Project cannot be appraised for fresh EC until the project has valid TOR under violation category. Therefore, the Committee decided unanimously to send case to SEIAA for filing the case in view of existing TOR under violation category and submit EIA/EMP report under violation category as per issued TOR or the PP shall get withdrawal the issued TOR in view of their request dated 24.09.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; after detailed deliberations; the Authority decided to *Refer back this case to SEAC with the directions to re-examine the case after conducting spot inspection by the team comprising of two Members of SEAC and RO, HSPCB, Gurugram and submit the report within two weeks positively. The Authority further directed SEAC to put up the case with clear cut recommendations/proposal based on the visit report to the Authority.*

Item No.[13] ToR for Modernization of Development of Rajiv Gandhi Education City of Haryana Sehari Vikas Pradhikaran (HSVP)Village-Bahalgarh, Tehsil-Rai, District-Sonepat, State-Haryana by Haryana Sehari Vikas Pradhikaran (HSVP).

The Project was submitted to the SEIAA vide Online Proposal No. SIA/HR/NCP/40387/2019 dated 08.11.2019 for approval of ToR under category **8(b) of** EIA Notification 14.09.2006.

Thereafter, the case was considered in 192nd, 209th, 218th & 222nd Meeting of SEAC held on 03.12.2019, 30.01.2021, 29.06.2021 & 11.10.2021 and recommended to SEIAA for approval of TOR with directions to the Project Proponent to prepare EIA Report by using Model Terms of Reference as per MoEF & CC with the additional Terms of Reference. The recommendation of SEAC was considered in the 130th Meeting of SEIAA held on 15.11.2021 and the Authority observed the following:

• Mentioned Capacity of STP seems to be lower than the required.

After due deliberations; the Authority decided to **approve** the **"Terms of Reference"** and directed the Project Proponent to prepare EIA Report by using **Model Terms of Reference as per MoEF & CC** with the **additional Terms of Reference as recommended by SEAC** and observation of SEIAA alongwith submission of Scrutiny Fee in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

Item No.[14] Environment Clearance for VSR Mall (Known as 114 Avenue) (Retail-Cum-Office Complex) at Sector-114, Gurgaon, Haryana by M/s VSR Infratech Pvt. Ltd.

The Project was submitted to the SEIAA, Haryana vide online Proposal No. SIA/HR/MIS/215355/2021 dated 22.07.2021 as per check list approved by the SEIAA/SEAC for amendment in EC under Category 8(a) of EIA Notification 14.09.2006.

Thereafter, the case was considered **218th & 222nd** meeting of SEAC held on **30.07.2021 & 11.10.2021** and the PP presented the case before the Committee and during discussion on the earlier EC dated 28.05.2013 extension of validity of EC, built up area sanctioned in earlier EC and it was found that PP has constructed 45573.778 Sqm instead of 41,429 sqm as sanctioned in EC dated 28.05.2013, it was concluded by the Committee that PP has constructed more area than that sanctioned in the EC letter hence, it is, the clear case of violation of MOEF&CC notification dated 14.09.2006 and the Committee unanimously decided to **recommend to SEIAA for taking action against the PP under the provisions of section 19 of EP Act 1986, being a violation case.**

The recommendation of SEAC was considered in the 130th Meeting of SEIAA held on 15.11.2021 and the Authority decided to issue a "Show-cause notice" to the Project Proponent, stating why not the legal proceedings be initiated under Section 19 of EPA, 1986 for increase in built-up area beyond the specified area in accorded "EC".

Item No.[15] Extension of EC validity for Mining of Boulder, Gravel and Sand Minor Mineral at Mandewala Block/ YNR B-38" village Mandewala, Tehsil Chhachhrauli, District Yamunanagar, Haryana over an area 15.00 Ha with total production capacity of 2,40,000 TPA by M/s Saharanpur Mines Management Services Pvt. Ltd.

The Project Proponent submitted the case to the SEIAA vide online Proposal No. SIA/HR/MIS/217849/2021 on 16.08.2021 for obtaining Extension in EC under category 1(a) EIA Notification dated 14.09.2006.

The case was considered in **222nd meeting of SEAC held on 12.10.2021 and i**t was intimated in the meeting that a complaint regarding the project has been received in the office with the copy marked to the ACS Environment & Climate Change Department and copy endorsed to Chairman HSPCB, Chairman SEIAA, Member Secretary SEIAA, and Chairman SEAC. The complaint was discussed in the Committee wherein issues raised that mining is not being carried out as per approved mining plan and hydal channel tazewal is approximately 150 meters and regarding replenishment study.

After discussion on the complaint it was decided that the case along with complaint dated 04.10.2021 be send back to SEIAA to seek the comments from DG Mining, irrigation and concerned departments.

The recommendation of SEAC was considered in the 130th Meeting of SEIAA held on 15.11.2021 and the Authority decided to seek the comments from DG Mining, Irrigation, Forest and concerned Departments.

Hence, it is decided that the case be sent back to SEAC for getting the project inspected by their members and take a final view after that.

Thereafter, the case was taken up in 217th meeting of SEAC held on 20.07.2021. The discussion was held on the MoEF Notification 18.11.2020 and the decisions of SEIAA in its meeting regarding the projects to be get inspected by the members of SEAC. As per the

orders of SEIAA vide its 128th MOM dated 26.05.2021. A Committee was formed comprising of the following:-

- 1. Sh. R.K. Sapra, Member SEAC
- 2. Sh. Vivek Saxena, Member SEAC

The Committee shall visit the project site and submit the report regarding the status of the project in view of the details as mentioned above within 30 days positively.

Finally, the case was taken up in 222nd meeting held on 12.10.2021 and the Sub-Committee submitted the report which is placed before the committee vide which it is submitted along with affidavit from the Director M/s AAR Housing Pvt. Ltd that land is plain and the boundary wall with a guard room have been constructed at the site to secure the line and after deliberation on status of construction Committee unanimously **decided that the case be again recommended to SEIAA for filing.**

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority decided to agree with the recommendations of SEAC and the application is hereby de-listed.

Item No.[17] Environment Clearance for Affordable Group Housing Colony Project at Village Dharampur, Sector-108, Gurugram, Haryana by M/s Shyam Kripa Infrastructure Pvt. Ltd.

The case was taken up in **217th meeting of SEAC held on 20.07.2021 and t**he discussion was held on the MoEF Notification 18.11.2020 and the decision of SEIAA in its meeting regarding the projects to be get inspected by the members of SEAC. As per the orders of SEIAA vide its 128th MOM dated 26.05.2021. A Committee was formed comprising of the following:-

- 2. Sh. R.K. Sapra, Member SEAC

The Committee shall visit the project site and submit the report regarding the status of the project in view of the details as mentioned above within 30 days positively.

Finally, the case was taken up in 222nd meeting held on 12.10.2021, the subcommittee submitted the report which is placed before the committee vide which it is submitted along with affidavit from the Director M/s Shyam Kripa Infrastructure Pvt. Ltd that land is plain and no construction has been done at the site and after deliberation on status of construction committee unanimously decided that the case be again recommended to SEIAA for filing.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority decided to agree with the recommendations of SEAC and the application is hereby de-listed.

Item No.[2] Environment Clearance for Project "National Institute of Ayurveda, Panchkula" Sector 5D, Shree Mata Mansa Devi Shrine Board Campus, Panchkula, Haryana by M/s National Institute of Ayurveda.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/199240/2021 dated 03.06.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance under Category 8 (a) of EIA Notification 14.09.2006. The project will establish an indispensable health infrastructure required for providing support for ensuring health, well-being and cure for various diseases.

It will comprise of 250 bedded Hospital Block and Service Block, Auditorium, Academic Block, Guest House, UG Double Occupancy Hostel (Male & Female), PG Single Occupancy Hostel (Male & Female), International Single Occupancy Hostel, Type II, III, IV and V Quarters, Director's Bungalow, Shops etc.

The project will comprise of all the laboratories and health monitoring services like central laboratory, CT scan & MRI, Ultrasound & X -ray room, OTs & wards. The project will also include services and facilities such as kitchen, laundry, lift, demo room, students' room and doctors' room, audio/video visual room, private wards, doctor's lounge, preparation & sterilization room, seminar room, administration hall and chambers for consultant physicians.

The case was considered in 218th, 222nd & 223rd meeting of SEAC held on 30.07.2021, 11.10.2021 & 21.10.2021 and recommended to SEIAA for grant of Environment Clearance with Gold Rating.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 16.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

• That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project

- That the no. of in-bound & out-bound vehicles (____PCU/Hr.) and the running hours per day (____) of DG sets considered while undertaking the studies for evaluating the "Incremental Pollution Load" and those are true to best of our knowledge.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/63763/2020 dated 28.06.2021 as per check list approved by the SEIAA/SEAC for obtaining Environmental Clearance under Category 8(b) of EIA Notification dated 14.09.2006. The TOR was granted vide SEIAA letter NO. SEIAA(127)/HR/2021/290 dated 12.04.2021.

The case was considered in 217th, 219th, 222nd & 223rd meeting of SEAC held on 19.07.2021, 13.08.2021, 12.10.2021 & 21.10.2021 and recommended to SEIAA for grant of Environment Clearance with Gold Rating.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 004429 dated 11.11.2021 vide letter dated 12.11.2021 received on 12.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 16.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

- That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project
- That the no. of in-bound & out-bound vehicles (____PCU/Hr.) and the running hours per day (_____) of DG sets considered while undertaking the studies for evaluating the "Incremental Pollution Load" and those are true to best of our knowledge.
- That the proposed/installed DG sets & fuel to be used would be as per NCAP/GRAP
- That no untreated water would be released inside or outside the project or anywhere, waste water would be treated to tertiary level & would be used with the installation of "Dual plumbing and project would achieve "Zero Liquid Discharge" by installing all the necessary equipment.

Authority decided to agree with the recommendations & appraisal of SEAC to accord "EC" to the said project.

Item No.[4] Environment Clearance for Development of Multi Level Car Parking Project at Kaman Sarai, Adarsh Nagar, Sector 12, Ward No. 18, Gurugram, Haryana by M/s Municipal Corporation Gurugram.

The Project was submitted to the SEIAA, Haryana vide online Proposal No. SIA/HR/MIS/121102/2019 dated 27.07.2020 for obtaining Environmental Clearance under Category 8(a) of EIA Notification 14.09.2006.

The case was considered in 203rd, 212th, 215th, 218th, 222nd & 223rd meeting of SEAC held on 14.10.2021, 25.03.2021, 17.06.2021, 29.07.2021, 11.10.2021 & 21.10.2021 and recommended to SEIAA for grant of Environment Clearance with Gold Rating.

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 16.11.2021; the Authority asked to Project Proponent as well as his consultant to furnish the following under the oath in form of an affidavit:

- That adequate studies have been carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of the project due to the said expansion of the project
- That the no. of in-bound & out-bound vehicles (____PCU/Hr.) and the running hours per day (_____) of DG sets considered while undertaking the studies for evaluating the "Incremental Pollution Load" and those are true to best of our knowledge.
- That the proposed/installed DG sets & fuel to be used would be as per NCAP/GRAP
- That no untreated water would be released inside or outside the project or anywhere, waste water would be treated to tertiary level & would be used with the installation of "Dual plumbing and project would achieve "Zero Liquid Discharge" by installing all the necessary equipment.
- That before coming to operation, Project proponent will ensure that all the permissions & connections pertaining to Electricity/water & Sewage discharge are in place.

Authority decided to agree with the recommendations & appraisal of SEAC to accord "EC" to the said project subject to submission of Scrutiny Fee in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

Item No.[5] Environment Clearance for Group Housing Colony project at Sector-82 A, Gurgaon, Haryana by M/s Vatika Ltd.

- The SEAC recommended this case for grant of EC vide its 150th meeting held on 07.04.2017. The recommendation of SEAC was considered in 102nd meeting of SEIAA held on 20.04.2017 and referred back to SEAC to verify the status of Construction.
- 2. SEAC again considered this case in its 153rd meeting and constituted a subcommittee comprising of Sh Hitender Singh, Member SEAC and Sh A.K. Bhatia, Member SEAC. The committee inspected the site on 02.06.2018 and submitted its report on 05.06.2018 with conclusion that *"it is established that construction has been raised at site prior to grant of Environmental Clearance. Appropriate action as per law may be taken."*
- 3. The report of the sub-committee was read out in 170th meeting of SEAC held on 07.06.2018 and it was decided to place the matter in 172nd meeting of SEAC.
- 4. Again the matter was considered in 172nd meeting of SEAC held on 03.07.2018 and the matter was discussed on the status of construction along with the judgement of

Hon'ble High Court of Bombay (CP-132 to 135) and recommended to SEIAA for taking necessary action.

- 5. The Recommendation of SEAC was considered in 115th meeting of SEIAA held on 25.07.2018 and it was decided to issue show-cause Notice to the project proponent.
- 6. The Project Proponent submitted his reply vide letter dated 13.08.2018 received on 16.08.2018 which was not considered due to lapse of term of SEIAA/SEAC on 20.08.2018.
- 7. After Constitution of SEIAA on 30.01.2019, the reply of the project proponent was put up to W/Chairman, SEIAA and it was directed to the project proponent to appear in person to explain.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority observed that the Committee comprising of SEAC Members has reported on 05.06.2018, "It is established that the construction has been raised at site prior to grant of Environmental Clearance. Appropriate action as per law may be taken". The Project Proponent has been afforded his personal appearance or through his representative on 30.01.2019.

It is found that adequate opportunity to present view point were afforded to the PP but on one or other pretext PP dragged the ongoing proceeding due to reason best known to him.

Accordingly, Authority decided to constitute a Committee comprising of Dr. Punit Ghai, Member SEIAA (Head of the Committee), Sh. Vinay Gautam, Joint Director (Technical), SEIAA and Sh. Ajay Choudhary, Assistant District Attorney, SEIAA to examine all aspects for the said project and will submit the report within 2 days.

The Committee submitted its report on 17.11.2021 with the recommendations that appropriate action may be initiated against the PP within the scope of relevant laws as PP has violated the provision of EIA Notification dated 14.09.2006.

After detailed deliberations & report of the Committee, the Authority decided to initiate legal action for violating the norms of EIA Notification dated 14.09.2006, however, before proceeding further a final notice / opportunity be given to PP to present his view point.

Item No.[6] Environment Clearance for proposed Institutional Project "Prannath Parnami University" located at Chaudhariwas, Hisar, Haryana by M/s Shree Prannath Parnami Education Society.

- 1. The Project was considered in 145th meeting of SEAC held on 30.11.2016 and recommended to SEIAA for de-listing as the PP was failed to comply the observations within a period of six months.
- The recommendation of SEAC was considered by SEIAA on 19.01.2017 and it was decided to constitute a sub-committee comprising of Sh. Hitender Singh and Dr. S.N. Mishra, Members SEAC.
- 3. Thereafter, no such report has been received till date from the Sub-Committee.
- *4.* Thereafter, the case was again taken up in 117th meeting of SEIAA held on 18.04.2019 and it was decided that *Chairman, SEIAA would take the final view at his own level.*
- **5.** A show-cause Notice was served to the project Proponent but the PP has failed to submit his reply.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to ask RO, HSPCB, Hisar to conduct a spot inspection and submit the report at the earliest possible and defer this case to the next meeting.

Item No.[7] Environment Clearance for proposed Common Bio-Medical Waste Treatment Facility (CBWTF), at Plot no. 66, Roz Ka Meo Industrial area, Sohna, Mewat, Haryana by M/s Synergy Waste Management Pvt. Ltd.

- 1. The case was considered by SEAC in its 160th meeting held on 06.11.2017 and referred back to SEIAA for further necessary action in view of the directions issued by CPCB vide letter dated 03.11.2017 wherein it was directed that SEAC and HSPCB should adhere to the CPCB guidelines of CBWTFs while permitting new establishment. A new CBWTF in Mewat area shall not be permitted if Mewat area is already covered by the existing CBMWTFs.
- The case was again considered in 165th of SEAC held on 14.03.2018 and decided to refer back this case to SEIAA with a decision that case cannot be considered for appraisal.

- 3. Again the case was considered by SEAC in its 190th meeting held on 22.10.2019 and recommended for grant of EC.
- The recommendation of SEAC was considered in 121st meeting of SEIAA held on 25.11.2019 and decided to defer this case for want of information (Gap analysis Report).

Observation

- CWP No. 13204 of 2021 titled as Synergy Waste Management Pvt. Ltd Versus SEIAA & Anr was also filed before Hon'ble High Court of Punjab and Haryana. Hon'ble High Court vide order dated 20.07.2021 disposed of this petition with a direction to the respondent-authorities to consider and decide the representation dated 02.02.2021 preferable within a period of four weeks."
- 2. It was decided to direct the project proponent to appear in person along with the relevant documents. The project proponent intimated that he has already requested to Member Secretary HSPCB to issue Gap Analysis Report, in the meanwhile a letter from the Office of Member Secretary, HSPCB received by stating therein *that PGIMER Chandigarh has conducted its study and has submitted the preliminary interim report to HSPCB with the conclusion that presently, the existing CBWTFs have enough capacity to handle the BMW Generated even for the upcoming years and hence there is no need to install new CBWTF or no need to increase the capacity of any CBWTF as they have enough capacity with respect to current generation of Bio Medical Waste. However, the final report on the same is yet to be received and considering the COIVD 19 lockdown and its resultant impact on the study, PGIMER has sought more time to conclude the study, as demanded by HSPCB with a projected period of next 01 years especially in terms of incineration, with specific reference to their capacity and scope for handling the projected waste generation.*

The PP has submitted his request vide letter dated 10.11.2021 received on 12.11.2021 to defer his case next meeting as Gap Analysis Report is awaited with HSPCB.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to finally ask the Project Proponent to appear in person to represent their case.

Item No.[8] Extension of validity of Environmental Clearance for proposed construction of Township Project "Parsvnath City, Dharuhera" at Sector 1, 1 B & 2B, near Village Kharkhera, Distt. Rewari, Haryana by M/s Parsvnath Developers Ltd.

- The case was considered in 203rd meeting of SEAC held on 16.10.2020 and referred to SEIAA for taking legal action under the relevant provisions of the Act for violation of EIA Notification
- 2. The recommendation of SEAC was considered in 126th Meeting of SEIAA held on 11.12.2020 and a show-cause notice was issued. The project proponent submitted his reply vide letter dated 21.01.2021 which was considered in 127th meeting of SEIAA held on 17.03.2021 and it was decided to agree with the recommendation of SEAC and de-listed the project.
- The authority further decided to constitute a sub-committee comprising of Dr. S.N. Mishra and Dr. Mehar Chand, Members, SEAC for spot Inspection and to submit their report on current status of the project.
- 4. Report is still awaited.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to ask RO, HSPCB, Dharuhera to conduct a spot inspection and submit the report at the earliest possible and defer this case to the next meeting.

Item No.[9] Environment Clearance for expansion for proposed Warehouse (for storage of commercial goods) on area measuring 86109.916 sqmt at Village Binola, Tehsil-Manesar, District-Gurgaon, Haryana by M/s Integra Urban Infrastructure Private limited.

- 1. The project was submitted on 27.07.2018 and was taken up in 175th meeting of SEAC held on 14.08.2018 and was deferred on the request of PP. Thereafter, the case was transferred to MoEF & CC, as the term of the Authority was lapsed.
- 2. Thereafter the case was taken up in 207th meeting held on 17.12.2020 and SEAC deliberated decided that PP has constructed the area more than the area granted in the EC letter which is a violation of EIA Notification 14.09.2006 and recommended SEIAA to take action under EP, Act, 1986.

- 3. The recommendation of SEAC was considered in 127th meeting of SEIAA held on 17.03.2021 decided to defer this case.
- 4. The case was again taken up in 128th meeting of SEIAA held on 26.05.2021 and it was decided to issue Show-Cause Notice to the Project Proponent.
- 5. The project proponent submitted his reply and intimated that this project has already been applied under violation category vide proposal No. SIA/HR/MIS/212461/2021 which is already under consideration of SEAC in its 219th meeting held on 13.08.2021 which was already considered by SEIAA in 129th meeting of SEIAA and referred back to SEAC.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority observed that the Project Proponent has not applied during the Violation Window Period provided as per Violation Notification dated 14.03.2017 & 08.03.2018. Therefore, the Authority decided to issue a "Show-cause notice" to the Project Proponent, stating why not the legal proceedings be initiated under Section 19 of EPA, 1986.

Item No.[10] Environment Clearance for proposed 03 MLD Common Effluent Treatment Plan (CETP) HSIIDC, Industrial Estate, Village Kutana, Tehsil Rohtak, Haryana by M/s HSIIDC, Site Office, I.M.T. Rohtak, (Near Village Kheri Shad), Haryana.

- The case was considered in 157th meeting held on 30.08.2017 for Approval of terms of Reference. The TOR has been granted to the project on 08.11.2017. Thereafter, the PP submitted the EIA/EMP report on 14.12.2020.
- The EIA/EMP report was considered in 209th meeting of SEAC Haryana held on 29.01.2021 and observed that CETP has already been constructed without taking prior EC and recommended to SEIAA for taking Action under Section 15 of EP, Act, 1986.
- 3. The recommendation of SEAC was considered by SEIAA in its 127th meeting held on 17.03.2021 and it was decided to issue show-cause notice to the PP.
- 4. Reply of Show-cause Notice was not received.
- 5. The matter was again taken up in 128th meeting of SEIAA held on 26.05.2021 and it was decided to defer this case till next meeting in order to have deeper look at the facts of the case.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to ask RO, HSPCB, Bahadurgarh to conduct a spot inspection and send the visit report at the earliest possible. Authority further asked the PP to make the presentation before the Authority to understand the case.

Item No.[11] ToR for ''Remediation and Reclamation of Existing Dumpsite and construction, operation and maintenance of Sanitary Landfill at Village Khurana Kaithal Dumpsite Haryana by M/s Municipal Council of Kaithal, old city, Kaithal, Haryana.

- 1. The case was considered in 211th Meeting of SEAC held on 26.02.2021 and the committee after detailed deliberation decided to recommend to SEIAA for taking appropriate action under EP Act as the project has not obtained EC under the provision of EIA notification dated 14.09.2006.
- 2. The recommendation of SEAC was considered by SEIAA in its 128th meeting held on 26.05.2021 and it was decided to constitute a sub-committee comprising of Sh. Vijay Kumar Gupta, Chairman, SEAC and Sh. Hitender singh, Member SEAC for spot inspection and submit their report on current status of the Project.
- 3. Site inspection report is still awaited.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to refer back the case to SEAC and stated that the case may be taken up as per mandate if it has been applied within the Violation Window period alongwith recommendations on the basis of site inspection report.

Item No.[12] Terms of Reference to the Proposed Development of Industrial Estate (Phase-II) at Sector - 30, 30-A, 31 & 32 at Manakpur, Jagadhri Haryana by M/s HSIIDC.

- 1. The case was considered in 212th meeting of SEAC held on 25.03.2021 and observed that this is a case of violation as the construction activities has already been started without obtaining EC and recommended to SEIAA for taking legal Action under EP, Act, 1986 under section 19.
- The recommendation of SEAC was considered by SEIAA in its 128th meeting held on 26.05.2021 and it was decided to issue show-cause Notice to the Project Proponent.

3. The Project Proponent submitted his reply and requested to consider this case under violation category.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority decided to refer back the case to SEAC and stated that the case may be taken up as per mandate if it has been applied within the Violation Window period.

Item No.[13] ToR for proposed project for Manufacturing of Formaldehyde 40 M.T. per day at village Bhagwanpur, Kharwan Road, Tehsil Jagadhri, Yamuna Nagar, Haryana by M/s Chemwood Industries.

- The case was considered in 212th Meeting of SEAC held on 26.03.2021 and recommended to SEIAA for taking action against the PP under the provisions of section 19 of EP Act being a violation case.
- The recommendation of SEAC was considered by SEIAA in its 128th meeting held on 26.05.2021 and it was decided to issue show-cause notice to the Project Proponent.
- The Project Proponent submitted his reply by stating therein that he has started construction after obtaining CTE from HSPCB vide letter No. 313282118YAMCTE5784449 dated 20.12.2018.
- 4. The Proposal was submitted to SEIAA for manufacturing of 40 TPD Formaldehyde but later they have planned to establish unit for 100 TPD and applied Proposal to MoEF & CC under Violation Category vide Proposal No. IA/HR/IND3/204922/2021 dated 20.03.2021 for which Terms of Reference letter was issued vide F. No. IA-J-11011/108/221-IA-II (I) dated 20.07.2021.

The matter was placed before the 130th Meeting of SEIAA, Haryana held on 16.11.2021 and the Authority observed that the PP has obtained Terms of Reference letter from MOEF & CC, GOI, issued vide F. No. IA-J-11011/108/221-IA-II (I) dated 20.07.2021. No further action is required by SEIAA at this movement and decided to de-list the case.

Item No.[14] Environment Clearance for Revision and Expansion of Commercial Complex Project located at Village Pawal Khusurpur, Sector 109, Gurugram Manesar Urban Complex, Haryana by M/s Ish Realtors Pvt. Ltd.

The case was considered in 212th meeting of SEAC held on 26.03.2021 and recommended to SEIAA for grant of EC for Revision and Expansion of Commercial Complex Project.

The recommendation of SEAC was considered in 128th meeting of SEIAA held on 26/05/2021 through "VC" and the Authority directed the project proponent explain the followings:

- PP should submit an affidavit under oath that neither any investor has invested in project nor any part of project has been sold to anyone on the basis of previous "EC" mentioning the Green Area 26%
- Waste water generation is 111KLD, category of Industry & Pollution index of city in which project is located to be verified by SSA. On that basis decrease in Green Area may be allowed
- PP has to submit the RO visit report & compliance report to SEIAA
- Water requirement is reduced & capacity of STP is reduced, SSA to verify the increase or decrease in population
- 150 KLD of treated water for HVAC cooling, 100% will not be lost, scheme, equipment & plan for treating the residual water & how to handle the rejects?
- PP must achieve "Zero Liquid Discharge" being a commercial project, plan for the same should be submitted & affidavit in this regard.

After due deliberations; the Authority decided to agree with the Appraisal & Recommendation of SEAC to grant "Environment Clearance for Revision and Expansion" to the project subject to satisfactory reply of the raised observations and on submission of asked documents as well as Affidavits.

The case was again considered in 130th Meeting of SEIAA held on 16.11.2021 and Authority after due deliberations arrived at the conclusion, that "it will not be prudent to set such trends where PP in the initial stages agrees to observe certain green area and subsequently make the case for reduction/down sizing the same green area for gainful motives under the garb of revision/modification/modernization/expansion route. This appears to be unreasonable proposal. Therefore, the Authority disagrees with the proposal of Project Proponent and recommendations of SEAC, however, Authority considers Revision & Expansion to the extent where the Green Area will not be curtailed and reduced in any way from the original allocated Green Area.

After detailed deliberations; the Authority decided to accord EC for "Revision and Expansion" to the Project to the extent the Green Area is kept at the level of earlier accorded EC subject to submission of Scrutiny Fee in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

Item No.[15] Environment Clearance for Expansion of Group Housing Colony Sector at Sector 32, Village Dhunela, Tehsil Sohna, District Gurgaon, Haryana by M/s St. Patricks Realty Pvt. Ltd.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/187424/2020 dated 07.04.2021 for obtaining Environmental Clearance under Category 8(a) of EIA Notification 14.09.2006.

The case was considered in **213th meeting of SEAC** held on 19.04.2021 and recommended to SEIAA for grant of EC.

The recommendation of SEAC was considered in 128th meeting of SEIAA held on 26.05.2021 and the following queries were raised:

- 1. Plot area is not increasing and Ground Coverage is being increased.
- 2. Power back-up in "Existing" is shown to be 4 X 1500 kVA + 1 X 500 kVA= 6050 KVA & after expansion shown to be 3 X 1010 kVA + 3 X 500 kVA = 4530 KVA, is it so?
- **3.** Type of APCM proposed, DG sets & fuel to be as per GRAP/NCAP. Affidavit in this regard

After due deliberations; Authority decided to agree with the Appraisal & Recommendation of SEAC to grant "Environment Clearance" to the project subject to satisfactory reply of the queries raised & submission of asked documents as well as Affidavits.

Authority again considered the case in 129th meeting dated 14.10.2021 & Authority asked the project proponent to submit the above documents at the earliest possible so that "EC" could be processed.

The case was again considered in 130th Meeting of SEIAA held on 16.11.2021 and after detailed deliberation; the Authority asked the PP to submit in affidavit mentioning that the Green Area is neither being decreased nor being changed and will be kept as per the accorded EC.

After detailed deliberations; the Authority decided to agree with the recommendation of SEAC to accord EC for "Expansion" subject to the conditions that the PP will continue to maintain the size of the Green Area as per the accorded EC alongwith submission of Scrutiny Fee in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

Item No. [16] EC for Expansion of Group Housing Colony area measuring 13.2118 acres in Sector 68 (HD Zone), Gurgaon, Manesar Urban Complex by M/s Hans Propcon Pvt. Ltd.

The Project was submitted to the SEIAA vide online Proposal No. SIA/HR/MIS/62566/2014 dated 12.04.2021 for obtaining Environmental Clearance Group Housing Colony area measuring 13.2118 acres in Sector 68 (HD Zone), Gurgaon, Manesar Urban Complex by M/s Hans Propon Pvt. Ltd. The project falls under Item 8(b) with built up area more than 1,50,000 sqm (Township and Area Development projects) of the Environmental Impact Assessment (EIA) Notification dated September 14, 2006. The Project has already been granted Environment Clearance vide letter No. SEIAA/HR/2016/650 dated 17.08.2016

ToR has been issued by SEIAA, Haryana vide letter no. SEIAA/HR/2020/366 dated 08.02.2021. Earlier Environment clearance was granted vide letter no SEIAA/HR/2016/650 dated 17.08.2016.

The case was considered in **213th meeting of SEAC** held on 19.04.2021 and recommended to SEIAA for grant of EC for Expansion.

The recommendation of SEAC was considered in 128th meeting of SEIAA held on 26/05/2021 through "VC" and Authority directed to the project Proponent to explain the following in next 15 days

• Capacity of STP to be at least 1.25 times of quantity of Waste water generated.

- PP should submit an affidavit stating that no construction would be carried out under 220 KVA line and area would be left as "Buffer Zone" on both sides of the 220 KVA as per the regulations
- Power back up 4500 KVA, no capacity of proposed DG sets is mentioned

Authority further asked the PP to submit the following in Affidavit:

- Affidavit regarding the studies carried out to ascertain that there would not be any obstruction or impediment in general traffic in vicinity of project due to the proposed Expansion of the said Project
- Affidavit regarding the no. of in-bound & out-bound vehicles (PCU/Hr.) and the running hours per day of DG sets considered while undertaking the studies for "Incremental Pollution Load"/"Air Dispersion Modelling".

After due deliberations; the Authority asked the Project Proponent to submit reply to the raised queries in the next 15 days and decided to defer the case till next meeting.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 000212 dated 10.11.2021 vide letter dated 10.11.2021 received on 12.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021.

The case was again considered in 130th Meeting of SEIAA held on 16.11.2021 and after detailed deliberation; the Authority observed that the Project Proponent has submitted the asked documents dated 28.07.2021 and decided to agree with the recommendation of SEAC to accord EC for Expansion to the Project.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 079218 dated 30.10.2021 vide letter dated 30.10.2021 received on 02.11.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021

The recommendation of SEAC was taken up in the 130th meeting of SEIAA held on 15.11.2021; the Authority decided to refer back the case to SEAC for clear cut recommendations & appraisal of the case.

Item No.[34] Regarding Terms of Reference (ToR) for carrying out EIA studies of the Common Bio-Medical Waste Treatment Facility (CBWTF) located at Khevat No. 128, Khatoni No. 150, Rakba –69 canal –19 Rale, Village –Kandela, Tehsil & District –Jind (Haryana by Divya Waste Management Company, Village & Post- Kandela, Tehsil & District- Jind, Haryana by M/s Divya Waste Management Company.

The recommendation of SEAC was considered in 126th meeting of SEIAA held on 11.12.2020; the Authority decided to agree with the recommendation of SEAC. Accordingly, a letter was written to Regional Office, MoEF& CC, GoI, Chandigarh to conduct site visit of the Project but no response has been received so far.

The matter was taken up in 127th meeting of SEIAA held on 17.03.2021; after deliberations the Authority decided that reminder letter should be written to Regional Office, MOEF & CC, GOI, Chandigarh by Member Secretary, SEIAA on behalf of Authority for expediting the Report.

The case was again considered in the 128th Meeting of SEIAA held on 26.05.2021 and after going through the communication from MOEF & CC, GOI OM dated 18.11.2020; so, it has been revealed that guidelines of EAC at Ministry Level. Hence, it is decided that the case be sent back to SEAC for getting the project inspected by their members and take a final view after that.

Thereafter, the case was taken up in 217th meeting of SEAC held on 20.07.2021.The discussion was held on the MoEF& CC Notification 18.11.2020 and the decision of SEIAA in its meeting regarding the projects to be get inspected by the members of SEAC. As per the orders of SEIAA vide its 128th MOM dated 26.05.2021. A Committee was formed comprising of the following:-

- 1. Sh. S.K. Mehta, Member SEAC
- 2. Sh. Mehar Chand, Member SEAC

The Committee shall visit the project site and submit the report regarding the status of the project in view of the details as mentioned above within 30 days positively.

The subcommittee submitted the report dated 21.10.2021 and thereafter the case was taken up in 224th meeting and the report of subcommittee was placed before the committee. It is mentioned in the report of sub-committee that the paddy crop has been grown at the designated project site. A boundary wall existed at the site which seems to be more than 10 years old. However, a small office like structure seems to have been raised after that. The Affidavit dated 27.08.2021 of sh. Ishwar Singh s/o sh. Sum Ram is also attached with

the report mentioning that

- He is the owner of Divya waste management company.
- That they have surrendered the Lease of land obtained from Sh. Satbir.

The committee considered the report of subcommittee and **decided to recommend to SEIAA for delisting the said case in view of above report of subcommittee.**

The matter was considered in the **130th Meeting of SEIAA held on 17.11.2021 and it was observed that the** Project proponent submitted his application for seeking environment clearance for establishing Common Bio Medical Waste Treatment Facility and the same was lastly considered by SEAC in its 224th meeting held on 29.10.2021 and recommended to SEIAA for de-listing in view of joint committee report constituted by SEAC as well as Affidavit submitted by the owner of the project "they have surrendered the lease of land".

After detailed deliberation; the Authority decided to agree with the recommendations of SEAC and the application is hereby de-listed.

Item No.[35] ToR for setting up Integrated Paint Manufacturing Unit in Plot No. 48 to 62 (both plots inclusive), HSIIDC Industrial Estate Panipat, Village Dadlana, Tehsil and Dist. Panipat, State Haryana by M/s Grasim Industries.

The Project Proponent submitted the case to the SEIAA vide online Proposal No. SIA/HR/IND3/68324/2021 dated 22.10.2021 as per check list approved by the SEIAA/SEAC for obtaining TOR under category 5(h) of EIA Notification dated 14.09.2006.

Thereafter, the case was considered in 224th Meeting of SEAC held on 29.10.2021 and recommended to SEIAA for approval of TOR with directions to the Project Proponent to prepare EIA Report by using Model Terms of Reference as per MoEF & CC with the additional Terms of Reference.

The PP has submitted Scrutiny Fee amounting to Rs. 2,00,000 vide DD No. 003609 dated 25.10.2021 vide letter dated 25.10.2021 received on 26.10.2021 in compliance of Haryana Government, Environment & Climate Change Department Notification No. DE&CCH/3060 dated 14.10.2021

The recommendation of SEAC was considered in the 130th Meeting of SEIAA held on 15.11.2021 and after due deliberations; the Authority decided to approve the "Terms of Reference" and directed the Project Proponent to prepare EIA Report by using Model Terms of Reference as per MoEF & CC with the additional Terms of Reference as recommended by SEAC.

Item No.[36] Request for clarify the Built Up Area of the Project Affordable Group Housing Colony measuring 11.262 Acre at Sector-67, Gurgaon, Haryana by M/s DSS Infra Structure Pvt. Ltd.

The PP has submitted the application for clarification in Built Up Area of the Project Affordable Group Housing Colony measuring 11.262 Acre at Sector-67, Gurgaon, Haryana.

The matter was considered in the 130th Meeting of SEIAA held on 17.11.2021 and it was observed that as per the current guidelines issued vide letter F.No 22-37/2018-IA.III dated 19.04.2021 by MOEF & CC, GOI, all proposals are to be received online.

After due deliberations; Authority deem it appropriate to ask PP to apply online through PARIVESH Web Portal alongwith requisite documents so that necessary action can be taken.
