4. **Grant of EC**

The Authority after detailed discussion and deliberation decided the following:-

1. **Serial No. 01:** The Authority decided to defer the proposal for submission of the following requisite documents/clarifications:

a. The Hon'ble Supreme Court of India, vide its order dated 29.12.2025 in Suo Moto Writ Petition (Civil) No. 10/2025 (In Re: Definition of Aravalli Hills and Ranges and ancillary issues), has directed that -
"until further orders, no permission shall be granted for mining, whether it is for new mining leases or renewal of old mining leases, in the 'Aravalli Hills and Ranges' as defined in the FSI


Report dated 25.08.2010 without prior permission from this Court."

In view of the above direction and with reference to the FSI Report dated 25.08.2010, the PP is required to submit a revised Aravalli Certificate issued by the competent authority, clearly indicating the status of the project site with respect to the Aravalli Hills and Ranges in compliance with the aforesaid order.

- b. Approximately 10-15 trees are located within the lease area, therefore, prior permission for felling of trees due to mining activities is required from the competent authority, along with submission of a detailed replantation/compensatory plantation plan.
- c. The list of Schedule-I species has been prepared in accordance with the Wildlife (Protection) Act, 1972 instead of Wildlife (Protection) Amendment Act, 2022. Therefore, list of flora/fauna found specifically in the study area duly authenticated by local DCF as per Wildlife (Protection) Amendment Act, 2022 and accordingly draft of Wildlife Conservation Plan covering all Schedule-I species as per the Wildlife (Protection) Amendment Act, 2022, with adequate budgetary provisions in accordance with CWLW Order F.No.()WCP/CWLW/2019/6451-6463 dated 25.05.2019, along with the receipt of submission to the CWLW, in compliance with SEIAA Office Order No. F(8)Gen/SEIAA/Env./2024/1361 dated 03.11.2025, shall be submitted.
- d. Production Certificate from inception of mining lease to FY 2024-25 duly certified by Mining Department.
- e. Duly signed copy of Annexure-C.
- f. A copy of the mining plan has been submitted to IBM through email, but the registration slip issued by IBM has not been submitted. Proof of registration with the Indian Bureau of Mines under the provisions of Rule 45(1) of the MCDR 2017, in compliance of Ministry of Mines, GoI order dated 01.05.2025, is required to be submitted.

g. The PP has not proposed the mandatory 7.5-meter safety barrier within the mining lease area, thereby, defeating the purpose of pollution control and environmental mitigation measures as prescribed under the applicable environmental norms and conditions.
