


**Minutes of the 94<sup>th</sup> meeting of State level Environment Impact Assessment Authority, Jharkhand held on 13<sup>th</sup>, 14<sup>th</sup> & 15<sup>th</sup> April, 2022.**

The 94<sup>th</sup> meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 13<sup>th</sup>, 14<sup>th</sup> & 15<sup>th</sup> April, 2022 in the office of SEIAA, Ranchi under the chairmanship of Shri S.E.H. **The SEAC has scrutinized the above projects in the light of Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018. and SEAC has made unanimous recommendations for grant of Environmental Clearance of above mentioned project proposals. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearance to the above mentioned project proposals subject to Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and the directions issued by vide MoEF & CC, OM dated – 12.12.2018 which are given below:**

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.

- b. Form-IM be made more comprehensive for areas of 0 to 5 Ha by dispensing with the requirement for public consultation to be evaluated by SEAC for recommendation of grant of EC by SEIAA instead of DEIAA/DEAC.
- c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.
- d. EIA and/or EMP be prepared for the entire cluster in terms of recommendations 5 (supra) of the guidelines for the purpose of recommendations 6, 7 and 8 thereof.
- e. Revise the procedure to also incorporate procedure with respect to annual rate of replenishment and time frame for replenishment after mining closure in an area.
- f. The MoEF & CC to prepare guidelines for calculation of the cost of restitution of damage caused to mined- out areas along with the Net present value of Ecological services forgone because of illegal or unscientific mining.

**SEAC has made unanimous recommendations for grant of Environmental Clearance. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearance to the above mentioned project proposals with minor correction with regard to details given in NOC issued by Airport Authority of India and the conditions recommended by SEAC alongwith the following specific additional conditions:-**

- a. Environment management system to be drawn to ensure compliance of EC conditions stipulated based on principles of Continual Improvement and periodical management review.
- b. Rooftop rain water harvesting to ensure 100% Recharge/Use of rainfall. Storm water runoff to be collected in collection chamber /settling pond and maximise its use.
- c. All raw material to be stored only under covered shed.
- d. PAs to ensure ZERO DISCHARGE for its process discharges.

- e. PAs to offset (>20%) consumption of conventional energy sources by promoting use of solar energy, passive energy utilization, optimum fenestration, shading effect and heat islands.
- f. Green belt and Green cover to be implemented as provided in layout plan.

- a. Green belt should be developed & maintained in not less than 15% of project area.
- b. Environment management system to be drawn to ensure compliance of EC conditions stipulated based on principles of Continual Improvement and periodical management review.
- c. Rooftop rain water harvesting to ensure 100% Recharge/Use of rainfall. Storm water runoff to be collected in collection chamber /settling pond and maximise its use.
- d. All raw material to be stored only under covered shed.
- e. PAs to ensure ZERO DISCHARGE for its process discharges.
- f. PAs to offset (>20%) consumption of conventional energy sources by promoting use of solar energy, passive energy utilization, optimum fenestration, shading effect and heat islands.

**SEAC has made unanimous recommendation for grant of Environmental Clearance. The SEIAA, based on the recommendations of SEAC, unanimously decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC alongwith the following project specific additional conditions:**

- a. 100% transportation of raw material by rail and 70% product by rail must be ensured.

- b. Environment management system to be drawn to ensure compliance of EC conditions stipulated based on principles of Continual Improvement and periodical management review.
- c. Rooftop rain water harvesting to ensure 100% Recharge/Use of rainfall. Storm water runoff to be collected in collection chamber /settling pond and maximise its use
- d. All raw material to be stored only under covered shed.
- e. PAs to ensure ZERO DISCHARGE for its process discharges.
- f. PAs to offset (>20%) consumption of conventional energy sources by promoting use of solar energy, passive energy utilization, optimum fenestration, shading effect and heat islands.
- g. The environmental clearance is subject to the permission for supply of water from a competent authority.
- h. The baseline data & Modeling for the month of March, 2022 is to be collected by the consultant AMPL Environ Pvt. Ltd., Hyderabad and submitted to SEIAA / SEAC within April, 2022.

**5. 

The proposal was examined in the light of 90<sup>th</sup> meeting held on dated 14-18.09.2021, 92<sup>nd</sup> meeting held on dated 20-23.10.2021 and 93<sup>rd</sup> meeting held on dated 18-27.02.2022 of SEAC, Jharkhand for granting of ToR. SEIAA considered the above proposal in 93<sup>rd</sup> meeting dated 26<sup>th</sup>, 27<sup>th</sup> & 28<sup>th</sup> October, 2021 and made queries with reference to its 59<sup>th</sup> meeting regarding minimum distance criteria of 100 meter of lease from forest boundary. It is pertinent to mention here that then SEIAA in its 59<sup>th</sup> meeting held on 09.08.2018 has taken a decision to keep a minimum distance criteria of 100 meter even for renewal of mines (existing mines) and other projects in the light of recommendation of then SEAC of 49<sup>th</sup> meeting.

SEAC has made full deliberation on the issues raised by SEIAA, in its 93<sup>rd</sup> meeting held on 26<sup>th</sup> – 28<sup>th</sup> October, 2021 and came to the conclusion that SEAC, Jharkhand is bound to follow the EIA notification 2006, guidelines of MoEF & CC and directions given by apex Court or any competent Court of Law. But examples of other state, if any, can not be taken as direction or necessary guidelines for this committee. SEAC has again reiterates its recommendation of 92<sup>nd</sup> meeting to issue ToR to Serangdag Bauxite Mines.

SEIAA examined the recommendation made by SEAC in above mentioned project proposal and after full deliberations, it was unanimously decided to accept the recommendation made by SEAC in this regard and accordingly, delist the above project proposal from parivesh.

This proposal was appraised by SEAC in its 81<sup>st</sup> meeting held on 23<sup>rd</sup> – 25<sup>th</sup> October, 2019 and recommendation was made for grant of Environmental Clearance. Meanwhile District Mining Officer, Garhwa vide memo no. – 769/M, dated – 12.10.2019, intimated in SEIAA Office on 01.11.2019 that LOI of said project has expired as per 9 (1) of Jharkhand Minor Minerals (Amendment) Rules, 2017 due to non submission of Environmental Clearance within 180 days from the date of issue of LOI (Letter of Intent).

The SEIAA has examined the matter in its 83<sup>rd</sup> meeting held on 02<sup>nd</sup> November, 2019 and decided to seek a clarification from Deputy Commissioner, Garhwa on the matter of expiry of LOI and area mismatch for which SEIAA has written the letter to Deputy Commissioner, Garhwa vide letter no. – 605, dated 04.11.2019.

The Deputy Commissioner, Garhwa vide letter no. – 798/M dated 24.11.2021 has clarified on both the points, area mismatch and expiry of LOI and made recommendation for issue of Environmental Clearance.

On the basis of clarification submitted by Deputy Commissioner, Garhwa and recommendation of SEAC, the SEIAA, unanimously decided to grant Environmental Clearance to the above mentioned project proposal with the conditions recommended by SEAC.

and all the terms and conditions of Environmental Clearance dated **01.05.2015** shall be complied by "*M/s Abhiyan Coal & Coke LLP, Dhanbad*".




