Online proposal for granting Environment Clearance was submitted on dated 11/12/2021 and accepted by the SEIAA secretariat on dated 15/09/2021 and forwarded to SEAC secretariat. The hard copy was submitted by project proponent on dated 01/01/2022.

The project site falls under Government Industrial Area and the land is under the possession of Sarv Bio Labs. An existing industrial building is present at the site. Thus, there is no clearance of land & vegetation required.

As proposed expansion shall be undertaken at the adjacent land located east of the existing plant. The total available land for the proposed project is 1780 sqm. The land is recently procured and is under the possession of Sarv Bio Labs. The project site project falls under Government Industrial Area thus there will be no change in Land use pattern, land cover or topography.





The land acquired consists of full-fledged industrial building without any plant and machinery. Therefore no pre-construction investigation is required to be carried out. The building available in the site will undergo necessary structural stability analysis by a Chartered Engineer before carrying out modification work.

The SEAC discussed the matter in light of provisions of Notification no. SO 2859(E) dated 16-07-2021 for relaxation of API units till 31-12-2021 and recommended that the SEIAA may seek prior clarification from MoEF&CC, GoI regarding the appraisal of such API/ bulk drug proposals as to whether the applications received before 31-12-2021 or earlier pending before SEAC are to be appraised at the GoI level or by SEIAA in view of the fact that the date of relaxation was only up to 31-12-2021.

Thereafter, the case was listed in 58th meeting of SEIAA held on 21st July, 2022, where SEIAA after considering the recommendations of SEAC, approved that the Member Secretary, SEIAA shall seek prior clarification from MoEF&CC, GoI regarding the appraisal of such API/ bulk drug proposals as to whether the applications received before 31-12-2021 or earlier pending before SEAC are to be appraised at the GoI level or by SEIAA in view of the fact that the date of relaxation was only up to 31-12-2021.

Mean while, the SEAC in its 88th meeting discussed the matter of M/s CMG Biotech (API manufacturing unit) and decided to appraise the case after issuance of necessary directions from SEIAA, Himachal Pradesh in view of clarifications, if obtained, from MoEF&CC, GoI on Notification no. SO 2859(E) dated 16-07-2021 for relaxation of API/ bulk drug proposals received before 31-12-2021 or earlier pending before SEAC. The SEAC also advised the project proponent to revisit the list of products submitted for seeking Environmental Clearance as under the relaxation only products for addressing ailment such as Noval Corona Virus (COVID-19) are eligible for the appraisal as Cat B2 project as an interim measure.

In response an email was received to MS, SEIAA, HP on dated 3/1/2023 with a copy of letter issued to M/s Jags Pharma Ltd., Solan, H.P, by MoEF&CC, Gol informing that that, "Based on date of receipt of the application, SEIAA may examine if the project in question meets the said criteria or not and take appropriate necessary action accordingly".

All such above listed projects are received prior to 31.12.2021 for further action by SEIAA, H.P.

The SEIAA in its 60th meeting noted that one time exemption was valid upto 31.12.2021. After discussions, it was decided that these case applications may be transferred to MoEF&CC, GoI for further necessary action in view of the fact that the proponents have proposed the manufacturing of the products other than addressing ailment such as NOVAL Corona Virus (COVID-19) and also the fact that the some of project proponents have proposed only the testing of the products on trial basis.

Thereafter, a letter was written to MOEF&CC, vide this office letter number HPSEIAA/Main-2021-Vol-1-1052-1056 dated 06.03.2023 regarding transfer of application of API units to MoEF&CC and clarification of Notification no. 2859(E) dated 16.07.2021.

Further clarification was received from Dr. M. Ramesh, Scientist-E, Impact Assessment Division, MoEF&CC vide letter number IA-J-11013/72/2022-IA-II(I) dated 20.03.2023 stating that:-

.....the provisions of the said notification apply to all proposals in respect of APIs, not just those addressing ailments such as COVID-19. A clarification was also issued to SEIAA, H.P. in this regard vide letter dated 02.12.2020. In view of the above, SEAC & SEIAA, H.P are requested to expeditiously appraise all such long pending proposals.

The SEIAA secretariat forwarded the case applications online to SEAC on dated 1st April, 2023. Accordingly, the case application was listed in 91st meeting held on 4/4/2023. Mr. Sajjathe Sulthan, QSI, NABET approved EIA Coordinator of SBA Enviro System Private Limited, New Delhi presented the case application before the Committee.

After deliberating on the information submitted by the project proponent and considering the facts placed before the committee, the SEAC recommended the case application for consideration of grant of environmental clearance by the SEIAA as Category B2 project, subject to fulfillment of standard terms and conditions as imposed and are applicable to bulk drug industries as notified by MoEF&CC, GoI and term and conditions as conditions annexed at Annexure-III and with the following additional conditions for above proposed details:

- The project proponent shall deposit an amount of Rs.0.60 Crore under CER in the form of Demand Draft to the office of Director (DEST), GOHP within 15 days. The Director (DEST) shall device environment monitoring plan for this purpose within one month for that area including spring shed management.
- The project proponent shall sensitize and create awareness among people working within the project area as well as its surrounding area on the ban of SUP in order to ensure the compliance of Notification published by MoEF&CC on 12/08/2021. A report, along with photographs, on the measures taken shall also be included in the six monthly compliance reports being submitted by the project proponents.
