Transfer of EC of Group Housing at Plot No.- SC-02-G, Sector-150, Noida., U.P., M/s ACE Infracity Developers Pvt. Ltd. From M/s Crest promoter pvt. Ltd File No. 3657

SEIAA gone through the letter dated 09.12.2022 of M/s ACE Infracity Developers Pvt. Ltd regarding the above subject which states that pursuant to merger order dated 21.03.2018 passed by the National Company Law Tribunal, Allahabad Bench, Allahabad the project has been vested in M/s ACE Infracity Developers Pvt. Ltd from previous company M/s Crest promoter pvt. Ltd. Hence SEIAA opined to transfer EC no. 324/parya/seac/3657/2016 dated 27.12.2016 to M/s ACE Infracity Developers Pvt. - The project proponent install organic waste converter.
- 2- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 3- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 4- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. The committee discussed the matter in its 756th meeting on the basis of procedure laid down in violation SoP dated 07/07/2021 and reply dated 29/05/2023 submitted by the project proponent on legal notice and recommended to grant environmental clearance to the project proposal along with environmental clearance conditions earlier stipulated in 737th SEAC meeting dated 21/03/2023.

In light of discussion held in SEIAA meeting no. 597 dated 05.05.2022. SEIAA opined to accept the recommendation of SEAC and grant EC to the said project along with all the general and specific conditions as suggested by SEAC. In addition to the conditions imposed by SEAC, SEIAA added following additional specific conditions:-

- 1- That the project proponent shall deposit bank guarantee for a value equivalent to the amount of remediation plan and natural and community resource augmentation plan to the SPCB that is Rs. 40 lakhs with UPPCB which should be valid for a minimum period of 5 years. The bank guarantee will be deposited prior to the issuance of EC and will be released after successful implementation of the Remediation Plan and Natural & Community Resource Augmentation Plan and a penalty @ 1% of Rs. 32 lakhs shall be deposited to UPPCB as per SOP dated 07.07.2021.
