After general introductory remarks by the Chairman, SEIAA, the Committee took up items agenda-wise and reviewed the recommendations of State Expert Appraisal Committee (SEAC). After detailed deliberations & discussions on recommendations of the SEAC, the SEIAA recorded their decisions on case to case basis as under.

The SEIAA discussed the recommendations of the SEAC in detail and noted that the proponent obtained EC dt.19.07.2022 for construction of Residential Apartment with total builtup area of 79,766.3 Sq.m. Now, the proponent applied for EC amendment with total builtup area of 82,256.53 Sq.m. and no. of units increased from 237 to 354 units. However, there is no change in project cost and EMP cost. Hence, the proponent is directed to clarify the same.

The SEIAA discussed the recommendations of the SEAC in detail and noted that the environmental public hearing was conducted on 28.04.2022 wherein, some of the villagers opposed the project by stating that there is a Maisamma Temple on the hill, dust pollution problems envisaged from proposed mining activity and transportation of the mined mineral through the village and affect the surrounding agriculture fields. The proponent has submitted a copy of permission Ir.dt.28.04.2022 of the Sarpanch, Rekonda village, Chigurumamidi (M), Karimnagar District and not submitted copy of latest Resolution of the Grama Sabha. Hence, rejected.

The SEIAA discussed the recommendations of the SEAC in detail and noted that the project is considered under Violation and processed as per S.O. 804(E) dt. 14.03.2017, S.O. 1030 (E) dt. 08.03.2018, OM dt. 12.11.2020 & Lr. dt. 16.02.2021 O.M. dt: 07.07.2021 & O.M. dt: 28.01.2022 issued by the MoEF&CC, GoI. As per the guidelines of the SEIAA for Mining project involving violation, the rationalized project cost is Rs. 20,00,000/- and the amount of Bank Guarantee is Rs.50,000/- for Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan. Hence, the proponent is directed to submit the Bank Guarantee for an amount of Rs. 50,000/- (Rupees Fifty Thousand only) along with detailed action plan for implementation, Penalty amount of Rs. 15,673/- (Rupees Fifteen Thousand Six Hundred Seventy Three only) through DD in favour of Member Secretary, TSPCB, status of case No.CC No.03 of 2023 and an undertaking to abide by the additional guidelines of the MoEF&CC, GoI, if any.

Now, the proponent again applied for EC by furnishing the same information furnished earlier and not submitted proper justification for re-consideration of the proposal and a copy of latest Resolution of the Grama Sabha conducted on the issues raised in the public hearing, hence rejected.

The SEIAA discussed the recommendations of the SEAC in detail and noted that the proposed mine is located in the cluster of mines of Chinnaraviryala & Bandaraviryala villages in Abdullapurmet Mandal, Rangareddy District and obtained TORs (Violation) on 22.06.2022. Environmental Public hearing was conducted on 26.07.2022. The SEIAA received public complaints from Save Bandaraviryala through mail dt.14.02.2023 by stating that the EIA report is furnished with false information and the same was forwarded by the IRO, Hyderabad, MoEF&CC, GoI. Another complaint made by Sri P.L.N. Rao was also received from the MoEF&CC, GoI, New Delhi vide lr.dt.21.03.2023. It is also noted that an Appeal No. OA.No.9 of 2022 is pending before the Hon'ble NGT-Chennai on the pollution problems due to Quarries / Stone Crushers / Hotmix plants located in the above said Cluster. Recently, SEIAA received a mail dt.15.06.2023 from Save Bandaraviryala & Others on the issues of pollution being caused by the proponent. Hence, the issue is referred back to the SEAC for detailed examination of the issues mentioned in the above complaints and offer specific remarks & recommendation.


