The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in the 5.129th meeting of SEIAA as in this proposal, while SEAC has recommended for grant of EC under re-appraisal, it has also stated that the application for transfer of EC to the transferee is pending. Since, the fresh EC will be issued in the name of the present PP, the case is deferred and SEAC is directed to forward its recommendations in respect of the Transfer of EC so that both matters could be decided simultaneously.

Now, PP has applied for Transfer of EC. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the direction that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 03.11.2023 issued by MoEF&CC.

2. Serial No. 2: Proposal was deferred in the 5.133rd meeting of SEIAA for *submission* of Production Certificate FY 2023-24, ATR for non-complied condition in CCR and Conservation Plan submission receipt as applied area falls in 10 km of Nahargarh WLS.

Now, PP has submitted requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

3. Serial No. 3: Proposal was deferred in the 5.135th meeting of SEIAA for submission of affidavit clearly indicating that there is no violation of EIA Notification, 2006 and DCF Certificate regarding the distance of lease area from various Conservation Reserves of Baran District.

Now, PP has submitted requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

4. Serial No. 4, 5: These proposals were deferred in the 5.135th meeting of SEIAA for submission of Transfer EC application.

Now, PP has applied for Transfer of EC. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the direction that the RSPCB shall initiate action against the Project Proponent for non-compliance of O.M. dated 03.11.2023 issued by MoEF&CC.

5. Serial No. 6: Proposal was deferred in the 5.136th meeting of SEIAA for submission of affidavits from the PP and the Consultant for project being in

The committee is therefore recommending grant of EC to mine without going into the merits of the crusher plant. The project proponent shall obtain necessary permissions from the concerning authority(s) prior to establishment / operation of crusher plant."

6. Serial No. 7: Proposal was deferred in the 5.135th meeting of SEIAA for *submission* of Conservation Plan submission receipt as applied area falls in 10 km of Mukundra Hill Tiger Reserve.

Now, PP has submitted requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

- 7. Serial No. 8: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal with the condition that PP shall ensure the compliance of the conditions of Certificate issued by Water Resource Department.

Serial No. 18, 19: The Authority accepted the recommendations of SEAC and decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
