The Agenda item pertain to applications filed by the project proponents for grant of environmental clearance with reference to mining of minor minerals with mining lease size of less than 5.00 Ha. In light of S.O. 141(E) dated 101-2016 and recently Office Memorandum No.L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018 issued by Ministry of Environment, Forest & Climate Change, the following cases of B2-Category have been recommended by JKEAC for grant of Environmental clearance without requirement of Environment Impact Assessment/Public consultation subject to the compliance of specific & general conditions for safeguards of environment.

### **Agenda Item No.2**

#### **Grant of Environmental clearance in favour of M/S Sudershan Cements, Bari-Brahamana, Jammu.**

The project proponent had applied for grant of Environmental clearance before the former SIAAA/SEAC as an offline case pursuant to which the concerned SEAC vide letter No.Secy/SEAC/09/2009 dated 16-07-2009 had recommended the case for grant of Environmental clearance under Category B2. Instead of approved the recommendation and issuing the Environmental clearance, the then SEIAA referred the case to the State Pollution Control Board for necessary action vide letter No.107/MS/SEIAA/2009 dated 26-10-2009. During February, 2018, the State Pollution Control Board vide letter No.SPC B/T/Cement/Sba/05/1006 dated 17-02-2018 asked the SEIAA that despite recommendations of SEAC issued vide No.Secy/SEAC/09/2009 dated 16-07-2009, SEIAA has not issued the formal Environmental clearance.

The instant case was forwarded to the SEAC and was discussed in series of meetings which recommended that Project proponent be asked to apply afresh using online portal. The Project proponent accordingly applied online afresh under proposal No.SIA/JK/IND/86834/2018. The J&K Pollution Control Board had already given consent to establish & operate the renewed its consent from time to time. The case was again discussed in the JKEAC meeting held on 16<sup>th</sup>/17<sup>th</sup>/ & 18<sup>th</sup> December, 2019 and

Committee uphold the recommendations of former SEAC for grant of Environmental clearance in favour of the project proponent as per the conditions stipulated by former SEAC with one more specific condition that raw material & the finished products from the cement plant shall primarily be transported thorough railways to which effect the project proponent may be asked to furnish an affidavit & certificate of compliance from the J&K Pollution Control Board with reference to the stipulated and general and specific conditions put forthth b the former SEAC while recommending the case for grant of E.C. during 2009. before issuing of environmental clearance in his favour.

### **Grant of Environmental clearance in favour of M/S Mehboob Cement Industries at Village Wuyan Bala, District Pulwama.**

The case was transferred from Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi to the SEIAA. Subsequently the case was discussed in the series of meetings of SEAC and on the recommendations of SEAC the Authority vide letter No. No.SEIAA/2016/12/2019-II dated 29-03-2017 asked the project proponent to obtain clearance from the Standing Committee for National Board for Wild Life besides NOC from the State Wild Life Protection Department. In the meantime, the ownership of the project has been transferred in favour of Mr. Ubaid Hussain Lala & others who filed compliance under Form 2 The project proponent has complied the letter dated 29-03-2019 issued by the Authority. The case discussed in the JKEAC meeting held on 16<sup>th</sup>/17<sup>th</sup> & 18<sup>th</sup> Decembedr, 2019 in light of Office Memorandum No.J-11013/41/2006-IA-II(1) dated 2<sup>nd</sup> December, 2009 and recommended for grant of environmental clearance in favour of project proponent subject to subject to general & specific conditions.

Geology & Mining Department. The Committee recommended that project proponent be asked to fulfill the shortcomings.
